SUBJECT: Recommendations on the Governor's Proposed Biennial Budget, LD 1001, "An Act Making Unified Appropriations and Allocations for the Expenditures of State Government, General Fund and Other Funds, and Changing Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 2019, June 30, 2020 and June 30, 2021"

The Joint Standing Committee on Marine Resources reviewed the budget items in the Governor's proposed biennial budget that pertain to the committee's jurisdiction. All initiatives except for three received the unanimous support of the committee members present and voting. Those three initiatives not receiving a unanimous vote are as follows:

- Under the Bureau of Marine Sciences: Reference #2214 (page 7 and page A-411) Vote - 11-2, and Reference # 2216 (page 8 and page A-411) Vote - 9-2; and
- Under the under the Bureau of Public Health: Reference #2270 (page 17 and page A-415) Vote - 10-1.

Please find attached related OFPR worksheets outlining the committee's recommendations regarding all budget initiatives.

In addition to the recommendations shown on the OFPR worksheets, the committee voted 9 to 2 among those present and voting to support one new initiative.

- **New Initiative:** This initiative would provide ongoing funding to fund one currently unfunded Marine Patrol Officer position. According to the Department of Marine Resources (department), this position would require \$91,486 in FY2020 and \$95,427 in FY2021 (See attached for initiative language and justification).

Lastly, the committee would like to note that there is an error in the justification for the initiative with a reference number of 2214 on pages 7 and 8 (A-411). The department is not currently in the process of seeking federal funds for the project. The last two sentences of the justification for this initiative were included in a previous budget proposal and their inclusion was an inadvertent oversight. The department had sought federal funds previously, but discovered that this project was not eligible for federal funding.

Justification:

PURPOSE: The Maine State Legislature established the Maine Lobster Promotion Council in 1991 at the request of the Maine lobster industry. In 2013, the Maine Lobster Promotion Council became known as the Maine Lobster Marketing Collaborative (MLMC). MLMC is funded through 2018 at which point its efforts will be accessed by a third party, independent auditor to ascertain the effectiveness of all its activities between the years 2014-2018. MLMC is a public instrumentality of the state, funded primarily through assessments paid by lobster license holders.

MLMC markets the Maine Lobster brand to consumer and trade audiences around the globe. The objective of MLMC is to support brand awareness and premium positioning for Maine Lobster in order to maintain consumer interest and demand for Maine Lobster and thereby support the value of the brand for all sectors of the industry.

ORGANIZATION: Legislation passed in 2013 provided that MLMC is managed by an 11-member Board of Directors composed of four harvesters, three dealers/processors, two public members, and the Commissioners of the Department of Marine Resources and the Department of Economic and Community Development. The Council elects a chairman from among its members and employs an executive director and staff to handle the responsibilities of the lobster promotion programs.

Fiscal Management: The organization strives to maximize market impact of its expenditures through strict adherence to conservative fiscal policy. All revenue is generated through an assessment on lobster licensees.

An annual audit is compiled by an independent, external CPA accounting firm; a copy of the 2014 fiscal year audit will be available in early 2015. In all the years of MLMC's existence, the auditors were satisfied that the MLMC had well managed and responsibly administered financial records, policies and procedures that were well managed, and the accounting and financial management adhered to Generally Accepted Accounting Practices standards. The auditors had no recommendations for, nor suggested any, need for improvements.

Sources and uses of funding: Sources - As mentioned above, the funding for the MLMC comes from license assessments from industry licensees. These include harvester licenses, wholesaler licenses, and transportation licenses. The MLMC does not receive any funding directly from State or Federal funds.

Uses - the MLMC uses a detailed budget that is approved and overseen by the 11 member board of directors that represents diverse industry sectors, including harvesters, dealers, processors, and the general public.

The MLMC has a very broad mandate and minimal funding so the entire board and staff is continuously focused on programs and activities that generate the most return on investment in terms of supporting the industry in the areas of marketing and promotion of the sale of Maine Lobster.

Justification:

The Bureau of Marine Science (BMS) is engaged in scientific research, monitoring, and education to restore, conserve and manage the marine, estuarine, and diadromous resources of the State of Maine. This Bureau is the result of a consolidation of the Bureau of Resource Management and the Bureau of Sea Run Fisheries and Habitat. The BMS conducts research and population assessments of commercial and recreational fisheries such as American lobster, northern shrimp, Atlantic herring, green sea urchin, sea scallops, and striped bass, and Maine's native diadromous fish populations. The focus of sea run fisheries activities is on multi-species, ecosystem based management and restoration of eleven diadromous species such as shad, striped bass and alewives, including multi-party/multi-species settlements that are connected with the hydro-dams that are licensed by the Federal Energy Regulatory Commission (FERC) and collaborative work with NOAA Fisheries and the US Fish and Wildlife Service on species oversight and leadership relating to Atlantic Salmon listed under the Endangered Species Act. The Maine State Aquarium and the Burnt Island Living Lighthouse Program provide marine education and outreach to the public, Maine's school children and teachers.

Justification:

The Department of Marine Resources (DMR) seawater system, which supplies seawater for the wet labs and aquarium, has needed an upgrade for many years. Seawater is pumped from Boothbay Harbor via two 4-inch intake pipelines that extend approximately 70 feet into the ocean, which were installed during the last major upgrade of the facility in 1992.

The pumps need to be replaced, the existing filtration system needs to be upgraded, and additional disinfectant/treatment improvements are badly needed. Additionally, the waste handling system requires significant improvement to address biosecurity concerns. Presently, effluent from the aquarium and wet laboratory is discharged to the storm drain system outside the facility and ultimately to an ocean outfall. Modifications are recommended to bring the system into compliance with current Maine State Plumbing Codes. The existing seawater system is expensive to maintain (\$3,000/mo), structurally unsound, and does not meet standards for biosecurity. If DMR is going to effectively conduct research, hold specimens for display in the aquarium or receive additional sample for other disease or pathogen related work, biosecurity must be improved; it is untenable for state facilities not to meet the same standards we impose on private facilities to ensure protection of public trust resources. DMR contracted with Wright Pierce for an evaluation of operating costs, cost recovery options and installing a outfall treatment system. Total estimated costs for the recommended improvements are \$1,035,000, including a 15% project contingency and a 20% allocation for professional services for design, development of bidding documents and construction administration. DMR intends to seek federal funding to fund the entire project. If not successful, DMR will reduce the scope of work, as necessary, to meet biosecurity standards as its top priority.

The systems in the lab are expensive to operate, are outdated and in some cases replacement parts are no longer available outdated and expensive. System improvements would include the upgrade of the heating, ventilation, and air conditioning system (HVAC) from pneumatic to electronic controls HVAC system and a new high efficiency chiller for office and laboratory spaces. The Boothbay Harbor lab houses the department Bureau of Marine Science staff, the Bureau of Public Health water quality lab and the Bureau of Marine Patrol Division I office.
