- (3) §83-C(5) (ST 24) change "sales incentives for alcoholic beverages" to "sales incentives for liquor"? Also change §83-C(6) from "jurisdiction over alcoholic beverage matters" to "alcoholic beverage<u>s</u>"? And a corresponding change for §83-B(11)?
- (4) §90 (ST 28-30) change "alcoholic beverages" to "spirits"?

   Do not change: sub(6) lead-in "committee . . . having jurisdiction over . . . alcoholic beverages matters"

Notwithstanding any other provision of this Title, a brewery or small brewery licensed in accordance with under this section that has a chapter 43 retail license under subsection 2, paragraph I may sell from the establishment at the site of the brewery licensed for the sale of alcoholic beverages to be consumed on the premises malt liquor to be consumed off the premises under the conditions specified in this paragraph.
