The SPEAKER: The Chair recognizes the Representative from Winter Harbor, Representative Faulkingham.

Representative **FAULKINGHAM**: Thank you, Madam Speaker. I rise in support of the pending motion. As was discussed at length the last time we debated this bill, 44 states have already enacted this law. This is a sales tax on gold and silver. I've heard some things develop since the time we passed this bill and to be quite frank with you, Madam Speaker, they sound kind of crazy. I've heard that this bill will upset the monetary system, that this bill is going to change the way money is used in our country. Madam Speaker, that is just ridiculous. They're fear tactics for removing a sales tax. This bill got the Majority Report of the Committee, it's a bipartisan bill. This is removing the sales tax on something that working-class people invest in. The overwhelming number of people that invest in gold and silver are working-class people. They're not rich people who are the ones that invest in stocks, which we do not double tax in this manner. That was spoken about a lot last week and that's true. We don't charge a sales tax on stocks and then capital gains like we do with gold and silver, where you pay the sales tax and the capital gains tax. Madam Speaker, there are numerous items that we do not charge a sales tax on. I believe it was last week we passed a bill that would remove the sales tax on diapers. Is that going to upset the monetary system that we don't charge a sales tax on diapers? Are people going to trade in diapers?

We have gone so far away from the gold standard that I don't know if we could ever get back. But, Madam Speaker, this bill certainly does not do that. There is no reason to be scared of this bill. You know, the rhetoric that's gone on since then, Madam Speaker, is just, quite frankly, ridiculous and as we get into the nitty-gritty of this Session, it would be nice to see a little bit of work where we can work together and have some bipartisan good faith such as we did last week. So, I would just urge the Members, whether you voted yes for this previously or no for this previously to just hold your vote and do the work that we were sent here to do. I've said it all when I've said it but please vote for the pending motion.

The SPEAKER: The Chair recognizes the Representative from Auburn, Representative Libby.

Representative **LIBBY**: Thank you, Madam Speaker. Madam Speaker, this is a good bill that will benefit Maine people. Last week, we stood on the floor and we clarified details that garnered a majority vote to remove the sales tax from gold and silver. And those details have not changed in the interim but here we are re-voting a good bill for purely political reasons. Madam Speaker, I cannot speak to anyone else's motives for how they vote on this bill, but during this morning's prayer, I reflected on my motives. We were encouraged to hear our own voice and to live with clarity. I would extend that personally to hearing the voice of my district and voting accordingly, to speak our truth with love and respect which, to me, means speaking the truth with my vote even when my leadership disagrees. And, finally, to put aside desire for personal gain, which encourages me to vote what is right according to my conscience and what is

best for my district and the people of the State of Maine, regardless of which of my bills may or may not get passed or Committee assignments withheld. Madam Speaker, this is a good bill that will benefit Maine people. Let's put aside politics and vote accordingly.

The SPEAKER: The Chair recognizes the Representative from Fairfield, Representative Rudnicki.

Representative **RUDNICKI**: Thank you, Madam Speaker. In listening to this, I just kind of wanted to give you a little bit of how this actually works. I've bought gold myself. I bought gold through a company we all know, advertised a lot, Goldline, and if I buy gold and I have it shipped to my home in Maine, I have to pay the 5.5% sales tax. So, I didn't have it shipped to Maine. I had it shipped to my sister's house in Pennsylvania. They don't pay and I was going down anyway. In fact, I held off on my purchase until I knew I was going so it would be delivered there and I could pick it up. And the other thing that I learned while I was talking to my broker on this; and we're not talking a lot of money, I don't have a lot of money but I was trying to hedge my bets on my investments; but while I was talking to the broker, I said why am I paying sales tax and these other states don't? Well, Maine charges it. What I could do, though, and I don't have to have it shipped somewhere, I can have it held in their depository for one year and then have it shipped to me and they just charge me 2% for the holding fee. So, Maine's not getting the sales tax on that, anyway, so I could do that, too. There are alternatives we can do but this affects Maine people. And if 40-plus other states are already not charging sales tax, Maine people have an alternative to go somewhere else. Well, if I'm going to Pennsylvania, I'm spending other money outside the State doing that as well.

So, I just want to urge people to think about what's good for your constituents because we are not talking millionaires and that type of thing is what we're talking about; we're talking regular people like myself who just wanted to hedge my bets a little bit on my investments. I certainly don't pay a sales tax when I go buy a stock or something like that but I'm having to pay sales tax on gold. And I did order silver and paid sales tax on silver and it ticked me off. So, what I'm saying is think about what you're doing, think about what this does for your constituents, and help them out. Thank you.

When she sold her house last fall and moved out of State, she left behind a detailed map of instructions of what her garden contained and how to care for each plant. I met with her family over the weekend for a small service for her and they were truly touched by this Expression of Legislative Sentiment. Thank you, Madam Speaker.

A son of Biddeford, Ralph graduated from the old St. Louis High School and went on to teach at Biddeford High for more than 30 years, teaching math and then opening the school's first computer lab. He also worked many years at two

iconic local businesses, the Clam Shack in Kennebunk, right up against the Lanigan Bridge, and Vic's Appliance in Saco.

But Ralph Jacques' life was more than just a bio. It's the generations of people he taught and positively influenced to be their best selves. Take it from his long-time colleague at Biddeford High, Paul McDonough, who sent me the following, quote; Ralph Jacques was a steadfast professional educator par excellence. He believed that students deserved the very best that Biddeford High School had to offer. His enthusiasm was infectious and his ability to communicate what was needed for all his students was so very evident. Ralph was a friend, gifted with skills that few ever achieve. His presence will be much missed by all who have had the privilege to call him a colleague or a friend; end-quote.

Or take it from one of his many students, Emma Bouthillette, who graduated from Biddeford High in 2004 and went on to write a book called "The Brief History of Biddeford." Quote; math has never been my strong suit, yet Mr. Jacques was one of my favorite teachers at Biddeford High School. My adoration for him started young when my parents and I would visit the Clam Shack in Kennebunk during the summer months. Ralph and his wife, Charlotte, were always excited to see us at the window and they knew I wanted to order fried shrimp. It made me feel special because at the time, I didn't realize this was how they treated everyone who came to patronize their summer business. By the time I got to high school, I heard my Mom talk about Mr. Jacques and how he helped her pass geometry. When I started his class, I said to him, when it comes to math, I take after my Mom. He took the same care in helping me understand the principles of geometry so I could pass his class, too. In more recent years, I'd often run into Ralph and Charlotte eating breakfast at New Moon in Saco or shopping around town and no matter where I saw him or what he was doing at the time, he always asked how I was, what I was up to, how my parents were doing, et cetera. I'm sure he did this with many of his former students and not just me but it still made me feel good to know he cared after all these years, especially during some particular trying times in adulthood. I may have forgotten the geometry lessons he taught me in the early 2000s but I will never forget him, end-quote.

Madam Speaker, Ralph Jacques represented the best of Biddeford, Biddeford at its very finest. His legacy lives on his amazing family, many of whom are here today, and we can all carry on his legacy by taking the same care to listen to and respect people the way Ralph Jacques did. Thank you.

These hearts brought joy, whimsy and delight to everyone who saw them. Kevin leaves behind a legacy of love for his family, the City of Portland and the State of Maine. I'm grateful to have known Kevin and have the opportunity to recognize him here and I hope that that will bring some joy and comfort to his wife, Patti, and his daughter, Sierra, who are here with us today. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Gorham, Representative Terry.

Representative **TERRY**: Thank you, Madam Speaker. Madam Speaker, I just want to share a little story. A long time ago, when I first moved to Portland, I bought my restaurant in somewhere around November. And it's really hard to start a restaurant. As a kid, I was too young to have it, I wasn't sure if I was going to fit in there. And February rolls around and there are little hearts on the window of my restaurant. It made me feel so special and it showed me that I was definitely in the right place. I just want the family to know that fast-forward nearly 30 years later, not only do we love seeing all those hearts in Portland on Valentine's Day, but thanks to Mr. Fahrman, he inspired countless towns all over the State and really the country to have Valentine's Bandits in their town, including Gorham, and I just want them to know that they make everybody feel like we're in the right place. So, thank you.

  - the docket number of the matter, OJ-23-1;
  - the title of the matter, "In the Matter of Request for Opinion of the Justices";
  - the title of the document as a "Brief of" followed by the name of the person or entity filing the brief; and
  - the name, address, and Maine bar number of counsel representing the filer or, if the filer is not represented by counsel, the name and address of the filer; and
- b. the brief may not be longer than 25 pages.

So, the long-range implications of this would be that employers do need to track the amount of work that the employees are doing and a lot of employees choose to work at home now and

we think that's a good idea. However, if this bill were to pass, I think we would find that a lot of employers would choose not to allow employees to work at home, thereby hurting the employees more than if the bill does not pass. So, I stand opposed to the pending motion. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from New Gloucester, Representative Arata.

Representative **ARATA**: Thank you, Madam Speaker. I just want to give you an example of a situation that I encountered where I didn't consider myself doing surveillance of my employee but I guess that's what I was doing. I had him install an app so that he could check in so I could properly pay him and check out of a job site and so I would know where he was working at any given day, going to various properties that I had him perform maintenance duties for me. So, that's why I oppose this bill. Thank you.

The SPEAKER: The Chair recognizes the Representative from Bangor, Representative Roeder.

Representative **ROEDER**: Thank you, Madam Speaker. In the example given by the Honorable Representative from New Gloucester, that installation of an app would only be illegal via this bill if it was on an employee's personal device. I would like to read the amendment. The amendment specifies that an employer may use employer surveillance if the employer informs the employee before beginning employer surveillance. It's still allowed. It prohibits an employer from using audiovisual monitoring in an employee's residence or personal vehicle or on the employee's property and states that an employee can decline a request by an employer to install data collection or transmission applications on an employee's personal electronic devices for the purposes of employer surveillance. It also requires that an employer notify a prospective employee during the interview process that the employer engages in employer surveillance.

It was important to me to tailor the bill to personal property because I feel that that is something that we should control over, we should have rights over. Not only is it an issue of equity but it's an issue of personal rights and that's one of the reasons that I put this bill forward. I did have bipartisan support in cosponsors and I would encourage folks to follow my light. Thank you.

The SPEAKER: The Chair recognizes the Representative from New Gloucester, Representative Arata.

Representative **ARATA**: Thank you, Madam Speaker. I appreciate the clarification. However, in this bill, it's not clear to me whether an employee could change his mind partway through employment and not allow the app on his phone, so, therefore I'm still going to oppose the motion. Thank you.

Representative **PERRY**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House, just to give you a brief overview of this bill, it has to do with tax increment financing, the TIF program. That's a financial tool that can be used by municipalities to try and attract business and create economic development in their community. This bill has Democrats and Republicans on both sides, Ought to Pass as Amended and Ought Not to Pass.

It was brought to us mainly on behalf of the Town of Hollis but would have impact statewide and what it allows is for money to be removed from the TIF program to be used for municipal buildings. Previously, that was not an accepted use, it is currently not an accepted use. However, the TIF program has evolved some over the years where recently we made changes where you could use some TIF proceeds to build public safety buildings, police and fire. This takes it another step.

I've been on both sides of this bill before. The Ought Not to Pass side views it as an erosion in TIF which is to be used for economic development. The proponents of this bill view a safe, sound municipal building where planning and other activities for business occurs as an acceptable use. There is already a mechanism for using TIF money for something of this nature but you have to remove it from the TIF sheltering. The TIF sheltering gets you off the hook for your share of education funding and it has revenue sharing implications. So, that's the question of the day; is this an acceptable next step forward and on this particular bill, in this particular Legislature, I came down on the side of this being a reasonable use of TIF money. Thank you.

The SPEAKER: The Chair recognizes the Representative from Buxton, Representative Carlow.

Representative **CARLOW**: Thank you, Madam Speaker. Madam Speaker, in the preparation of my remarks this afternoon, I was reminded of the 1974 song from Rolling Stones; "Time Waits for No One." And just as it did in the lyrics, that refrain rings true today in the modern world. And the towns and cities and villages across Maine are fighting to keep up, to keep pace with an unrelenting foe.

A few days ago, I was asked by a good friend and colleague of mine in this House why I cared so much about tax increment financing. It's an important resource. It helps all of our municipalities but especially the ones that are most in need and with the fewest options available to them to solve the increasingly complex problems of their work.

The legislation now pending before the House seeks to correct a confounding provision of Law by repealing the expressed prohibition against the utilization of TIF revenues for the capital cost related to the construction and renovation of municipal offices which provide an indispensable function of local government and impacts the local economy in any number of ways. This policy has already been adopted by 26 states and the District of Columbia because the right of a community to decide for itself how to utilize its own resources is essential for the success of towns and cities across America. In terms of an outright prohibition on the use of TIF revenue for this purpose, we are an outlier. Nevertheless, the question has been posed today why the revenue raised by TIF districts should be used to defray the costs of building and maintaining municipal buildings. And I respect the conclusions my colleagues are about to make with regard to this question but I would urge them to consider the Home Rule doctrine upon which so many of our decisions

have derived their basis. The doctrine that local leaders know what their communities need and that they can be trusted to be good stewards for their citizens without arbitrary prohibitions from the State Legislature.

I thank my colleague from Bangor for his thoughtful comments. The people of Hollis, Maine, which I have the good fortune of representing in this House, need a new Town Hall. It was built in 1973, a year before the Rolling Stones song was released, and it's truer now more than ever that time isn't waiting. The Town Hall is falling apart, it's restraining the growth of this small town, and I hope this Body will trust them to make good decisions about how to use the TIF revenues that are already available to them, that will cost the State nothing, and that will greatly, greatly improve the economy for the community I represent. Thank you, Madam Speaker.

Representative **ANDREWS**: So, when we're selling land to only an individual party, is that land usually sold below market value or at market value?

The SPEAKER: The Member has posed a question through the Chair. The Chair recognizes the Representative from Hallowell, Representative Shagoury.

Representative **SHAGOURY**: Thank you, Madam Speaker. This particular sale, and it is common practice, was done by a negotiation between the National Guard which owns the property and the City of Hallowell. And since it looks like we're going back with a question and answer for a bit, let me just tell you a little bit about this property and how we got to where we are, with the Speaker's permission.

The SPEAKER: The Member may proceed.

Representative **SHAGOURY**: The City of Hallowell has a 160-acre park that serves the greater Augusta area. Formerly known as the Hallowell Reservoir Recreation Area, it's known by all who know it and use it as the Res, and I'd be glad to take any of the Members up there any time we have some time. It's a really lovely spot. A few years ago, there was a survey done of this land and a unique irregularity showed up. It turns out that there was a parcel approximately seven acres within the Res that is actually owned by the National Guard. And this was something of a shock to both parties. Starting in the 1930s, this parcel was used as a site of a tower that was a beacon for the airport when there was a military airport here in Augusta. And after World War II ended, the tower came down and everybody forgot about that 7 acres. And in the interim years, the surrounding area had become parkland. Again, neither the city nor the Guard was aware of this situation and over the years, trails were built through the property. To rectify the situation, there was a Resolve in the 130th Legislature, LD 1852, to make the property available for sale. The Resolve passed and this Resolve is a follow-on to set the conditions for the sale.

The Guard had an assessment done and set the value at \$80,000 and, after a great deal of negotiation, accepted that over the 40-plus years the City had been maintaining that parcel as part of the park, they had put at least the equivalent of \$40,000 into the parcel in terms of maintenance and building the trails and et cetera. And let me also stress that this parcel is essentially landlocked and has probably very little value to anybody else other than the city. And that's the point we're at today. Again, this is common accepted practice for sales and it sets no precedent for how things would be done in the future. I would encourage everyone to vote to allow the sale to proceed as negotiated by mutual agreement with all the parties. Thank you.

Representative **BOYER**: Thank you, Madam Speaker. Madam Speaker, the amendment that's presented as the Minority Report would allow for the Secretary of State to conduct voter list maintenance for the purposes of updating the voter lists. Madam Speaker, the initial bill that came across to us was flawed and this was what we worked up and basically, it provides ongoing funding to ensure that our voter rolls are clean and up to date. I'm sure we all went to a door this last election cycle where the names didn't match up and, you know, we had an embarrassing moment with a voter. So, you know, I think we all kind of acknowledge that the voter lists aren't where they should be. In my district in Poland, we have people registered at the Elan School. It's been closed since 2011, Madam Speaker.

Under the Federal laws, it does take years and years to take an invalid voter off the voter rolls through these mailings. So, we thought it makes sense to put this funding into Statute and allow for the Secretary of State to do this on a rolling basis, the idea that the mailings would get smaller and smaller as we go through because the voter rolls would get cleaner and cleaner. Even in 2018, there were dead folks that got certified as signatures on a petition at the town level. The Secretary of State confirmed these dead voters as people so, you know, I'm not talking about election fraud, I'm just saying that our current rolls aren't the best that they could be and this would help in that regard. Thank you, Madam Speaker.
