2 3	Sec. 1. 20-A MRSA §6402-A, as enacted by PL 1985, c. 258, §2, is amended to read:
4	§6402-A. School physician or family or pediatric nurse practitioner
5 6	Each school board shall appoint one or more school physicians <u>or family or pediatric nurse practitioners</u> .
7 8 9	1. Duties. The school physician <u>or family or pediatric nurse practitioner</u> shall advise the administrative unit on school health issues, policies and practices and may also perform any other health-related functions assigned by the board.
10 11 12	2. Other functions. A school physician <u>or family or pediatric nurse practitioner</u> may perform other medical and health-related duties assigned by the school board, which may include all or some of the following:
13 14	A. Examine and diagnose students referred by teachers and other school employees to protect against the outbreak of contagious diseases in the schools;
15	B. Examine students for participation in physical education and athletic activities;
16	C. Advise and serve as medical consultant to the school nurse; or
17 18	D. Examine school employees and property if the physician <u>or family or pediatric nurse practitioner</u> believes it is necessary to protect the health of students.
19 20 21	3. Prohibition. A school physician <u>or family or pediatric nurse practitioner</u> may not treat any student examined under this subchapter unless the physician <u>or family or pediatric nurse practitioner</u> is also the student's personal <u>physician health care provider</u> .
22	4. Appointment. Appointment shall be is on a yearly basis.
23 24	Sec. 2. 22 MRSA §451, sub-§6, as enacted by PL 2007, c. 462, §1, is amended to read:
25 26 27 28	6. Duties. Local health officers may be employed on a part-time or full-time basis. The offices of local health officer and town or school physician <u>or family or pediatric nurse practitioner</u> may be combined when, in the opinion of the municipal officers, the health needs of the public would be better served.

30 31	This bill allows a family or pediatric nurse practitioner to serve as a health care provider in a school.
