LR 2847, An Act To Make Additional Supplemental Appropriations

and Allocations and To Change Certain Provisions of the Law for

Fiscal Years Ending June 30, 2012 and June 30, 2013

The Joint Standing Committee on Labor, Commerce, Research and Economic Development conducted a work session with the Commissioner of the Department of Economic and Community Development on March 20, 2012 and conducted two work session with the Commissioner of the Department of Labor on March 24, 2011 and on March 26, 2012 to consider LR 2847, the Governor's Second Supplemental Budget.

The Joint Standing Committee on Labor, Commerce, Research and Economic Development has the following unanimous recommendations:

- Rather than transferring funding in the amount of \$16,796.00 for indirect costs for Administration Labor (line 0030, page A-74) in FY 2011-12 and in FY 2012-13 from Women, Work and Community (line 0132, page A-79), the committee supports the transfer of funds from the Governor's Training Initiative unencumbered balance forward (Part BB, page L-45);
- Rather than transferring funding in the amount of \$2,000.00 for funding to cover per diem Maine Labor Relation Board costs (line 0160, page A-79) in FY 2012-13 from Women, Work and Community (line 0132, page A-79), the committee supports the transfer of funds from the

- Governor's Training Initiative unencumbered balance forward (Part BB, page L-45); and
- Amend the amount of unencumbered balance forward in in the Governor's Training Initiative (Part BB, page L-45) from \$451,183.00 to \$415,591.00 to reflect the above proposed recommendations.

The Joint Standing Committee on Labor, Commerce, Research and Economic Development has the following divided reports:

• The majority report of the committee in attendance (8 – Senators Rector and Martin; Representatives Prescott, Newendyke, Volk, Dow, Wallace, and Gilbert) support the reorganization of a position from range 29-35 in Administration – Labor (line 0030, page A-74) being funded from Employment Services Activity (line 0852, p. A-78) in the amount of \$12,808.00 in FY 2011-12 and \$21,640.00 in FY 2012-13.*

The minority report of the committee in attendance (3 – Senator Jackson and Representatives Tuttle and Hunt) do not support the reorganization of a position from range 29-35 in Administration –Labor (line 0030, page A-74).*

• The majority report of the committee in attendance (7 – Senators Rector and Martin and Representatives Prescott, Newendyke, Volk, Dow, and Wallace) support the addition of the Director, Bureau of Unemployment Compensation in Sec. D-4. 5 MRSA §943, sub-§1 (L) as a major policy influencing position (page L-12).

The minority report of the committee in attendance (4 – Senator Jackson and Representatives Tuttle, Hunt, and Gilbert) do not support the addition of Director, Bureau of Unemployment Compensation in **Sec. D-4. 5 MRSA §943, sub-§1** (L) as a major policy influencing position (page L-12).

• The majority report of the committee in attendance (7 – Senators Rector and Martin and Representatives Prescott, Newendyke, Volk, Dow, and Wallace) support the addition of the Director, Bureau of Unemployment Compensation in **Sec. D-7. 26 MRSA §1401-B, sub-§1**(B)(8) as a commissioner appointed position (page L-13).

The minority report of the committee in attendance (4 – Senator Jackson and Representatives Tuttle, Hunt, and Gilbert) do not support the

addition of Director, Bureau of Unemployment Compensation in **Sec. D-7. 26 MRSA §1401-B, sub-§1** (B)(8) as a commissioner appointed position (page L-13).

*Please note that the budget has an error on page A-74 in the initiative that proposes to transfer funds to reorganize a position from range 29-35 in Administration – Labor (line 0030) in FY 2012-13. The amount should be for \$21,640.
