Budget Bill (LD 100)

The Joint Standing Committee on Education & Cultural Affairs is pleased to submit our budget recommendations related to the Governor's proposals in the FY 2011 supplemental budget bill (LD 100). We held three work sessions and carefully reviewed the initiatives related to pre-kindergarten to grade 12 education, postsecondary education and cultural affairs programs.

The Education & Cultural Affairs Committee voted to unanimously support the passage of all but three of the 41 initiatives presented in LD 100. Our recommendations are presented in the attached EDU Report-back template and the EDU budget worksheets.

We also provide brief comments below to summarize the views of Education & Cultural Affairs Committee members regarding two items where we object to the (Part W) language proposed in the bill, another item (Sec. A-22) where we present a divided report, and several other budget-related matters that we wish to bring to the attention of the members of the Appropriations & Financial Affairs Committee.

# Education & Cultural Affairs Committee Recommendations FY 2011 Supplemental Budget Bill (LD 100)

## 1. CHILD DEVELOPMENT SERVICES ("CDS") SYSTEM

• Language Part W, Sec. W-1 (EDU-30). This initiative eliminates statutory provisions that allow certain children to continue to receive services from the Child Development Services ("CDS") System for an additional year rather than be enrolled in kindergarten.

Vote: "OUT" 12-1

Majority ONTP Report (12): Sen. Langley, Sen. Mason, Sen. Alfond, Rep. Richardson, Rep. Maker, Rep. McClellan, Rep. McFadden, Rep. Johnson, Rep. Wagner, Rep. Rankin, Rep. Lovejoy, Rep. Nelson; Rep. Soctomah supports the Majority ONTP report Minority OTP Report (1): Rep. Edgecomb

Recommendation: Members on the majority report object to including this language provision in the supplemental budget bill for the following reasons: (1) the proposed initiative does <u>not</u> have a fiscal impact for the current fiscal year; (2) there is disagreement over the fiscal impact of this proposed initiative on the budgets of both the CDS System and K-12 special education programs; and (3) this budget initiative involves important policy considerations that merit further consideration by both the Education & Cultural Affairs Committee and the Appropriations & Financial Affairs Committee (please also see Part K below).

• Language Part W, Sec. W-2 (EDU-30). This initiative requires the Department of Education ("DOE") to amend rules regarding the period of time required to complete special education evaluations for children (3 to 5 years of age) from 60 calendar days to 45 school days.

<u>Recommendation</u>: The majority of Education & Cultural Affairs Committee members also object to including this language provision in the supplemental budget bill. While the basis for opposing this item is stated in the 1<sup>st</sup> and 3<sup>rd</sup> reasons above (for Sec. W-1), members also noted that the 124<sup>th</sup> Legislature rejected this proposed DOE rule change twice in the last two years.

• Language Part K (EDU-27). This initiative requires the DOE Commissioner to identify savings in the CDS System program and to submit a report to the Legislature by March 31, 2011 with a plan that "identifies savings ... equal to at least 5% of the total fiscal year 2010-11 program budget" for the CDS System "that do not affect services to children."

Vote: "IN" 13-0

Rep. Soctomah supports the ONTP report

Recommendation: The Education & Cultural Affairs Committee unanimously supports this initiative. As the Legislature looks forward to the FY 2012-FY 2013 biennium budget, we expect that the comprehensive review promised by the DOE can clarify unanswered questions related to the total budget of the CDS System program. While we understand that the DOE interprets the Part K language to represent 5% of the General Funds appropriated to the CDS System, we request that the DOE comprehensive review considers analyses of all revenue sources, including allocations from Federal Expenditure Funds (i.e., IDEA funds, Medicaid funds, etc.). We also request that DOE officials consult with DHHS officials to incorporate the impact of MaineCare rule changes on the eligibility of the CDS System program for reimbursements from Medicaid funds.

## 2. DOCTORS FOR MAINE'S FUTURE SCHOLARSHIP FUND

• Sec. A-22. Finance Authority of Maine, Ref. #: 239; Doctors For Maine's Future Scholarship Fund; (EDU-9). This initiative proposes to reduce funding in the amount of \$125,445 from the Doctors for Maine's Future Scholarship Fund.

Recommendation: Education & Cultural Affairs Committee members agree that this innovative scholarship program is a "win-win" that provides tuition assistance for Maine medical students while improving access to primary care providers for rural communities across the State. The majority report members reluctantly accept this one-time funding reduction and note that the impact of this cut will be deferred until FY 2016 – a preferable choice when compared to less appealing alternatives that would result in withdrawing financial support in the middle of the academic year. The members of the minority report feel that taking funds from this new program sends the wrong message to prospective medical students and to private philanthropists.

All committee members concur that this scholarship fund must <u>not</u> be a target for further funding reductions in the FY 2012-FY 2013 biennium budget. We urge members of the Appropriations & Financial Affairs Committee to join us in sending a strong message to the Administration that further cuts to this program could result in great harm to this public-private partnership that is poised to deliver medical care to the rural Maine communities that need it the most.

### 3. CULTURAL AFFAIRS AGENCIES

While Education & Cultural Affairs Committee members unanimously accepted the Governor's proposed initiatives related to the cultural affairs agencies, we note that these institutions – the Maine Arts Commission, the Maine Historical Preservation Commission, the Maine Historical Society, the Maine Humanities Council, the Maine State Library and the Maine State Museum – deserve continued state support and our sincere gratitude for the value they individually and

collectively bring to our quality of life and for their contributions to the economic and cultural spheres of our State.

Along with all of state government, the cultural affairs agencies have faced a State "hiring freeze" and an "attrition saving" initiative during the past few years. We have heard of the challenges that these constraints present to relatively small state agencies such as the Maine Arts Commission, the Maine State Library and the Maine State Museum. These agencies must forgo filling vacancies, restructure existing positions, and risk the elimination of funds for vacant positions in order to remain within their tight budgets and in compliance with these personnel limitations. While we recognize that these personnel issues may more properly be addressed during the upcoming FY 2012-FY 2013 biennium budget proceedings, the Education & Cultural Affairs Committee offers one final recommendation for your consideration.

Recommendation: On behalf of the Director of the Maine Arts Commission, we request that the Administration consider providing an exception to the "hiring freeze" so that the Maine Arts Commission is allowed to fill the Assistant Director position that was vacated last year. We have been informed that the 124<sup>th</sup> Legislature approved the allocation of federal funds for the Assistant Director position, but that once the position was vacated, the "hiring freeze" prevented the Maine Arts Commission from filling the position. We recommend that the Administration establish an appeals process to consider – on a case by case basis – the merits of "thawing out" frozen positions that do not have an impact on the General Fund.

# 4. MAINE PUBLIC BROADCASTING CORPORATION

Finally, we wish to thank the Maine Public Broadcasting Corporation for continuing to provide quality programs that are broadcast to all regions of the State in spite of the reductions in state funding. We also recognize the critical public service that MPBN provides with respect to transmitting emergency signals on behalf of federal and state emergency management agencies.


