THE PRESIDENT: Good morning. Another seamless morning at the State House in Augusta. Fellow Senators and guests, what an incredible honor it is to stand before you today. I will be eternally grateful to you for electing me the 116th President of the Maine Senate. It is an awesome responsibility and I will do everything within my power to live up to your expectations and the expectations of the people of this great state of Maine. I'm also honored to be the 5th President of the Maine Senate from Waldo County. Mr. Buzzell was the last one in 1925, just in case you're wondering. I'm sure President Buzzell is well pleased today. Thank you to the Senator Majority Leader, Garrett Mason, for nominating me and for the kind words. Thank you to my friend, Senator Ron Collins. You truly are a friend. Senator Alfond, we often disagree on matters that come before us. We have different backgrounds, but there is no doubt that we have a common bond. You and I both love the great state of Maine and its people and are committed to make sure it is a better place for all of them to live and work.

I would like to recognize two former Presidents who are with us today. Former President Kevin Raye of Washington County is here with us today. Senator Raye served as the President of the Maine Senate just two short years ago when I was a freshman in the State Senate. He set a tremendous example of how to perform this duty and I aspire to do as good a job as he's done. Senator Raye, thank you for being here. We also have with us today the former President of the Maine Senate, Rick Bennett. For many of us Republicans it was decades, it seemed, before we had another Senate President and we're really excited that Rick was able to join us this morning and we appreciate him being part of the festivities.

You know we all have our own interesting journeys that have brought us here today. I know that I wouldn't be here today if it weren't for the unwavering support of my bride, my beautiful bride, of nearly 30 years, my wife, Stacy. She's here in the Chamber today along with our two beautiful daughters, Megan and Sarah. My Mom and Dan, Vaughn and Frances Thibodeau, are here as well, along with my siblings. You know, it is our parents, just like many of yours, that taught us the work ethic that

would not allow us to quit. I want to publicly thank them for all they've done for me. Thank you.

As I look before me today I see many familiar faces on both sides of the aisle. Some of you are returning Senators who served together last time, some of you are House members that have come down to the upper Chamber, welcome, and others are serving in the Legislature for the very first time. We have some folks that made the conscious decision to return to the State Senate. Senator Diamond, it's good to see you back. We look forward to the return of your famous end of session awards for the members of the State Senate. On the Republican side of the aisle, the youth movement continues. We've got Senator Eric Brakey, who's joining us at the age of 26. He now refers to our Senate Majority Leader as "Old Man Mason". They say there's got to be just a hint of truth in it for it to be funny and I think it is.

What is our charge for the 127th Legislature? Everyone has

What is our charge for the 127th Legislature? Everyone has their own opinion on what the voters said during the last election. What can't be disputed is that, as the result of the election, we now have a Republican Senate and a Democratic House of Representatives. This means nothing happens unless we work together. In short, the voters said work it out. They don't want to hear excuses. To that end, I look forward to working with the Speaker of the House, our Chief Executive, and each one of you as we seek to solve Maine's biggest challenges. The time has come to finally act on some things that are long overdue.

You know, a few weeks ago I was in a convenience store in Waldo County, in my hometown. I witnessed a young lady come in the morning and she used a State funded EBT card to buy six lottery tickets. She didn't buy a gallon of milk. She didn't buy a little bit of gas. She bought six lottery tickets. You know, what message does that send to the cashier that began her day at 4 am to open up the store, who probably makes \$9 or \$10 an hour? What message does that send to all of us who are responsible for funding that purchase? It's time for real and meaningful welfare reform. It doesn't matter if the abuse occurs once a day, once a week, once a month, or once a year. This should not happen. Mainers have become all too familiar with stories of taxpayer funded welfare benefits being abused. These benefits are intended for the down and out and our disabled. Welfare abuse comes at their expense. It's not a victimless crime and it must be fixed. It also comes at the expense of our elderly population that's fighting for the very limited resources in State Government. In the past few years we've seen several nursing homes close due to insufficient funding. Our elderly population is the ones that raised us and worked hard all their lives. They deserve better. We can keep the promises that we made to them.

We made great progress in the previous Legislature in reducing waiting lists for the people living with significant disabilities, but until that list is at zero our work here is not done. During the campaign I met a young man in Waldo County with some of these significant disabilities. His mother carries her 24 year old son from the car to the house. He qualifies for services, yet the State doesn't have the resources to get the federal match that would take him off these waiting lists. By the time the gavel comes down at the end of this session I want to be able to go back to this young man's home and look him in the eye and say, "You're wait is over."

The key to solving our financial problems is a robust economy. We've seen tremendous improvement over the past four years with the declining unemployment rate. We're starting to see surpluses in the State budget instead of shortfalls, but in order for our economy to reach its full potential we need to give

our businesses every opportunity to be successful. That means revisiting some failed energy policies of the past 30 years. Our goal should be to make the lowest priced energy available to all Maine families and small businesses. This will drive Maine's economy and eliminate the competitive disadvantages that we have with other states that are enjoying lower energy costs. Here in Augusta we must resist the attempt to make the State budget a priority over the family budget. We simply cannot ask families to give up a bigger portion of their paycheck when they're already working hard to make ends meet at home. This will be challenging, but together we can accomplish this. For that reason, we must conduct a thorough review of all unfunded mandates put on our local communities, including our local school districts, by our State. We must eliminate unneeded expenses that they're incurring.

Finally, we are all now emerging from one of the most costly and ugly campaign seasons in Maine's history. The voters of this state have simply had enough of the negative ads that include character assignation and half-truths. My friends, we can do better than that and the people of Maine deserve better than that. It's time to stop tearing each other down and start trying to start building Maine up. Let's not look at each other as Democrats and Republicans. Let's look at each other as fellow Mainers with a common cause. We all want a better state and, except for a few folks that maybe aren't Patriot's fans and we're not sure what they're up to, we all want a better state to live in. I blew that line, by the way. Here's the challenge for all us. Let's never forget that it's the citizens of the state of Maine who have put us here and we work for them and I'm confident and, indeed, hopeful that we will do great things for them over the next two years together. Let's not let them down.

May God bless each one of you and may God bless the great state of Maine.

Senator **KATZ** of Kennebec **NOMINATED HEATHER J.R. PRIEST** of Augusta for the Office of Secretary of the Senate of the 127th Legislature.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator KATZ: Thank you very much, and let me be the first to say thank you very much, Mr. President. It is an honor to rise this morning in this great institution to nominate Heather Priest of Augusta as Secretary of the Senate for the 127th Maine Legislature. On paper, Mr. President, her qualifications speak for themselves. Number one, and perhaps most importantly, she is a holder of a coveted high school diploma from Conv High School class of 1983, a Husson College graduate, and a person who has spent almost her entire adult life here in this building, all the while being married to Keith and being a wonderful mother to Keith II and to Maggie. She worked her way up the rungs of the ladder of the staff in the lower Body; clerical aide to aide to senior aide and eventually became the Clerk of the House in the lower Body in the 125th Legislature, where she performed incredibly well. In many ways it's a job similar to that of Secretary of the Senate in this Body. I kind of look at it as like she had a great career in

Triple A and now she's coming to the Major Leagues. Because of Heather's performance as Clerk of the House, we can really see what we are getting: someone who will be competent, honest, bipartisan, an excellent parliamentarian, and someone who calls them as they see them. Beyond her public service, Mr. President, this is in her blood. Her father, Richard Ross, served in the Maine House. Her sister, Julie O'Brien, served in the Maine House. Her brother-in-law, Mark O'Brien, served as Augusta's Mayor. While we're at it, her step-father, Ed Coffin, was my Peewee Basketball coach. Most significant, Mr. President, is the connection with her mother. Heather's mom, Mae Ross Coffin, was the first woman ever elected to serve as the Secretary of the Maine Senate in 1977 and she served with distinction for many, many years. Mae Ross is one of my favorite people. She's here in the Chamber today with us and it's wonderful to see her here. I know how very proud she is of her daughter. On a personal note, Mr. President, I'd like to take you back to a stormy day in the January of 1977, the day that Mae Ross was first nominated for election as Senate Secretary. On that day the Senator from Kennebec rose to nominate her; that was my father. I'm particularly honored that today, almost 38 years later, I have the privilege to rise to nominate her daughter, Heather Priest of Augusta, to be the next Secretary of the Maine Senate. Thank you, Mr. President.

Nomination seconded by Senator CUSHING of Penobscot

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Cushing.

Senator **CUSHING**: Thank you, Mr. President. Ladies and gentlemen of the Senate and guests, it is my honor today to rise to second the nomination of Heather Priest as Secretary of the Senate. On a personal level, I had the opportunity to work with Heather in many capacities. She served as my aide. I worked with her in leadership in the House. I have found her to serve this institution with honor and distinction and I know that the opportunity for her to follow in the footsteps of many other Senate Secretarys, especially her mother, will be special to her. It is without further ado or need to add to the good Senator from Kennebec's comments, that I would like to second the nomination. Thank you.

On motion by Senator **LANGLEY** of Hancock, nominations ceased.

On further motion by same Senator, one ballot was cast, on the part of the Senate, in favor of Heather J.R. Priest of Augusta for the Office of Secretary of the Senate for the 127th Legislature.

Senator **DAVIS** of Piscataquis **NOMINATED SHAWN L**. **RODERICK** of Readfield for the Office of Assistant Secretary of the Senate of the 127th Legislature.

THE PRESIDENT: The Chair recognizes the Senator from Piscataguis, Senator Davis.

Senator DAVIS: Thank you, Mr. President. Ladies and gentlemen of the Maine State Senate, first congratulations, Mr. President, and congratulations to all my colleagues. It is with great honor that I present to you and nominate my good friend, Shawn Roderick, for the position of Assistant Secretary of the Maine Senate. Shawn grew up in Anson, Maine. Having served as Assistant Clerk in the House in the 125th Legislature, he understands very clearly the legislative process and role of Assistant Secretary and what is needed to get the job done. In regards to getting the job done, Shawn takes on a lot of extra work for himself. One of the things that he took on while we were down there was enforcement of the rules and he was real good at it. Shawn enforced the rules on the Floor of the House. He enforced the rules on how you speak to each other when you're on the Floor. He also enforced the rules on personal behavior. The one issue that, boy, you wanted to watch out when Shawn was around: don't get caught chewing gum. Shawn did not like to have gum chewing in the House of Representatives. If you were unfortunate enough to get caught, you wanted to get ready to be thoroughly embarrassed for a good long time. That went on for a considerable length of time, until the dastardly deed was committed by Shawn. Trust me, he was reminded of that and has been reminded of that and reminded of that, and today he's reminded of it again. Congratulations on that, Shawn.

Seriously, having served with Shawn when he served as Assistant Clerk, I know that this young man will bring the highest level of professionalism as possible to this new role that he's going to assume today and he has the experience that is necessary to continue the operation of the Secretary's Office at the high level that we all expect of that office. I ask you, my colleagues, to join me today in supporting the nomination of my friend, Shawn Roderick, to be the Assistant Secretary of the Senate. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator **SAVIELLO**: Thank you, Mr. President. Those were wonderful words that I get to use today to address my good friend, Mike Thibodeau. I won't tell people the jelly bean story, but ask me about it later.

Ladies and gentlemen of the Senate, it was my pleasure today to keep you warm, although I do believe there was enough heat floating around for all of us. Today, now, I get the opportunity and the pleasure to nominate my friend, Shawn Roderick, as Senate Assistant Secretary. He's more than competent to serve in this capacity. Let me tell you a little bit about Shawn that you might not know about him, other than the gum chewing. First, he's a family man. Lovely wife, two wonderful children, and I know, from my experiences and time with Shawn, those are his priorities. He's well founded. Great education. A University of Maine at Farmington graduate in Political Science. He has a rural connection, both from the University of Maine at Farmington and from the community he grew up in. He has political experience. He's worked for Senator Collins, Senator Snowe, and as the Assistant Clerk and a Legislative aide. He understands what we must do to maintain transparency in the process that we work through. Most importantly, Shawn had to deal with me. At one point I needed help as an aide and Shawn, unfortunately, was free one afternoon and soon became that person that I went to. I'm sure he got no extra money, but a lot of extra headaches. He never complained. He always responded. I know that he will take that experience, along with his family values and his rural values and his political values, to be a leader as Assistant Secretary and I urge you all to support Shawn in this endeavor. At the conclusion of the recount for State Senator in District 25, on November 18, 2014, the attorneys for the candidates did not agree on a final result. The Election Night results were as follows:

| Catherine Breen | 10,930 |

The (disputed) results at the end of the recount were as follows:

Only the Town of Long Island hand-counted their ballots on Election Night, while the remainder of the municipalities used a digital scan tabulator to count their ballots. In Long Island, the Election Night Return of Votes Cast, which was faxed to the Elections Division at 11:28 pm on November 4th, showed a total of 171 votes cast. During the recount, one team was responsible for re-counting Long Island's ballots. There were 4 bundles (lots) of ballots in the tamper-proof container each with a tally sheet wrapped around the lot. The tally sheets for three of the bundles totaled 50 ballots each, matching the number of ballots in the lot. and the recount tallies agreed with the election night tallies for those lots. The tally sheet for the fourth bundle showed 21 total ballots, but the bundle contained an additional 21 ballots that were not reflected on the tally. All 21 of the additional ballots showed votes marked for Ms. Manchester. Thus, 192 votes were tallied at the recount. After the recount, on Monday, November 24th, representatives for the candidates inspected the Incoming Voter List for Long Island and agreed that there were 171 voter names checked off as having voted, including 34 absentee voters.

In several other towns and precincts in the district, there were minor discrepancies between the total votes tallied on election night versus the total votes tallied during the recount.

A comparison of the recount totals to the election night totals for the town of Gray showed a loss of three votes for Ms. Breen and a gain of three votes for Ms. Manchester. The attorney for Ms. Breen sought to recount the votes in Gray to test the accuracy of these numbers, but counsel for Ms. Manchester did not agree. The attorney for Ms. Breen did not agree to the recount results; thus, the election remains in dispute. When an election for State Senate remains in dispute after the recount, the Maine Constitution, Article IV, Part Second, Section 5, and 21-A M.R.S. § 737-A sub-§ 10, require that the Maine Senate determine the outcome of the election.

The Maine State Police are in custody of the materials related to this election. You may reach me at 624-7736 to make arrangements for the transmittal of the recount materials. I will make myself available to provide information and answer questions about the election laws and procedures, as well as the recount laws and rules, including the *Rules for Determining Voter Intent*. These rules (which had previously been published as

guidance) were promulgated in 2010, pursuant to the Administrative Procedure Act and in accordance with the statutory directive in 21-A M.R.S. § 696(6).

Re: Petition to the Maine State Senate to Conduct an Investigation on Irregularities Found During the Recount of Senate District 25

Dear Secretary Grant:

I was the Democratic candidate for State Senate to the 127th Legislature from District 25 in the November 4, 2014 general election. On election night, November 4, 2014, the official tabulation reported to the press and the Secretary of State showed that I was the apparent winner of Senate District 25 by 7 votes (10,897 to 10,890). The next day the overseas ballots (UOCAVA) were counted and added to the totals, which made me the apparent winner by 32 votes (10,930 to 10,898). A recount of the election was requested and after the recount occurred on November 18, 2014, the tabulation showed my opponent, Cathleen Manchester, winning by 11 votes (10,927 to 10,916).

That recount showed multiple alarming inconsistencies and irregularities in both the vote totals and the election and recount processes themselves. To ensure the integrity of the election results, I formally request that the Maine State Senate conduct a thorough, full, fair and impartial review of all of the issues surrounding the recount. The forty (40) disputed and questionable ballots are more than sufficient to change the results of the election.

Kate Knox, recount counsel for me and the Maine Democratic Party, refused to sign off on the recount totals that evening because of a number of alarming issues that arose during the recount process, which are outlined below. In light of these

issues, I respectfully request that the Senate review the following, at a minimum, as part of its investigation:

1) Town of Long Island – 21 More Ballots Than Voters

On Election night, the Town of Long Island warden's return indicated 171 votes had been cast in the Town, including 95 for Breen, 65 for Manchester, and 11 blank. During the recount, an additional 21 ballots were found in the locked ballot box for the Town, all together and only marked for Manchester. Thus, after the recount, there were 192 ballots, or 21 more votes than indicated in the warden's return.

These newly found phantom ballots were discovered in the final "odd" lot of ballots counted from Long Island. The tally sheet wrapped around this combined lot of 42 ballots, however, included only 21 ballots. The 21 phantom Manchester ballots discovered during the recount had not been recorded by the local official who completed the tally sheets on Election Day.

These issues were recognized and discussed during the recount by my counsel, the Assistant Secretary of State, and counsel for Manchester and the Maine Republican Party (the "MRP"), but final resolution of any challenges was delayed while recount officials reviewed the other Long Island ballots to ensure extra tally sheets had not been added to other bundles. At the end of the recount, no resolution could be agreed on by the parties and no re-examination of the ballots was allowed.

In a further attempt to determine how 21 new Manchester ballots could appear at the recount, representatives from the Maine Democratic Party, the MRP, the Office of the Secretary of State, and I met on Monday, November 24, 2014 to open the locked Long Island ballot box to review the official incoming voter list. Our goal was simply to verify the number of voters who cast ballots (including absentee ballots) for the November 4, 2014 election. The results confirmed our worst suspicions: All present at the inspection agree that the incoming voter list shows that only 171 ballots had been cast in the Town of Long Island, not the 192 found during the recount.

There are therefore three separate documents from Election Day which demonstrate that only 171 legitimate votes were cast in Long Island for the State Senate race. First, the incoming voter list shows 171 voters either voted in person or by absentee ballot. Second, the warden's return of votes cast also shows 171 votes by Long Island voters in the Senate race. Third, the written tallies wrapped around the lots of ballots from Long Island show 171 votes were cast and counted in this specific race.

All the available evidence shows that 21 more ballots were counted than people who voted in Long Island. In light of this alarming information, I respectfully request that the Senate Committee do the following, in a timely manner:

A. Conduct a full independent review and recount of all of the Long Island ballots and materials sent to the Secretary of State after the election:

- B. Subpoena the Long Island Town Clerk and any other persons who came into contact with the ballots and review any other documents related to the election in the possession of the Town:
- C. Take any and all steps to fully investigate how the additional 21 Manchester ballots were placed in the ballot box sent to the Secretary of State's office.

2) Towns of Cumberland and Westbrook - 10 Missing Ballots

During the recount on November 18, 2014, a total of ten ballots were found missing from the election night count, including four in the Town of Cumberland and six in the Town of Westbrook (two in Ward 1, four in Ward 4, and two absentee). Initially there were additional missing ballots from Westbrook, but during the recount the State Police retrieved the local ballots from Westbrook Town Hall which had not been sent to Augusta, and upon further review of the local ballots the counters were able to locate some of the missing state ballots. However, ten (10) ballots remain unaccounted for. That means ten (10) voters from District 25 have been denied their right to vote and select the candidate they wish to represent them in the State Senate.

At a minimum, the Senate should: Take any and all steps to conduct a full review and recount of all of the Cumberland and Westbrook ballots, including any additional materials, local ballots, and ballots from sections of Ward 1 and Ward 4 that are in a separate but abutting Senate district, in an effort to locate the missing ballots.

3) 9 Disputed Ballots

The parties were unable to resolve disputes for nine ballots during the recount. I respectfully request that the Senate review the nine disputed ballots and determine the outcome for each.

4) Town of Grav - 3 Switched Ballots

The recount total for the Town of Gray showed that three ballots originally counted for Breen on election night were switched to Manchester during the recount. Gray is a machine-counted town, and switched ballots between candidates are extremely unusual – normally any additional votes shown for a candidate during a hand recount come from blank ballots where the machine may have missed a mark. Additionally, none of these ballots were flagged by counters during the recount as having usual or confusing marks of voter intent.

As a result, the Senate should: Take any and all steps to conduct a full review and recount of the Gray ballots.

It should be noted for the record that on the day of the recount, requests were made by legal counsel to review and recount ballots in an effort to resolve these issues quickly and efficiently during the recount process. Those requests were denied by legal counsel to the Manchester campaign and the Maine Republican Party. As a result, my legal counsel refused to sign the final tabulation sheet for the recount. That highly unusual action is the result of our deep concern about the results of this recount – and

essentially challenges the results of the recount in their entirety. The inconsistencies and mystery surrounding the SD 25 election and recount are alarming. At a minimum, the Senate should fully investigate the circumstances surrounding the additional 21 phantom Long Island ballots, conduct a new review and recount of the ballots cast in Cumberland, Gray, Long Island and Westbrook, and after its investigation, report its findings to the public.

The Senate should conduct a full investigation of these matters to ensure that the integrity of this election is upheld.

WHEREAS, it is with great sadness that We, the Members of the 127th Legislature, now assembled in the First Regular Session, take this opportunity to honor the memory of the Honorable Millicent M. MacFarland, known as Millie, who served the Maine House of Representatives as a dedicated public servant for many years; and

WHEREAS, Ms. MacFarland was born in Augusta, Maine and was educated in Whitefield schools, graduated from Erskine Academy in South China in 1974 and attended Thomas College and the University of Maine at Augusta, where she earned her Bachelor of Science degree in Public Administration; and

WHEREAS, Ms. MacFarland served the Maine House of Representatives in various capacities for over 30 years, including 8 years as Assistant Clerk of the House of Representatives and service in the distinguished position of Clerk of the House of Representatives from 2000 to 2010 and from 2013 to 2014; and

WHEREAS, as Clerk of the House of Representatives, Ms. MacFarland worked closely with the Speaker of the House on issues of parliamentary procedure and administrative matters ranging from scheduling to developing personnel policies of House employees and oversaw the daily operations and workflow of the House under the direction of the Speaker of the House; and

WHEREAS, among her many professional contributions, on the national level Ms. MacFarland was elected by her peers to serve in every leadership post of the American Society of Legislative Clerks and Secretaries, including service as President in 2009, and in 1995 she became the first editor of the Journal of the American Society of Legislative Clerks and Secretaries, a publication that discusses topics such as parliamentary procedures, management and technology in state legislatures; and

WHEREAS, Ms. MacFarland was a member of the Mason's Manual Commission, which is a commission entrusted with the copyright of the premier guide on legislative procedure used by legislatures in the United States; and

WHEREAS, Ms. MacFarland received the Legislative Staff Achievement Award from the National Conference of State Legislatures for her dedicated and excellent service to the Maine Legislature in 1996, the first year the award was given; and

WHEREAS, from 1996 to 2002, Ms. MacFarland served as either permanent secretary or parliamentarian for the Maine

Democratic Party State Convention, and she was active on the Maine Legislative Memorial Scholarship Committee and the Joseph W. Mayo ALS Scholarship Committee; and

WHEREAS, throughout Ms. MacFarland's tenure, she served with honor and distinction and displayed unfailing professionalism, integrity and expertise, and she exemplified the dedicated public servant with her commitment to the Maine Legislature and to the State of Maine; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-seventh Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to pause in a moment of understanding and prayer to inscribe this token of sympathy and condolence to all who share our sorrow at the passing of the Honorable Millicent M.
