The Honorable Nancy Randall Clark, of Freeport, the first woman to serve as Maine's Senate Majority Leader. Ms. Clark was a highly regarded member of the greater Freeport community and a leader in Maine politics. She was born in Portland and attended Freeport schools. Ms. Clark received her teaching and business degrees from the University of Maine and Husson College and a master's degree from Bryant College. She was a teacher for 40 years, first in Scarborough and then in the Freeport school system. She was an involved member of the Maine Teachers Association, where she served as president. Ms. Clark was elected to the Legislature in 1973 and served for 20 years, with 3 terms in the House of Representatives and 7 terms in the Senate. She served one term as Assistant Senate Majority Leader and 3 terms as Senate Majority Leader. She was a member of Harraseeket Grange No. 9 for more than 4 decades, having served on the Executive Committee of the Maine State Grange, and she was a longtime member of the Order of the Eastern Star. Ms. Clark was involved in many professional, community and service organizations, was a member of the Cumberland County Retired Educators Association, a member of the Board of Directors of the Maine State Society for the Protection of Animals for 37 years and a member of the Daughters of the American Revolution for 39 years. She was a lifelong member of the South Freeport Congregational Church. Ms. Clark will be greatly missed and long remembered by her family, her friends and those whose lives she touched:

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Gerzofsky.

Senator GERZOFSKY: Thank you, Mr. President, Ladies and gentlemen of the Senate, I'd like to rise today to pay tribute, to speak for a brief moment about not only my friend, Senator Nancy Clark, but also my Senator. She was my Senator. Many, many years ago Nancy Randall Clark from Freeport helped get me a job in this building. She mentored me in a lot of ways. I saw her mentor a lot of people in a lot of ways here. I saw Senator Clark come to work every morning, good weather and bad weather, to represent not only her district but all her issues, all her concerns. She loved this institution more than most things, but she loved her Grange, she loved her education, teachers. There used to be a building out here that no longer stands here. It used to block our view of the museum. For many years a lot of us didn't know there was a museum over there because we had this big brick building. It was the Department of Education out here. Nancy, I'm going to call her Nancy as my friend, used to think it was a way of treating me special when I was on staff. She would have -- back then we didn't have the computers and stuff. She would be taking books back to Freeport or to one of the schools in Brunswick or someplace else. She would say, "Stan, do you want to get a break out of Chamber? I want you to go over and grab some books." Well, there was never ten books. It was always one hundred books. I was always breaking my back with the dolly,

trying to get them over to her car and stuff. She thought that was great fun, and so did I because it gave me an opportunity to get out of the building for a moment. As a staffer, in the summertime, that meant something.

Watching her do her daily job here, watching how she communicated with everybody, whether they were staff or they were other Senators or if they were Governors, to see her be able to do her trade of being a Legislator, I learned an awful lot; but I watched her with other people, how she mentored them and they got to learn. I've known a lot of legislators over the years. She was one of the strongest, most even tempered -- until you angered her -- legislators I ever worked with or saw. When I got elected, I didn't have a bigger supporter in my whole district, or the whole state, than Nancy Randall Clark. I could always hear her in the back of any crowd, "You give them hell, Stan." She used to love to say that. I have her saying that on a commercial once on television. She always brought a smile to people. I saw her work with young children up here, pages, my own daughter. They all loved her and they all still think about her and talk about her. I put an article out on the desks today. One of her lobbyists wrote it years ago. It's about Senator Clark. I could not express it better than that article because it's so accurate; how she was and how serious she took her job.

What a leader for women in this building. Every woman that ever serves in this Chamber should thank Nancy for a lot of her trailblazing, a lot of the things that she did. There was a time when she was in the House, in the other Body, a long time ago and Representatives, male Representatives, would always call her ma'am. They used to call a lot of our women legislators back in those days ma'am. She lost her temper one day, and I was there to see it, and she yelled at one of the Democratic legislators from the House. She said, "I earned the respect of being called a legislator, being called Representative Clark. There will be no more ma'am." By golly, I'll tell you there was never any more ma'am about it. They called her Representative or they called her Senator Clark after that. She was the type of person that could look demure. She could look nice and calm, but there was a volcano if you got her going.

She did the people's work tirelessly, not only every day she was here but in her retirement years. She still drove the bus for the seniors in Freeport to all their events. If there was a parade, she was in it. If there was a meeting, she was there. She always -- up until her last days, a few days before she passed, we were together and she told me, first of all, not to be sad, that she was going to be passing. She told me about her trip. She got ill. She was out in Nebraska working for the Grange. She got ill and she had to tell me in every detail about her trip back to Maine. She had to get back to Maine. She was on oxygen. She had a very, very trying experience. She had a nephew that went out and escorted her home. She wanted to be at her home when she passed, and she was. I visited her in the hospital. I visited her back at home. She got home. She was in her house overlooking the ocean, which she loved to do, overlooking the clam flats at the bottom of her hill and watching the clammers out there harvesting the clams.

I just can't say enough, how important she was to this Body; to the women that are going to serve here or that have served here; to the members, whether they are male or female, that are in this building; to the kids that came through here and got a bit of an education from her about this Chamber. She used to love to stand in the well and tell the stories. I want everybody to at least know that and to read this article because that's really who she is.

We all serve our people and we all serve our people the best we can and we all care about the issues of this great state and we all need to be recognized for the hard work that we all do, and sometimes for darned little reward, but when we have somebody that really wants to be a pioneer and lead, these are the people we should really stand up and speak for. I thank you very much for the time, Mr. President. I appreciate the Body for listening to me, but we just lost a real giant, in my estimation. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Haskell.

Senator HASKELL: Thank you very much, Mr. President. Members of the Senate, I am one of the few people still serving who actually served with Nancy Randall Clark. I was in the House when she was here in the Senate. I have some very fond memories, some of those you'll remember. Nancy had a little trouble with arthritis, so she was one of the first women to decide that, after the events of the morning were over, she could put on her sneakers because her feet were so sore. Mr. Gerzofsky can tell you the stories about that, but I do remember that she did not feel as though she had to comport with tradition, but that she could wear those sneakers if she needed to for her feet. The other thing that I remember about her was that she picked up every recyclable bottle, I think, in a half mile radius of this State House. No matter who had cans and bottles in their office, just in order to encourage and support them, she was the one that went around and collected them and made sure that all of those got turned back in. She was such a strong advocate for issues like that. Those are just little things that I remember about her, but I also remember the first time that I met her. I was a freshman Representative, coming in, and I had known Nancy Randall Clark and I had such admiration for the ground that she plowed for women to come and serve, for her open-door policy around supporting, helping, and making sure that women knew they had a position here in the State House. The very first day that I walked in, I think it was the day that we were sworn in, she was sitting in one of the seats in the rotunda and I walked up to her, very meekly because I was a freshman Legislator, and said, "I'd like to introduce myself to you. I'm Anne Larrabee." She said, "Oh, I know who you are." I've got to tell you, my back straightened up and I thought, "Wow, Nancy Randall Clark knows who I am. That's got to be a big deal." It was a big deal. It was a big deal to have her for a friend and a mentor and a colleague and she will be fondly remembered for all of those wonderful things. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Diamond.

Senator **DIAMOND**: Thank you, Mr. President. Ladies and gentlemen of the Senate, just briefly. You've heard most of what I was going to say. You've heard it said much better than I could. I do want you to know that she really was a giant and unique. Not only would she pick up bottles, for example, but you'd see her car pulled over on the turnpike from time to time because there would be some trash out in the field that she felt was disgraceful for the state of Maine, so she would waddle out there and get that trash and bring it back and put it in her car. That was the kind of person she was. She was very, very unique and she was tough. She did have arthritis, very serious arthritis. Many days she would tell me it was very difficult just to get out of bed, but she

never missed a day. That's the kind of woman she was. Just one quick story, the first time I met her. The first time I ran for the House and my race was very close and had a recount. I had to do that whole recount process. I was feeling sorry for myself and, when the process was all done, she came up to me and said, "Well, how was that? How did that feel to go through a recount?" I said, "It felt terrible." She looked at me and said, "Well, stop whining, just don't ever let it happen again." I didn't. That's the kind of person she was. She was tough but she had that twinkle in her eye. Lastly, it's a little frustrating. Think of someone, if you would, that you know and you respect highly today, and they're kind of a giant to you and to others, and then when they pass away several years from now, many people don't even know who that person was. That's the level of frustration that some of us feel because she was such an icon and such a giant, but now, unfortunately, and that's the way it goes, most folks had never even heard of her. Maybe take that with you and thank some people today for what they're doing today because that's what counts. Thank you, Mr. President.
