the State in the availability of adequate classroom space, in the
quality of other school facilities and in access to appropriate levels
of technology for students; and

unequal educational opportunities for students, depending on the

WHEREAS, it is necessary for the Legislature to have
adequate information on the issue of classroom equity in order to
decide whether policy changes are warranted; now, therefore be it

ORDERED, the House concurring, that the Joint Select
Committee to Study Classroom Equity is established as follows.

1. Committee established. The Joint Select Committee to
Study Classroom Equity, referred to in this order as the
"committee," is established.

2. Membership. The committee consists of 7 members
appointed as follows.

A. The President of the Senate shall appoint 2 members from the
Senate who either serve on the Joint Standing Committee on
Education and Cultural Affairs or are interested in the issue of
classroom equity.

B. The Speaker of the House of Representatives shall appoint 5
members from the House of Representatives who either serve on
the Joint Standing Committee on Education and Cultural Affairs or
are interested in the issue of classroom equity.

3. Chairs. The first Senate member named is the Senate
chair and the first House member named is the House chair.

4. Appointments; convening committee. All appointments
must be made no later than 30 days following the effective date of
this order. The appointing authorities shall notify the Executive
Director of the Legislative Council upon making their
appointments. When the appointment of all members is

complete, the chairs of the committee shall call and convene the first meeting of the committee no later than May 15, 1999.

5. Duties. In conducting its study the committee shall:

A. Review relevant previous studies and analyses on appropriate classroom size, use of classroom space, the availability of other school facilities and access to computer and other current technologies;

B. Meet with state and national experts on those issues; and

C. Hold one or more public meetings to gather input on those issues.

6. Staff assistance. Upon approval of the Legislative Council, the Office of Policy and Legal Analysis shall provide necessary staffing services to the committee.

7. Compensation. Members of the committee are entitled to receive the legislative per diem, as defined in the Maine Revised Statutes, Title 3, section 2 and reimbursement for travel and other necessary expenses for attendance at meetings of the committee.

8. Report. The committee shall submit a report on the plan developed along with any recommended legislation to the Legislature by October 15, 1999. If the committee requires an extension of time to make its report, it may apply to the Legislative Council, which may grant the extension.

9. Committee budget. The chairs of the committee, with assistance from the committee staff, shall administer the committee's budget. Within 10 days after its first meeting, the committee shall present a work plan and proposed budget to the Legislative Council for its approval. The committee may not incur expenses that would result in the committee exceeding its approved budget.

Upon request from the committee, the Executive Director of the Legislative Council or the executive director's designee shall provide the committee chair and staff with a status report on the study budget, expenditures incurred and paid and available funds.
