**CHAPLAIN DOERSAM:** Thank you, Mr. President. Good morning. My name is Warren Doersam. I served a little over 20 years doing prison ministry in our jails and prisons. Part of that time I was Chaplain of the Waldo County Sheriff's Department for 10 years in that 20 years. I have since retired as Director of Maine Prison Ministry. Some of my best friends are in prison and I know what God has done in their lives. I've seen them change dramatically. They have no desire for their past life. I want to thank you for inviting me back and I wish you and your families my best to you all, and our Governor also. Where you may have strife I asked your marriage to be resolved and both parties be reconciled and there would be peace in your home.

In 1828 Noah Webster, an American Dictionary of the English Language, described patriotism as love for or devotion to one's country. Webster's original definition starts with a love for country but moved to specific actions: service to country, defense of country, protection of the rights of country, maintenance of the laws and institutions of country, and preservation of religion and morality in public and private lives. This kind of patriotism puts the needs of the country above personal or partisan desires, as well as above favor of foreign nations.

If you would like to join me in prayer, please do so. Our God who art in heaven, Holy is thy name. All righteousness abides in You for You do not err. Enable your Senators to recognize and then do what is right in Your sight today. Help us live as one who esteems integrity, truth, and trust in You and Your word. I pray for these precious people in political leadership, that they may turn to You when they need to make decisions. Please move upon the hearts of those who legislate and those who vote for them. **JOINT RESOLUTION  
COMMEMORATING THE CENTENNIAL OF  
ACADIA NATIONAL PARK**

**WHEREAS**, Sieur de Monts National Monument was created by proclamation of President Woodrow Wilson in 1916 and was renamed Lafayette National Park in 1919 and Acadia National Park in 1929; and

**WHEREAS**, Acadia National Park is Maine's only national park and was established to ensure that Maine's natural and cultural heritage, including its rocky coastline, granite mountains, clean water, diverse plants and wildlife and enduring Wabanaki and European histories, is protected and recognized within the National Park System as a part of America's heritage; and

**WHEREAS**, Acadia National Park is one of Maine's most popular outdoor destinations, with over 2,500,000 visitors annually; and

**WHEREAS**, Acadia National Park has inspired generations of outdoor enthusiasts to appreciate Maine's natural and historic wonders; and

**WHEREAS**, Acadia National Park has been named by national public polls as "America's Favorite Place" and is identified as a top destination for hiking, scenic driving and family vacations; and

**WHEREAS**, visitors to Acadia National Park spent more than \$221,000,000 in Maine during their visits in 2014, supporting almost 3,500 jobs and generating more than \$91,000,000 in labor income and \$154,000,000 in value-added expenditures in Maine; and

**WHEREAS**, more than 250 Maine organizations, businesses and individuals have joined together to plan and implement a community-based, year-long, statewide celebration of Acadia National Park's founding with an eye toward encouraging the next century of stewardship of Maine's beloved national park; now, therefore, be it

**RESOLVED:** That We, the Members of the One Hundred and Twenty-seventh Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to recognize the centennial of Acadia National Park; to express gratitude to the founders of the park; to commend the National Park Service, volunteers and park supporters for their commitment of time, financial resources and knowledge to maintain the park for all to enjoy; and to convey our hope that future generations of Maine residents and visitors will continue this commitment to stewardship of Acadia National Park; and be it further

**RESOLVED:** That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to officials at Acadia National Park and the citizens of the surrounding towns in honor of the centennial of Acadia National Park.

Senator **LANGLEY:** Thank you, Mr. President. Women and men of the Senate, I rise today with great pride to recognize the upcoming 100<sup>th</sup> Anniversary of the dedication of the Sieur de Monts National Monument, now known as Acadia National Park. In the late 1970s I was recruited from the hills, the mountains, of Vermont to come to Maine to work, specifically in Bar Harbor, One Main Street in Bar Harbor, to work at a restaurant. My football coach in high school had bought a restaurant downtown Bar Harbor and he knew of me having lived and grown up in the restaurant business, taken culinary arts at the vocational school. He called me up, with a bunch of others, to come and work in Maine. We rolled into Maine in April 1978 about midnight. I'd come across Vermont, New Hampshire, and come all the way to Maine. I'd never been to the coast of Maine before. When we landed in Bar Harbor that was the year they had torn up all the streets and that April were laying down cobblestone sidewalks, which are still there today. I started to regret my decision to leave the Old Country Inn with a Swiss chef in the hills of Vermont to come to Maine, but I was led to where my room was, which was on the third floor of One Main Street, right on the pier. The next morning I woke up, I looked out the front window, and there was Bar Island. I looked out my right hand window of my room and there was Agamond Park and the pier in Bar Harbor. That's the story that's happened to countless people when they've come to Maine. They come, they see its beauty, and they end up staying. We're not the first ones to do that because it's happened for well over 100 years, especially with those people who had the forethought to create this national park.

I'd like to share with you a few remarks that were given at the original dedication in 1916, on August 22<sup>nd</sup>, and link this special American treasure, really, to the folks who preceded us in this very Body. We have some stake and we have some claim to fame here. This is from the dedication of 1916. "The movement for the creation of a great public reservation on Mount Desert Island started in 1901 when, at the suggestion of Dr. Eliot, the Hancock County Trustees of Public Reservations was organized under general law. Two years later, in 1903, the organization of this corporation was confirmed by a Special Act of the Maine Legislature. For example, we must understand that other great hills of this island need to be brought into reservation to be held first by Hancock County Trustees of Public Reservations and then by the government of the United States. The purpose of this corporation, as stated in the Act, were to receive, hold, and improve for public use lands in Hancock County which by reason of historic interest, scenic beauty, or any other cause were suitable for such an object. I feel that we may congratulate Mr. Dore on having had the privilege of being one to whom the achievement of a great thing has come and that we may add thanks and congratulations of a future generation." As a member of a future generation, I'm here to give my thanks.

At my perspective, the Hancock County Trustees of Public Reservations was really the first Lands for Maine's Future and I would argue that it was really Lands for America's Future. The Hancock County Trustees of Public Reservations still exists today and is the governing board for the 300 acre Woodlawn Museum in Ellsworth. Dr. Eliot, Professor Emeritus from Harvard, had this to say, "One of the greatest satisfactions in doing any sound work for an institution, a town, or a city or for the nation is that good

work done for the public lasts, endures through generations, and the little bit of work that any individual of the passing generation is enabled to do gains through association with such collective activities an immortality of its own." One hundred years from now I fully expect the Senator from Hancock County to add to these remarks. As a testament to its standing in America, over 2.5 million visitors will visit Acadia this year. Please join us sometime this summer to celebrate the 100<sup>th</sup> Anniversary of the dedication of Acadia National Park. Thank you, Mr. President.

**WHEREAS**, in 1804, Elder Robert Low, Deacon Robert Herring and Michael Webber of New Gloucester purchased several tracts of land from Bowdoin College to make into lots, and Bowdoin College sold single lots to settlers; and

**WHEREAS**, the eldest sons of Low and Herring, with axes, hope and the spirit of cooperation, opened the first clearing that summer just west of the spot where Low's Bridge would soon stand, as its successor stands today; and

**WHEREAS**, in 1805, Low and Herring planted the first crop and built the first cabins to make ready the homes in which their families would settle the next year; and

**WHEREAS**, by the end of the decade, with 10 families in residence and a sawmill erected, a town meeting was held and self-government begun and in 1812, the settlement of Lowstown was organized as Plantation 6, Range 7; and

**WHEREAS**, in 1816, the settlers petitioned the General Court of Massachusetts to be incorporated and on February 8, 1816, the Town of Guilford was incorporated by an Act of the General Court; and

**WHEREAS**, 2016 is the 200th anniversary of the incorporation of the Town of Guilford; now, therefore, be it

**RESOLVED:** That We, the members of the One Hundred and Twenty-seventh Legislature now assembled in the Second Regular Session, express our congratulations and best wishes to the good citizens of our 215th town; and be it further
