

**THE PRESIDENT PRO TEM**: The Chair recognizes the Senator from Penobscot, Senator Mitchell.

(In Senate, March 29, 2004, Reports READ.)

Senator MITCHELL: Thank you, Madame President, ladies and gentlemen of the Senate. This bill that is before is not a new issue. In the four sessions that I have served in this chamber, various legislators across the state have brought this issue to the floor. It is merely a cry from municipal government to ask for choice and flexibility in deciding what they are able to do in determining what legal aspirations they can take to reach out through the legal notices that they need to publish. Currently, the law states that you are required to use second-class postal matter. The municipalities that realize that in order to meet the second part of the law, which is that you are to reach the general circulation of your population, they need to go to more than one newspaper. This creates an additional cost to the municipal government. In order to reach a compromise, we were hoping to change second-class to periodical. It also puts restrictions in the law requiring that the municipality and the local newspaper that they do decide to use under the classification of periodical meets all the standards set forth, other than the mailing standards. Also required is that the municipal record is retained on file and there is an archive by the newspaper. They must have a system to keep all past editions of the paper. It also requires that municipality officials or the legislature approve the use of that newspaper. It does take away the fear of just over-the-counter periodicals that are just handed out. They must use the periodical postal matter. This third-class mail must meet the qualifications of newspapers for publication of legal notices. I would ask you to, please, grant flexibility to municipal governments and give them an opportunity to have a choice, and not a mandate, that incurs more than the cost that they should be able to incur to reach the majority of their circulation. Please join me in voting against the Ought Not to Pass motion.

On further motion by same Senator, supported by a Division of at least one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT PRO TEM**: The Chair recognizes the Senator from Androscoggin, Senator Rotundo.

Senator **ROTUNDO**: Thank you, Madame President, men and women of the Senate. I rise today to ask you to support the Ought Not to Pass report. Current law allows only newspapers with second-class periodical designation from the U.S. Postal Service to public legal notices. Newspapers with second-call periodical designation are the only publications that can ensure timely, dependable dissemination of legal notices to citizens. To qualify for second-class designation a newspaper must, among other things, have a stated, predetermined frequency of publication, have at least 25% editorial content in its issues, and have at least a 50% paying subscription base. Moreover, only second-class publications are guaranteed to be delivered by the postal service to readers on the date of publication. Legal notices are serious business, containing information that could potentially impact the rights of citizens. Publication of them should be left to newspapers that ensure dependable, timely dissemination of this vitally important information. I ask you, please, to vote Ought Not to Pass on L.D. 1873. Thank you.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Cumberland, Senator Turner.

Senator **TURNER**: Thank you, Madame President, ladies and gentlemen of the Senate. I obviously am not as aware of what is going on in your districts in respect to the publication or the arrival of new weekly publications. I can tell you that in my Senate district there have been two new papers started in the last year. When one is seeking to get local coverage, and wants to know what is going on in their local community, the citizens of my district are going to their weekly papers, not to the papers that are published daily. I do think this is an opportunity for you to allow municipalities to use their discretion and ensure that their citizens are being properly notified and at the same time doing it in what could very well be a more cost effective manner. I would urge that you defeat the pending motion. Thank you.

**THE PRESIDENT PRO TEM**: The pending question before the Senate is the motion by the Senator from Androscoggin, Senator Rotundo to Accept the Majority Ought Not to Pass Report. A Roll Call has been ordered. Is the Senate ready for the question?
