**JOINT RESOLUTION RECOGNIZING PARKINSON'S DISEASE AWARENESS MONTH**

WHEREAS, Parkinson's disease, or paralysis agitans, is a brain disorder that affects approximately 7,000 people in Maine and approximately 1,500,000 in the United States, as well as their numerous care providers; and

WHEREAS, there are 60,000 new patients diagnosed with Parkinson's disease annually in the United States, and this disease causes a loss of cell function deep within the brain, which disrupts and may end the lives of those who suffer from it as well as overwhelm the lives of their families and friends; and

WHEREAS, the symptoms of Parkinson's disease are not well understood by or well known to the general public, and this situation creates distress and danger in the lives of Parkinson's patients; and

WHEREAS, the American Parkinson Disease Association, the Maine Parkinson Society and the MaineHealth Learning Resource Center are all established at a central location in Falmouth, Maine; and

WHEREAS, the need to train, inform and educate health workers and police officers, firefighters and other public safety personnel is urgent, and there is a need to train hospital emergency room personnel statewide in the proper assessment of incoming Parkinson's patients; and

WHEREAS, there exists a network of 11 Parkinson's support groups statewide but only one neurologist specializing in this disease in the State of Maine, making access to treatment limited for prospective patients; and

WHEREAS, World Parkinson's Awareness Day is April 11, 2006, and the month of April is Parkinson's Awareness Month; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-second Legislature now assembled in the Second Regular Session, commit ourselves to supporting all efforts by the Parkinson's disease community to close the gaps in services, training, education and care; and be it further

RESOLVED: That we recognize World Parkinson's Awareness Day on April 11, 2006 and that the month of April is Parkinson's Awareness Month throughout the State; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Maine Parkinson Society, the Maine Chapter of the American Parkinson Disease Association and the MaineHealth Learning Resource Center.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Strimling.

Senator **STRIMLING:** Thank you, Madame President. I stand in support of the motion in front of you and I encourage my colleagues to support it as well. Just to talk a little bit about what this bill does, because there certainly has been quite a bit of misinformation going out and about concerning what this is looking to do. Let me be as short and succinct as I can in terms of what it accomplishes. It says, in its entirety, an employer may not fire you because you refused to participate in a meeting in which that employer wants to preach to you about a political perspective. That is it. There is all kinds of talk going on about this limits somebody's ability to free speech. It's going to stop all the water-cooler talk in an office. All of that is nothing. This is about an employer not being able to fire you or take some kind of adverse employment action against you because you don't want to sit there and listen to them preach about how great the Democratic party is. That is it in its entirety. When you hear all of this other stuff going on, I ask you to cast it aside. I think everyone of us believes if you sit down and talk to them and say, 'Do you think your employer should be able to bring you into the office and say he wants to talk to you about his political beliefs?' He says that you will have to listen for one hour and if you stand up and say, 'I really don't want to hear about that' that they should be able to fire you. Nobody would say that is okay if they brought you into the office and said they wanted to tell you all about how fantastic Governor Baldacci is and all the great work he's done, everything he's accomplished for the state of Maine. I could run off the list. I don't have enough fingers and toes. If you don't want to hear about it, you have a right to stand up and walk out. Today your employer could fire you. Unfortunately, we have seen it in the state. We have heard about instances of it. It has happened. There is currently a case in front of the Ethics Commission in which employees for a large business were required to work on behalf of a candidate, so they are claiming. One of them protested to their employer and that employer said, 'We'll crush you like a bug if you decide not to do this work or if you mention it' this person said. Well, the employer, unfortunately, was correct. They could have fired that person right there and then. Under this bill, it gives them that protection. Madame President, I encourage my colleagues to support the motion to protect worker's rights to be able to vote how they chose and to be able to have respectful dialog in their place of employment because it is the right thing to do, Madame President. Thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Snowe-Mello.

Senator **SNOWE-MELLO:** Thank you, Madame President and ladies and gentlemen of the Senate. I stand here, of course, in opposition to the minority Ought to Pass report. Let me say that sometimes I feel that we're in two different worlds here. This L.D. 1924 should be called the Employer Gag Law. This proposal would create a new class of employment discrimination claims. This bill would do far more than what the good Senator from Cumberland, Senator Strimling, suggested. It would prohibit an employer from taking any adverse employment action because an employee refuses to attend an employer sponsored meeting to discuss political matters, union organizing, or refuses to participate in any communication concerning a political matter. Ladies and gentlemen, alleged violations could result in costly proceedings before the Maine Human Rights Commission and possibly the courts. This would make Maine the first state in the

nation to have such a far-reaching employer gag law. Is that what this state wants to do? I hope not. This is nothing more than an unwarranted assault on employers' free speech rights. Ladies and gentlemen, that is part of the United State's Constitution. That is our liberty to have free speech. It's underlying purpose is to intimidate employers and discourage them from communicating with employees about even the simplest political matters including issues that could have significant impact on the organization. This bill makes the consequences of any such communication or meeting onerous. The threat of defending ones self in front of the Human Rights Commission will place a chill on the free speech rights of employers of all sizes, shapes, and forms in Maine. This law would apply to public and private employers from the biggest to the smallest, both for profit and non-profit. Ladies and gentlemen, I hope you can see that has far more unintended consequences than the good Senator from Cumberland, Senator Strimling, referred to. I hope that you will join me in supporting the majority report and vote Ought Not to Pass on L.D. 1924. Thank you.

WE, your Memorialists, the Members of the One Hundred and Twenty-second Legislature of the State of Maine now assembled in the Second Regular Session, most respectfully present and petition the Honorable Gordon R. England, the Secretary of the Navy, as follows:

WHEREAS, nearly 300 years ago, in 1719, the Pejepscot Proprietors donated 1,000 acres of land in the Township of Brunswick to be laid out as a "general perpetual commonage to ye town of Brunswick forever"; and

WHEREAS, the Town of Brunswick accepted the gift in 1774 and laid out the 1,000 acres that would come to be known as Brunswick Commons. In 1783 a deed was conveyed to the town selectmen, and the land became property of the town forever; and

WHEREAS, an 1816 survey was recommended by the Town Commons committee as the correct survey of the land, and in 1891 granite monuments were placed to mark the boundaries of the deeded land; and

WHEREAS, the Federal Government took the majority of Brunswick Commons to build the Brunswick Naval Air Station, which served this nation well during World War II. Five of the original granite markers of the Brunswick Commons are within the boundary of the current base; and

WHEREAS, the base was deactivated after World War II in 1946 and recommissioned in 1951 and has been active since that date, providing support to the United States military as a vital part of America's defense system; and

WHEREAS, Brunswick Naval Air Station was targeted for decommissioning in the latest round of federal base closings, with the direction that the base be sold to the highest bidder instead of returning the land to its original use as described by deed; and

WHEREAS, the original deed clearly meant for this land to be for the common good of the Town of Brunswick and, while the subsequent use of the land for Brunswick Naval Air Station was important for our national security, the Town of Brunswick and the people of Maine feel strongly that, since the Federal Government no longer has need of this land, it should be returned to its original source; and

WHEREAS, the Town of Brunswick declared in 1968 the full 1,000 acres of the Brunswick Commons to be an Historic Landmark, and the Town of Brunswick and the people of the State of Maine seek to make the original Brunswick Commons whole again, at no cost to the Town of Brunswick; now, therefore, be it

RESOLVED: That We, your Memorialists, on behalf of the people we represent, respectfully urge and request that Secretary England do all in his power to see that the land deeded to the people of Brunswick be returned to the people of Brunswick at no cost, now that the Federal Government no longer wants this historical tract of land; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Gordon R. Senator **SNOWE-MELLO:** Thank you, Madame President. I'm not sure on procedure how this is going to work. Is the good Senator from Cumberland, Senator Strimling, going to explain the amendment?

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Strimling.

Senator **STRIMLING:** Thank you, Madame President. The amendment that has been put forward basically takes out the penalties that are in there and leaves in place the audit, which is the important part of this. It takes away the penalties for a future legislature to decide.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Snowe-Mello.

Senator **SNOWE-MELLO:** Thank you, Madame President, ladies and gentlemen of the Senate. Although this amendment does take out the penalties, which I approve of and I think is a good thing, I still have sort of a gut reaction to this bill. I'm not quite sure whether I will still support the bill. Let me just tell you why. Maine Insurance Guaranty Association, known as MIGA, acts as sort of the FDIC of the insurance world. MIGA is a non-profit association created under Maine law in 1969 to provide a mechanism through which claims of Maine residents that were insured by carriers that are insolvent can collect on their claims. The statutes governing MIGA are nearly identical to those in

almost every state in the country. To my mind, that is a good thing. MIGA adheres to Maine insurance code and the Superintendent of Insurance has regulatory authority over it. One thing that I was surprised to learn while researching this bill is that no Workers' Compensation Board anywhere in the United States possesses authority over a guaranteed fund. L.D. 2068 intent to allow the Workers' Compensation Board to engage in the audit enforcement and monitoring of the Maine Insurance Guaranty Association is unprecedented in this country. I understand that this legislature often likes to follow the lead of the Starship Enterprise and go where no legislature has gone before, but this is one instance where we should stay put rather than putting the ship and its entire crew at risk. I honestly don't believe that it is a good idea to go down this course. I think the way the system of MIGA has been working since its creation has worked well. Why should we change it? Another thing that troubles me is that L.D. 2068 was not approved by the Workers' Compensation Board and this is required by statute. Nor did the board act by December 1<sup>st</sup>, as required by statute, to address this issue. MIGA is already required to conduct audits on claims and financial audits, the results of which are shared with the Bureau of Insurance. Fewer than a hundred claims are currently open. I believe the figure is more like 80. MIGA has, over the years, paid more than \$98 million to Maine residents for Workers' Comp claims and issued over 90,000 checks with little trouble or complaints. I ask you not to vote for this amendment but in the future, when the bill comes back to us, I would ask that you not support the bill. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Sagadahoc, Senator Mayo.

Senator **MAYO:** Thank you, Madame President, ladies and gentlemen of the Senate. Up until the amendment, which has been proposed, I was not in favor of this particular piece of legislation. I am now, at this point.

Off Record Remarks

---

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Bartlett.

Senator **BARTLETT:** Thank you, Madame President. I rise in support of the pending motion. In our committee this bill came to us because of problems with the Maine Insurance Guaranty Association. Over the years there have been some very poor claim handling practices, unfortunately, done by MIGA. We learned that there were problems with MIGA representatives not attending Workers' Comp mediations. There were problems with them not returning phone calls for months on end. There were problems with them not paying out claims, even after a judgment had been entered against them. This is particularly important in the context of Workers' Comp. Workers' Comp laws are very different than what other insurance laws deal with. Under the

Workers' Comp system employees and employers have entered into a bargain of sorts. Employees have agree to give up their tort claims, their right to go and seek pain and suffering as well as their compensatory damages in a court of law, in return for very swift payments of medical bills and of lost benefits. As part of that, the law requires that when an order has been entered the benefits be paid out within 10 days. It also requires, if you are going to challenge a claim, that you provide notice of that within 14 days.

The purpose of that is to try to move the process along so there would be certainty. When you do not have a claims handler attending mediations, not paying out claims, and sending workers into bankruptcy, you start compromising the whole system. Those costs are just going to be pushed on to somebody else. This process was initiated simply to try to insure that MIGA claims handlers are treated just like every other Workers' Comp insurer in the state, which is that they be subject to audits to make sure that they are complying with the law.

Originally the bill had penalties imposed. This amendment takes off those penalties. We did that as a way of trying to compromise and come to an agreeable resolution that will allow the Workers' Comp Board to go in, audit the books, and just find out what is going on. Penalties are not going to be assessed under this amendment. It was constructive that at the times of our work sessions the MIGA representatives agreed with this. They agreed that, ultimately, they would not be opposed to audits. What they really didn't like were the penalties. Having met MIGA and done exactly what they requested with this amendment, we certainly hope that everybody can come and support this.

Just as a final note, in order for the Workers' Comp system to have structure we need insure that workers get paid quickly and easily and when they don't it is not just the employee that gets hurt but the employers are well. Imagine being an employer that has an employee that has missed some time, that is owed some benefits, and they are not getting paid. That is going to compromise your position, particularly if you continue to have that employee on your workforce. This is not a typical Workers' Comp battle between employers and employees. This is really a unique situation with MIGA. We may well be the first in the states to do this, but we're also the first state to have clearly documented problems. We have lots of literature that was presented to the committee of exchanges back and forth with MIGA representatives who essentially acknowledged that these claims were not handled properly for months on end and no action was taken. What we would like to do is get it out of the books and decide whether further action may be needed in the future. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Mitchell.

Senator **MITCHELL:** Thank you, Madame President and distinguished colleagues in the Senate. I reluctantly rise in opposition to my good floor leader. It is a case of a disagreement on a fundamental principle of disclosure. The amendment, which replaces the bill, simply expands reporting requirements. Let me start by saying I do not see lobbyists as a bad word. I think this

place functions very well because we have lobbyists on both sides bringing us information. I do believe that their activities should be very transparent. Current law requires that if you have contact with legislators over 8 hours in a calendar month you have to sign up and report that you've done that. You have to register with the Ethics Commission. The names are available. The amendment that the minority of the committee embraced would include that same contact to people in the administration but exclusively when it's for the purpose of influencing legislation, not just casual contact, no rule-making but for influencing legislation. I encourage you to take a look at the committee amendment. It is has a filing number of H-923. It lays out very simply would ask to report contacts with state agency officials or with the Governor for the purpose of influencing legislation only. It's simply a reporting requirement. It adds transparency and I would encourage you to vote against the Ought Not to Pass report because I think it is important that we add this measure of accountability to public life.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Plowman.

Senator **PLOWMAN:** Thank you, Madame President, men and women of the Senate. This doesn't happen very often. We usually come to agreements in the committee and I'm sorry that we do have this disagreement. While there is a need for transparency, or a perceived need for transparency, what I didn't like about this was that we are going at this in a piecemeal approach when there is actually a select committee that has been put together in order to look at lobbying in a comprehensive way. There is a lot of debate in this committee on who would be covered, with fine lines being drawn between an official of the Governor, a member of the staff of the Governor's Office, a commissioner, a commissioner's designee, and would lead you to believe that the loophole would be the things that we'd be looking for here. The majority of the committee found that we'd be more comfortable looking at this in a very comprehensive manner instead of trying to react to a situation of the day in the papers. I would ask you to join the majority of the committee and defeat this bill. We'll be back with some recommendations, I'm sure, from the people who have worked on this process and are ready and eager to get it when we finally do adjourn. I appreciate that we have a disagreement. It is certainly never personal in our committee and I thank you for your attention.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Gagnon.

Senator **GAGNON:** Thank you, Madame President, men and women of the Senate. I am on the majority side of this bill. It didn't come down, to me, as some great love for lobbyists. For me it ended up being an issue for our Ethics Commission and what they may be saddled with and burdened with. In the past the standard has been always those who are professional lobbyists are who are trying to influence those who actually have a vote. We have a vote. Members of the other Body have a vote. The Governor, ultimately, has a vote with his pen, whether he vetoes or signs a bill. All of those people are covered. That's all covered. If you spend more than 8 hours a month in this building then you have to be a registered lobbyist, pay your \$200. We know who you are and you have to report.

This bill will go one step beyond that. It will now require those who try to influence the influencers of the legislature. In other words, those who come before us from the administration or other offices who try to influence us either to pass or reject certain pieces of legislation. To me that was somewhat of a slippery slope, I guess, and opening up a whole new area which blurs the lines as to who the influencers really are. The fact that I am concerned about is what we will end up doing and how we will end up funding this. The first year of this, if I read the amendment correctly, is going to be funded by the additional fees that people will have to pay. Clearly there will be a lot more people who will have to be registered, so they are covering the additional costs in the Ethics Commission but that funding goes away in the second and third year. Clearly, there will be a funding issue in future years with the Ethics Commission and I think that we want to make sure the Ethics Commission understands what the roles are. The people who are influencing those people who can actually push these buttons or push that signature pen is where we want the attention to lay. I am encouraging you to support the majority report. Thank you.

On further motion by same Senator, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Diamond.

Senator **DIAMOND:** Thank you, Madame President, men and women of the Senate. Lobbying, obviously, is a very highly respected profession. I spent 8 years doing that in these very halls and have a high regard for lobbyists and the job they do, especially in the state of Maine. Having done it for 8 years and also having been a head of a department, I can tell you that I truly and sincerely believe that commissioners and department heads should be included in those who are contacted and lobbied. If the Governor is included, certainly his or her commissioners need to be. The fact of the matter is that if the department head is lobbied than that should be reported because the influence of the contact is significant. We must remember that. Again, this is not a reflection on lobbyists in Maine or the lobby profession. It's simply a matter of fact. When those types of folks are contacted they have an unusual amount of influence. I think it's fair, appropriate, and reasonable that this be recorded. Thank you, Madame President.

**THE PRESIDENT:** The pending question before the Senate is the motion by the Senator from Kennebec, Senator Gagnon to Accept the Majority Ought Not to Pass Report. A Roll Call has been ordered. Is the Senate ready for the question?
