The real spring had come.  Let us pray. We thank You, Lord, for giving us this wonderful green world in which we live. We thank You, Lord, for giving us yet another spring. Amen.

#### READ.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Haskell.

Senator **HASKELL**: Thank you very much, Mr. President. Men and women of the Senate, it's such a pleasure today to have Derek Pierce here with us. I'd like to tell you just a little bit about him. I won't tell you all about him and he'll be very glad about that. The first thing you need to know about this gentleman is that this school, now you've got me started on this one, yes, I've got

that one but I tripped over it. One of the interesting questions he sometimes asks kids when they first get into high school is: tell me three things about you, two truth and one lie. Well in an interview somebody asked Principal Pierce that guestion and here were his three things he said: I was turned down to host Saturday Night Live; number two, I was a national athlete featured in Sports Illustrated; and three, I always wanted to be a Principal. Can you guess which two are true and which one is the lie? Turns out the first two are true. Indeed, he, being a fan of Saturday Night Live, wrote them a letter and decided that the show, at some point in time, should be hosted by just some guy. They turned him down, but at least he applied and was turned down by Saturday Night Live. Sports Illustrated, it looks like a basketball player, but no, it was called Team Wrst" which competed that year in the U.S. National Toboggan Championships in Camden and they specialized in being horrible. finishing last, and in tailgating. He said that the project involved a lot of sausage links and self-deprecating humor. There you have it. That's the man that's leading our children.

Let's get back to business a little bit because he's a lot more than just a funny guy. He is truly a genuine leader. He's, one of the great strengths that he has is he doesn't allow himself to get too comfortable. Well, if you ever went to his school, I don't believe he has an office. I've never seen him anywhere except on his feet on the floor with students, but maybe he has one. He taught for a couple of years in Los Angeles and then decided he had an obligation to grow more, to enlarge the field of education rather than just merely maintaining it. He earned a master's degree in education from Harvard in 1993 and, eager to settle in New England, he went up to Gorham High School, where he taught for five years, and then he saw an opportunity in Poland, where the chance to start a new school, too good to pass up. That was years of just this titanic energy and bold ideas which came to that school. That was the first school in our state to require every senior to fill out an application to college. It didn't matter where they were going to work, what they were going to do, but they were going to fill out an application to college. It has remained a part of what happens at Casco Bay High School. They actually go and march right to the post office and mail those at one particular time. This is a part of, and this is only a brief part, but this is a way of understanding what expeditionary learning is really all about. This school, about 275 students, has a waiting list of more than 100 families waiting to get in. It's a place where rigor, relevance, and relationships are paramount. It's really, it really grew out of Outward Bound, where students tackle multi-disciplinary projects, long-term in-depth studies of a single topic that involves field work and actual real work. This year the junior class studied coal mining and energy consumption. Good grief, I'm going back to school. Consumption, and their studies culminated in a trip to West Virginia and they met and interviewed people whose lives were touched directly by that issue, and then did a documentary about that experience. Casco Bay students go deeper but into fewer topics. They go deeper, bigger issues come up, and complex connections among the fields of study immerge. One last thing I'll tell you about is what they do at graduation. They are required to stand on stage and present themselves to their community, share what they learned, how they grew, and what they're doing. This has been very powerful for Casco Bay. In 2010 it was named a model school by the International Center for Leadership in Education. In 2014 they won \$100,000 in the Leadership Award from the Nellie Mae Foundation, which was plowed right back in,

at the Principal's request, to scholarships and projects. Here's what some of the students said at the end of their time: "Casco Bay forces you to step outside your comfort zone and do things you might never think of doing," "Growing up with obstacles has taught me the blessing is in the struggle. I feel more ambitious and inspired by my past and will use the lessons I've learned as the backbone for my future." These are kids graduating from high school. Rita said, "I came to school broken, I was simply surviving, when the school wrapped me in an invisible blanket and kept my strength, my warmth, inside." These are wonderful things to have happen at a high school. This is a Principal who knows the name of every one of those students who walks into his school and he knows their story, he knows them personally, and I'm very proud that it's in my district and that this amazing Principal will be representing the state of Maine. Thank you, Mr. President.

Senator ALFOND: Thank you, Mr. President. Ladies and gentlemen of the Senate, I will be incredibly brief and that's hard to do because, as you've just heard, Principal Pierce is quite a leader. I think we all every day get up and I think we all try to do our best and I think what really, to me, validates what we do is what other people think of us, how they respond to us. Do they react well? What do they say when you say, you know, Principal Pierce? There is no one better, for me, to understand that than the students. When Casco Bay High School received \$100,000 from Nellie Mae students were there, all around, receiving the award, speaking about the award, and you should have heard the compliments, the credit, the team effort, the collaboration that Principal Pierce has created at Casco Bay High School. I'm sure every single one of us would have wanted to be there, go to school there, and be under the leadership of Principal Pierce because he is really an outstanding leader for our state and it's just a terrific day for our state when we can recognize someone who is doing such good work for our young people of the state of Maine. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator KATZ: Thank you, Mr. President. Men and women of the Senate, this amendment does a couple of things. First of all, it takes L.D. 1523, which refers to increases in compensation for certain law enforcement supervisors of 5%, and it combines it with L.D. 1653, which was a more broad based bill which gives more significant raises to many other law enforcement personnel and many in various state law enforcement departments. What it does, Mr. President, instead of having the 18% raises, 17%, 15% depending on the department, the amendment would grant raises to all of these folks, both the supervisors and the members of the other various departments, of 5%. By doing so it would reduce the fiscal note from approximately, the total spend I should say, from about \$6.5 million to around \$2.4 million. Mr. President, there's no question that we know that raises are necessary for several of our law enforcement departments in order to assist them with recruitment and retention, but we suggest that this amendment does so in a much more fiscally sound and prudent way at this time. It gets an immediate raise to these folks but allows for a more reasoned and thoughtful approach to raises in the future, which can be accomplished in really several ways. One would be by finally taking a look at and implementing the studies which have been done, including the crescendo study, which looked at the appropriate raises for law enforcement. Secondly, Mr. President, this Legislature would have an opportunity to revisit this issue in January. Third, Mr. President, and perhaps more importantly, it would allow the usual process of collective bargaining to go forward, where the Executive Department and the various bargaining units could work out, by agreement, appropriate increases for pay, which I think we all agree in the usual course of events is the best way to do so. This bill, Mr. President, funds these raises by first looking at existing resources, secondly to the salary plan, and third, if absolutely necessary, to the General Fund. It's a down payment on raises we know are going to be necessary, but on the other hand it does so in a fiscally responsible way that recognizes that collective bargaining is generally the most, the preferred manner, of going ahead with raises. Thank you, Mr. President.

Senator MILLETT: Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise in support of my amendment to L.D. 1699. The Education Committee worked this issue that this bill addresses and decided, unanimously, that this issue would not best be dealt with through Education statute, that, in fact, it needed to be addressed through the Taxation Committee. Representative Stearns, Representative Tipping-Spitz, and myself spent an afternoon in the Taxation Committee discussing the intricacies of sudden and severe property evaluation decreases. We revisited this issue later in the session when we were asked to support addressing the sudden and severe valuation decreases for a number of communities in the state of Maine. The committee unanimously supported a letter to the Appropriations and Financial Affairs Committee asking them to take action for fiscal year 2016-2017, but in a manner that does not impact other districts across the state. I was dismayed to see then this bill come before us which, in fact, goes against what we unanimously agreed in committee and, going beyond providing relief in 2016-2017, institutes significant policy changes for education funding. Make no mistake, the way this bill is currently written, moving forward from 2016 to 2017 districts across the state of Maine will be negatively impacted by this language, seriously and significantly. This deserves the regular legislative process, which we all have come here to participate in and respect. My amendment would simply say that for fiscal year 2016-2017 relief would be provided to these communities that have experienced severe and sudden evaluation decreases and then allow us to come back and discuss this matter in the proper fashion. I hope that you will all join me in supporting this amendment which, again, does provide relief to those communities who have experienced sudden and severe devaluation and then we can come back and do the legislative process correctly. Thank you, Mr. President.

Senator **MASON** of Androscoggin moved to **INDEFINITELY POSTPONE** Senate Amendment "A" (S-519).

Senator **ALFOND**: Thank you, Mr. President. Ladies and gentlemen of the Senate, I just want to reinforce what my colleague from Cumberland just said. We, right now, have an opportunity to do a fix; do a fix that was often done in this place before we had the funding formula. We had cushions. We had fixes. We had all kinds of things that we used to do that really made this place go upside down. It was who was on Appropriations, who was on the Education Committee, who was the President of the Senate, who was the Speaker of the House. We are going back. We could be going back in time. I think it is okay to go back in time because of what's happening to our mill towns and we're creating that fix right now. We've over \$900,000 to be going to a few communities that have had sudden and severe losses. Now if we don't pass this, and move onto

something else, you know those 279 that everyone gets and every one of our communities gets and they look at because that is probably one of the most important things we do in this Legislature? Those things are all potentially going to change. They're all going to potentially change because of this vote right now. If you think this is a small vote, I kid you not, you're superintendent is going to know about this vote. This vote right here is one of the bigger votes that we're going to take in this entire time because every 279 can potentially change because of this vote. We have a chance to do something right, which is thoughtful, and fix these four or five communities, or we can open up the funding formula. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Hancock, Senator Langley.

Senator LANGLEY: Thank you, Mr. President. Men and women of the Senate, this bill does help those communities with sudden and severe, that are affected by this loss in the mill rate, and they evaluation decline, but what it also does is it has increased the trigger from 2% to 4.5% from the next most recently certified State valuation. What that does, in this bill it says that if a municipality saw from one single employer a loss of more than 4.5% in valuation from the year before that that would get averaged in with the previous three years rolling average to set a new rate for that year. What it does is it doesn't make them all whole. It creates a softer landing. It splits the difference, really, from their true loss. This is definitely a mid-range solution to this and what it also does, as I said before, it creates a hurdle that's much higher for municipalities to reach going forward in the future. It would have to be, for lack of a better word, a one-horse town that had one employer in it that went down and those folks really would be the ones that would need the most help. It sets in place something that creates a soft landing, it doesn't disrupt the whole formula, and, frankly, let's hope it's not in any one of our towns that we live in when this happens. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator MILLETT: Thank you, Mr. President. I certainly appreciate the sentiment of my colleague from the Education Committee. My amendment allows for rectification of 1617 sudden and severe devaluation. It's unfortunate that a few people in the last wee hours of this session met to develop education statute changes without the full participation of their committees, the public, and Maine citizens. I would encourage you to support this amendment so we can provide relief for these communities, I am sympathetic to their cause, but then allow our legislative process to function the way it was meant to function. Thank you, Mr. President.
