Re: Report Concerning License Revocation and Child Support Enforcement

Dear President Lawrence:

It is the responsibility of the Department of Human Services, Division of Support Enforcement and Recovery (DSER) to report to the Legislature and the Governor regarding license revocation. The first report is due January 31, 1999 and biennially thereafter, in accordance with 19A MRSA §§ 2201 and 2202 (12).

For Professional and Recreational Licenses

Requirement No. 1

The number of support obligors identified as licensees subject to this section.

Answer:

We have identified 2,284 professional licenses involving 2,635 cases. We have been unable to identify recreational licenses on a statewide basis because they are not contained in a centralized data base. Therefore we have tracked them on an individual basis. The Department is working with Inland Fisheries and Wildlife to develop an on-line procedure to automate receipt of this information.

Requirement No. 2

The number of support obligors identified by the Department under this section who are not in compliance with a court order of support.

Answer:

At this time, 1,306 non-custodial parents are presently matched with our child support caseload and an additional 1,333 cases have been closed which did have a professional license in our caseload.

Requirement No. 3

The number of actions taken by the Department under this section and the results of those actions.

Answer:

The Department has taken 309 business and professional licenses. The Department has requested the revocation of only a limited number of recreational licenses. Under present sales procedures for recreational licenses, obligors would be able to purchase a new license almost immediately at any number of locations around the state. Again, we are researching this issue to find ways to make this section more effective.

For Drivers Licenses

Requirement No. 1

The number of notices served upon support obligors by the Department under this section.

Answer:

The Department has served in excess of 24,000 notices upon support obligors. We also had to re-serve obligors after the law changed in 1997 in order to provide due process to all individuals. There has been a steady increase in the number of notices served since the process began in 1993.

Requirement No. 2

The number of obligors served notice under this section who request a hearing.

Answer:

Our records indicate that 267 hearings have been requested as a result of our license revocation initiative.

Requirement No. 3

The number of obligors held under this section, the results of the hearings and the number of cases settled without a hearing.

Answer:

Our records indicate 165 hearings were held, and 102 were settled without the need for a hearing. To date, the Department has prevailed in every hearing.

Requirement No. 4

The number of support obligors certified to the Secretary of State for noncompliance with a court order of support under this section.

Answer:

1,827 obligors have been certified as of January 21, 1999.

Requirement No. 5

The costs incurred in the implementation and enforcement of this section and the Department's actions under this section.

Answer:

DSER estimates that direct costs of approximately \$212,000 have been incurred in order to implement the enforcement of drivers license revocation since its inception in 1994 through 1998. These costs include service of process of the initial revocation notice(s); printing costs; photocopying; postage; and staff time for one clerical person. DSER acknowledges that additional indirect costs have been incurred, such as operation of computers; administrative hearings; cashier staff to process increased payments; expenditures billed to DSER from BMV, Secretary of State; and computer programming time. We are unable to break out this particular initiative from the total normal operating procedures.

The original four target groups totaling 23,456 cases were identified in a singular, concerted effort to bring an existing, non-paying caseload into compliance by utilizing the threat of license revocation. Initially two warning letters were sent to non-custodial parents. Effort was then undertaken to serve each of the individuals who ignored the two warning letters with Notices of Intent to Revoke which actually began the revocation action against them.

The backlog of existing cases subject to license revocation in the target groups was diligently worked by professional staff for a considerable period of time, during which time new cases came into the DSER system needing license revocation enforcement action, and paying cases fell out of compliance and became subject to license revocation action. The new cases and cases formerly in compliance have been handled, and continue to be handled, on an exception basis as they are recognized by the DSER data warehouse which extracts information from the DSER New England Child Support Enforcement (Computer) System (NECSSES).

The Department has found tracking certain aspects of the license revocation program to be useful. We track total number of license actions, total number of agreements, and payments received from targeted individuals.

The information requested in this report was formulated at the Legislative Session in 1993 prior to the actual implementation of our process. Information contained in this report does not mirror how the law is applied today. The attached LIRV sheet better reflects the actual process and gives a more accurate portrayal of how we use this law and the results to date. This information was developed as a result of a study done by the Office of the Inspector General for a national report studying the effectiveness of several states' license revocation laws. We have attached this report for your information.

Enclosed is a copy of the Inspector General's Report comparing Maine's administrative process with the processes in court states and quasi-administrative states.

**THE PRESIDENT:** The Chair recognizes the Senator from Somerset, Senator Mills.

Senator **MILLS:** Ladies and gentlemen of the Senate, I urge you to vote against the pending motion which is Ought Not to Pass so that we might move on to pass the Bill as Amended by Committee Amendment "A". The Bill, as I recall it, Amends one or two words of our statute that deals with the authority given to the tribes to do high stakes Beano operations. Current law says that the tribes have the authority to open up and maintain a high stakes Beano facility either on the Reservation or on any land that might be designated as Tribal Territory. The Amendment to include all

Tribal Territories was one that was passed just recently, a few years ago. And it opened up the possibility, for instance, that the tribes might have authority to locate a high stakes Beano casino in Albany Township, for example, because they had purchased land there.

I think there is currently litigation over the issue of whether they had succeeded in designating that land properly as Indian Territory. But in any case, it opened up the possibility that the tribes would have authority under our law to set up a high stakes gambling operation, in the form of Beano, in areas of the state outside of the Reservations maintained by the tribes. It would seem to me that if one of our intentions is to insure that the tribes themselves have capacity for economic development within the regions where they live, and if that was the philosophy behind the original licensing of high stakes Beano operations for the tribes, than that public purpose is very adequately served by permitting the tribes to maintain these casino-like facilities on the Reservations as they presently have authority to do, and I understand there is one such facility. But to say that they should be permitted to purchase land in areas remote from where they live, in regions of the state that are unaccustomed to this kind of development. To pick a swatch of land and convert it to a gambling enterprise, it seems to me that lies way outside the original policy behind giving them permission to hold high stakes Beano operations in the first place. The purpose of the Bill before you is to Amend the law back to where it was and simply say that high stakes Beano operations are permitted on the tribal Reservations but not elsewhere. That's the full purpose of the Bill. That's the simple one or two word change to an existing statute. I thank you for hearing me out and I ask you to vote, please, against the pending motion which is Ought Not to Pass.

**THE PRESIDENT:** The Chair recognizes the Senator from Franklin, Senator Benoit.

Senator **BENOIT:** Thank you, Mr. President. May it please the Senate, to echo remarks made by the good Senator from Somerset, Senator Mills, what this Bill proposes to do, is to put the statute back to where it was before 1991. In 1991 the Indian Nation could conduct high stakes Beano games on the Reservation and that's the way the law read up until 1991. In 1991 that language was changed to read within the Indian Territory. We've seen what has happened since 1991 and that change in the law. The Indian tribe, that Nation, has gone outside the Reservation to locations far removed from the Reservation. A good example is Albany Township over in Oxford County that they have attempted to locate these high stakes games. So all this proposes to do is return the law to what it was prior to 1991. I want to share with you the concern of constituents in my district and some south of my district in Oxford County. Their concern, and you can understand their concern, is that Albany Township is an unorganized area with very limited services. Of course they don't have their own fire protection, or police protection, or emergency services. They have to rely upon those to be provided from adjacent municipalities. They're concerned about the Indian Nation coming to their area and setting up a high stakes game requiring them then to come up with some sort of police protection, fire protection, ambulance service, and so forth. They are very much concerned with the cost to their municipality that is occasioned by the Indian Nation going to Indian Territory off the Reservation and setting up these high stakes games. I would ask you to vote against the pending motion so we could go on to

Accept the Minority Report. And by the way, the Minority Report does carry the agenda of the Indian Nation as it is today; those games that do exist on the Reservation. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Waldo, Senator Longley.

Senator **LONGLEY:** Thank you Mr. President. Colleagues in this Chamber, I promote the Ought Not to Pass Report and that isn't to be interpreted as promotion for or against gambling. Simply this issue is being fought out in the Courts and whether this Bill said no gambling except in certain places or gambling in certain places, I think it's besides the point. It's not a Referendum on gambling, it's simply deferring to the Judicial Branch pending the conclusion of court matters there. So for that reason I and several members on the Committee voted Ought Not to Pass. Thank you.

At the request of Senator **MILLS** of Somerset a Division was had. 14 Senators having voted in the affirmative and 12 Senators having voted in the negative, the motion by Senator **LONGLEY** of Waldo to **ACCEPT** the Majority **OUGHT NOT TO PASS** Report, **PREVAILED**.
