Senator **WESTON:** Thank you, Madame President, ladies and gentlemen of the Senate. This bill represents a problem that I think the solution is one that could have a remedy itself. We were presented with TANF and Aspire recipients who claimed they were not being given proper information by their caseworkers and were not being given information that could lead them to better decision-making. The Department of Human Services response was to turn that responsibility over to volunteers and create another bureaucratic level, a support group. I think that a support group would probably be beneficial to both those giving and receiving, but I do not think that the legislature should be requiring it in statute. The time spent that this bill would require by the department, could be better spent asking the very caseworkers, whose job this is, to do a better job. These are people who are knowledgeable, have been trained, and who are being given a salary to help these recipients. What we heard was that this is not happening. The department's response is not to make sure that these people, who are being hired to do this job, do it well. Instead, they are putting a second layer between the TANF recipient and the caseworker. That is happening on an informal basis now. I think the best thing that could happen is for our caseworkers to be reaching out, knowledgeably, to each one of these recipients and helping them through this process. I ask you to not support this bill and allow the department to do the job they are required to do. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Brennan.

Senator **BRENNAN:** Thank you, Madame President, men and women of the Senate. While I appreciate the comments of the good Senator from Waldo, Senator Weston, I respectfully disagree. This is a very straightforward bill and was worked by the committee. It was brought forward by the sponsor, and we asked the sponsor to go and work with the Department of Human Services. The

Department of Human Services came back with an agreement. There was an amendment adopted by the committee.

What this bill simply does is establish, on a demonstration project, a peer support program for TANF recipients. The testimony that we heard was that sometimes people who are in the TANF program have difficulty working with their case manager, from the perspective of having a colleague type relationship. All this bill does is establish a demonstration project where other peers will be working with people in the TANF program to provide support for them and to provide information to them. It hardly creates a new bureaucracy. It hardly takes away the role of the case manager, at this particular point. It simply sets up a demonstration project to allow peers, who have been in the TANF program, to work with other people that are coming into the program to assure that they get the appropriate support and appropriate information. I wholly support the majority Ought to Pass report.

Senator **DAVIS** of Piscataquis requested a Division.

**THE PRESIDENT:** The Chair recognizes the Senator from Waldo, Senator Weston.

Senator **WESTON:** Thank you, Madame President, men and women of the Senate. I don't know what your definition of bureaucracy is, but this particular program will require a training program, a management team set up in 4 areas, and it will require regular meetings with management. This is a level of bureaucracy that is going to take time away from those very management people, the employees, and the caseworkers, who should be working individually with the recipients. I would rather that happen. That those recipients have one-on-one with a knowledgeable caseworker instead of having the caseworkers become managers of a program.

**THE PRESIDENT:** The Chair recognizes the Senator from Washington, Senator Shorey.

Senator **SHOREY**: Thank you, Madame President, men and women of the Senate. I rise today to oppose this bill and request we vote Ought Not to Pass on it. This bill has many problems on many different levels. As you can see by the majority report, the Ought Not to Pass, the committee also saw this. In the years past, this committee has looked to reduce the number of members on all the boards. What we did was said there is a cost involved here, we do not need to have more members on the board, and we decided we would make a conscience effort to reduce the number on the board.

What this would do is increase the number of this board. It would also make it so that the opportunity would arise for a deadlock. Right now there are currently 8 members on the board with one non-voting. This would make it so you could have an opportunity for a deadlock. Also what this does is adds a labor union member onto the board. I really don't understand why we need to do that. There is no reason. There is nothing wrong with the board right now the way it is. The Governor has the opportunity, if he wants, to specify a member of the labor union, a member of management, anybody that he wants to put on, he can put them on. What we have done is create a special niche here, for a reason that was not explained to the committee appropriately, obviously, because of the Ought Not to Pass by the committee. It creates a special niche. The Chief Executive is, basically, forced to put someone on there, even someone he may not want to put on. I would ask for a division and ask that you vote Ought Not to Pass. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Bromley.

Senator **BROMLEY**: Thank you, Madame President, men and women of the Senate. I appreciate the good Senator from Washington, Senator Shorey, comments on the bill. I have to say that the committee did have some concerns, initially, about adding members to the board. That was the reason for the Ought Not to Pass report. There was an amendment put on in the other body that substituted, took one person off and inserted a member of labor. The original bill is preferable, in our belief, to the amendment, which goes back to the original bill and adds the additional person from organized labor. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Washington, Senator Shorey.

Senator **SHOREY**: Thank you, Madame President. I would remind the body that the committee voted Ought Not to Pass on the original bill, not the amendment. Thank you.

Senator **BENNETT** of Oxford rose to a **POINT OF ORDER** as to whether the Bill was in compliance with Joint Rule 312, Fiscal Notes.

The Chair **RULED IN THE AFFIRMATIVE, THE BILL IS IN COMPLIANCE WITH JOINT RULE 312, FISCAL NOTES HAVING BEEN REPORTED OUT OF COMMITTEE AS AMENDED.**

Senator **SHOREY** of Washington moved to **INDEFINITELY POSTPONE** the Bill and accompanying papers, in **NON-CONCURRENCE**.

On further motion by same, supported by a Division of at least one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT**: The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT**: Thank you, Madame President and fellow members of the Senate. I raised the point of order earlier on this matter because I do believe that the Joint Rules are a little ambiguous about this and I certainly respect the President of the Senate in ruling the way that she did. Any one of us may have ruled that way as well. In my reading of Joint Rule 312, there are two conditions that require a fiscal note. The first is that the bill or resolve does, in fact, affect state revenues, appropriations, or allocations. The Office of Fiscal and Program Review have, in fact, showed that. Secondly, the other condition is that the bill has a committee recommendation, coming out of committee, other than ought not to pass or referral to another committee. In other words, I think these two conditions were, in fact, met. Although the committee amendment may not be before us at the present time, I think it's just a very bad precedent to set, whether or not the ruling was correct. I think it's a very bad precedent to set for us to engross bills without an acknowledgement of their fiscal impact. For that purpose, I would encourage you to vote to Indefinitely Postpone this bill.

**THE PRESIDENT:** The pending question before the Senate is the motion by the Senator from Washington, Senator Shorey to Indefinitely Postpone the Bill and accompanying papers, in non-concurrence. A Roll Call has been ordered. Is the Senate ready for the question?
