In Senate Chamber Wednesday December 5, 2012

Pursuant to the Provisions of the Constitution and the laws of the State of Maine, the Senators-elect of the One Hundred and Twenty-Sixth Legislature convened in the Senate Chamber and were called to order by Joseph G. Carleton, Jr., Secretary of the Senate of the One Hundred and Twenty-Fifth Legislature.

Prayer by Rabbi Carolyn Braun, Temple Beth El in Portland.

**RABBI BRAUN**: I have been given the task of an inspirational talk and I'm sure everyone this morning is inspired. This is so much fun I wish I could stand here forever. Your inspiration will be needed later on, once the work begins, so think of this as a continuing prayer.

Among the Jewish books of wisdom is a very well known first century work called Pirke Avot, Teachings of the Sages. Early on in the first chapter there is a piece of wisdom. Shemayah taught, "Love labor, hate the abuse of power, and don't make vourself known to the government." Obviously, advice intended for members of the working class. One modern commentator understands this teaching as good advice about how to live in an imperfect world. Love work. The Hebrew here actually refers to physical labor, but I understand this to say that each one of us an important job to do. We must not only love what we do, but we must also recognize and preserve the dignity involved in labor; whether it be manual, mental, or spiritual. In contrast to the worker who often holds the least power and control over his or her situation, the Sages taught that we should distain those who have, yet abuse, power. We are all equal, or at least we should be, and so one must not laud their power over another. One commentator understands this line as praising humility, even when one is in power.

The most interesting line, and the one that stands out to me today in these Chambers, is the last line of Shemayah's teaching, "Don't make yourself known to the government." At least in 1<sup>st</sup> Century Jerusalem, and no doubt in other places and times throughout history and for some even today, it was not prudent to come into contact with the authorities if you were in the minority or if you did not agree with the ruling power. In fact, another teaching in this same work says, "Be wary of the government, for they get friendly with a person only for their own convenience. They look like friends when it is to their benefit, but they do not stand by a person when he is in need."

Thank God we have progressed from those days. Today we gather in these Chambers to open the 126<sup>th</sup> Maine State Legislature, to swear in new members, to celebrate a new legislative year, and to get down to work. Unlike governments in other countries and in other times, we, your citizens, hope never to have to shy away from those of you in power because your power comes from us. We are placing our trust in you with the expectation that you will legislate for the benefit of all people in Maine. We trust that you will stand by a person in need and we

want you to know that just as we rely on you to legislate fairly and wisely, you can rely on us to support you to the best of own abilities. For the government is not an entity separate from the governed. We are all part of government and we all share the responsibility to govern wisely.

Indeed, this is an exciting day for each one us and as you begin your very holy work in these Chambers a final lesson from Pirke Avot. "Who is wise? One who learns from all people. Who is strong? One who overcomes his or her own desires. Who is rich? One who is happy with what he or she has. Who is honored? One who honors all people." May you be blessed with the wisdom to listen and to hear your constituents. May you be blessed with the strength to see the needs of others and consider them fairly. May you be blessed with the richness of the feeling of one who is fulfilled and has worked to make this world a little better for all of us. May you be blessed with the honor which is accorded to one who truly honors all others. May you complete this session feeling that you have had a part in making an imperfect world a little more perfect. May you go from strength to strength. Mazel Tov.

#### **ELECTION OF SENATE OFFICERS**

Senator **GOODALL** of Sagadahoc **NOMINATED** Senator **ALFOND** of Cumberland for the Office of President of the Senate of the 126<sup>th</sup> Legislature.

**THE SECRETARY**: The Chair recognizes the Senator from Sagadahoc, Senator Goodall.

Senator GOODALL: Thank you, Mr. Secretary. Men and women of this Body, family and friends, nearly four years ago today Senator-elect Justin Alfond and I walked into this Chamber together. We became seatmates. We became friends. We have since then, I believe, became family. The position of Senate President is one of great importance, great trust, and great responsibility. The position places a burden on your shoulders. requires you to bring people together to get things done and move Maine forward, and help focus all of us on our State's great challenges. It demands leadership focused on results. It is a position clearly laid out in the Constitution to run this august Body while also knowing that you must be prepared to run the entire State. It is wonderful to see so many family and friends here today, family and friends that can witness and share in this day when our soon-to-be leader begins to lead us and focus us on our points of common ground and common purpose, areas of agreement that can help strengthen our economy and help people take advantage of opportunities to improve their lives, to improve our lives, and improve our great state. We, all 35 of us, must understand each other, must better understand and respect each other's perspective, and we must understand each other's background and experience. With better understanding comes greater respect and, yes, progress. I know, and I believe we all know, Justin is fully up to this task to lead us and make sure that we move forward. **THE SECRETARY**: The Chair recognizes the Senator from Cumberland, Senator Haskell.

Senator HASKELL: Thank you, Mr. Secretary. Men and women of the Senate and assembled guests, as most of you know, I have had a variety of different jobs. I've worked in a lot of different places and different positions. You can't do that without coming across a whole variety of leaders; some great leaders, some good leaders, and some not so good leaders. I've had a chance to get to know Senator Justin Alfond from the time that he took on the League of Young Voters in Portland way back when I was first running for the House, the other Body. I watched him work tirelessly in order to get results and improvement in voter participation. That was hard work. That was grueling work. I watched how he led in that position. As a close colleague here, he's demonstrated the work ethic and his competency over and over again. I believe he has the characteristics of a great leader and he's demonstrated them during his time here. I want to talk about a few of those characteristics. Integrity, first and foremost integrity is the outward action of the inner value. A person of integrity is the same on the outside as they are on the inside. When they are out in the Chamber and when they are behind closed doors, that person is the same and never veers from those inner values, even when it might be expeditious to do so. Dedication, dedication is spending whatever the time and energy is that is necessary in order to get the job done and by setting an excellent example. Senator Alfond has shown that there are no 9 to 5 jobs around here, only the opportunity to do something worthwhile. Humility, humility is knowing that you are no better or worse than anybody else and being willing to step up, speak up, to spread the credit, and to take the blame when it might be appropriate. Creativity, the ability to think differently, to listen to other ideas, even those from the outside, and to begin to close the barriers of those proverbial boxes that constrain solutions. Senator Alfond knows how to do that. Demeanor, demeanor is defined by the way others see you. As the President of the Senate, I want my leader to be respected for his professionalism and I am perfectly at ease when I know that Senator Alfond is out

in front and representing this Body. A sense of humor is vital. It's pretty easy to get wound up around here. I know many of you might not believe that, but it is. The ability to seek out humor in our day to day travels is a trait that you can't manufacture and yet it can make a big difference in how things flow. Senator Alfond has that quality and all of these qualities. These are the hallmarks of effective leaders and my friend, Senator Justin Alfond, optimizes these characteristics. Senator **THOMAS** of Somerset **NOMINATED** Senator **MASON** of Androscoggin for the Office of President of the Senate of the 126<sup>th</sup> Legislature.

**THE SECRETARY**: The Chair recognizes the Senator from Somerset, Senator Thomas.

Session. At that time we sat at the same table for lunch and we talked about professional hockey in the state of Maine. It was a very pleasant talk, but I have to confess that I really didn't think about Senator Mason again until I heard that he was running against an incumbent Senator from Androscoggin County. I probably shouldn't say it, but my thought at that time was, "This young guy with no political experience doesn't stand a chance against the experienced incumbent." Well, I was wrong. Senator Mason did win and I thought, "That's great for him." As the new Legislature, the 125<sup>th</sup> Legislature, was organizing, House Leadership asked me if I would be willing to serve as Chair of the Criminal Justice and Public Safety Committee. I gladly accepted this challenge. A short time later I was asked how I would feel about having a freshman Senator serve as the Senate Chair of that committee. **THE PRESIDENT**: Two years from today, should we be privileged to meet here again, my hope is that we will meet here as friends. My hope is that we will be thanking each other for sharing ideas, for working together, and for putting Maine first. With that future in mind, I am honored and privileged to serve as the 115<sup>th</sup> President of the State of Maine. With so many people to thank, deserving friends and colleagues, I'd like to begin with my family. My mom, Joan; my dad, Bill; my wife, Rachael; my loud son, Jacoby, who has left the Chamber; my in-laws, Deanna and Jack and Ben; and to all of the families and friends able to join us today, your love and support sustain us, and your patience and sacrifice are constant inspirations.

To my good friend, the Senator from Sagadahoc, Senator Goodall, I am honored by your kind remarks and continued support. As Senator Goodall said, we have entered this Body together, we were seatmates, and we learned about this Body

together. Now I am very honored to be working with Senator Goodall to lead this Body together. Thank you. To my dear friend, the good Senator from Cumberland, Senator Haskell, I also thank you for your kind words, your support and guidance. I know we both share a deep and abiding love of the state of Maine. To the Senator from Aroostook, Senator Jackson, "Action Jackson" is what we call him in the caucus. Your experience in the Legislature, coupled with your career in forestry, bring invaluable perspective to the Senate Leadership Team. To the good Senator from Waldo, Senator Thibodeau, I know firsthand what it's like serving in the Minority. There are many challenges, but also many opportunities. I look forward to serving with you. To the good Senator from Kennebec, Senator Katz, the Mayor of Augusta. Imagine, in this Body we have the past Mayor of Augusta. Your two years on Appropriations will guide our Leadership Team and I look forward to working with you. I'm honored that Governor LePage was here also this morning. Governor, we stand ready to work with you. Mainers need us to get back to work. I also wish to extend a warm welcome to all of our Senators, both new and returning members. All of Maine is represented in this Chamber. We have a carpenter, a doctor, a realtor, a fire fighter, a logger, and a mill worker. We have lawyers, business owners, and more. Together we embody the best of the state of Maine.

Finally, I would be remiss if I did not acknowledge my predecessor, the Honorable Kevin Raye. It wasn't always easy serving in the Minority, but under Kevin's leadership he always made it equitable. He gave every point of view a fair chance to be heard. Senator Raye understands that a leader does more than stand by his party. A leader brings factions together and helps broker the compromise that makes lawmaking possible. For your accommodating perspective, Kevin, my sincere gratitude. There is a footnote to this thank you, by the way, that goes back a generation to a second grade classroom at Eastport Primary School. My mother, Joanie, was a student in that class and Kevin's mother, Frances, was her teacher. Frances loved teaching second grade, she told me, because that is when children learn to take off their own coats and boots. By now. we've also learned to roll up our sleeves. A community, somebody once said, is people who know the same stories. Just as Kevin and I share an unexpected link through our mothers, everyone here shares a reservoir of stories and memories that connect us to Maine. The Flood of '87; the Ice Storm of '98; Seth Wescott and Joanie Benoit winning gold; ten-year old Samantha Smith, our ambassador of peace and goodwill to the Soviet Union; and the leaves turning red in October of '04 with the Red Sox, at long last, winning it all. Above and beyond personalities and politics, it's our love of this state that unites us and calls us to service.

Some say Maine is a divided state and there are those who want to divide us; divide us by age, by gender, and divide us by geography or by how we make our living. Of course, there will always be those who define and divide us by what we believe and to what we belong. The polarizing voices, all too often the loudest in the room, that try to tell us whom to fear and whom to blame. Even as we meet here today, there are those on both sides spoiling for a fight and expecting the worst: a showdown in Augusta between the Blaine House and the Legislature. Do you know what I say? Let's disappoint them. Let's show the people of Maine what can happen when we seek common ground as we did when Governor LePage and then-Representative Cain stood by women in the fight against domestic violence. Let's show the

people of Maine what can happen when we listen to both sides of an argument and care about all sides of an issue as we did last session when we adopted the Standards Based Education throughout Maine. Let's show the people of Maine what can happen when we work together, as with the many examples in this turbulent economy of workers and management coming together to keep the lights on and keep people working. Keeping the jobs we have and creating the jobs we need, no issue is more urgent than our economic security and nowhere are Mainers relying on us more to work together.

Our first order of business is rebuilding Maine's middle class by getting people back to work at good paying jobs with promising futures, more than a life lived from paycheck to paycheck. We have a mandate. Let's begin by developing a blueprint for job growth region by region. We need to connect the dots between industry, education, and the future of small business in downtown Maine. We need to analyze current jobs to identify future jobs and teach the skills required to fill those jobs. Why should any Maine business ever have to look elsewhere for qualified workers? Why should any Mainer ever have to leave the state they love to find the job they want? By closing the education gap in our workforce we put Maine business in a position to succeed and by adding strength to strength we put Maine government in a position to use all of our economic tools; research and development, bonding initiatives, and partnerships with the private sector to optimize job growth in the 21st Century. You see, economic security is not a partisan issue. We all pay bills, buy groceries, and seek shelter in a storm. As elected representatives we share something else in common. In a state that's like one big small town, we've all met with thousands of our constituents at their homes, in line at the market, or here at the State House. What do they tell us? They tell us they are tired of the gridlock, fed up with party politics. They tell us to reassess our priorities and to start by putting their interests first. Education, healthcare, energy, and the economy; the issues haven't changed in 200 years. What changes is us, this 126th Maine State Senate and how we choose to interact. We won't always agree, but why let our differences divide us. An honest debate is a crux of Democracy. It can only make us stronger. Labels, as Ed Muskie liked to say, are for jar jams. What matters is substance.

As we take off our coats and roll up our sleeves, imagine looking back at this moment two years from now. What did we, as a group, accomplish and whom did we serve? To the voices telling us we are destine to clash I offer these words in reply, to quote John F. Kennedy, "Let geography make us neighbors, let history make us friends, let economics make us partners, let necessity make us allies." Coming together today is a start. It's an invitation to listen, to collaborate, to ask the selfless questions, and it is a mandate to answer the call to public service by putting Maine and her people first. With that future in mind, let's get to work together. Thank you very much.

Senator **GOODALL** of Sagadahoc was granted unanimous consent to address the Senate on the Record.

Senator **GOODALL**: Thank you Mr. President. Men and women of the Senate, this is a great day. This is a day of family and friends. The start of our journey. The start of our job to serve the people of Maine for the next two years. I rise today to speak for my Democratic colleagues on this side of the aisle, and I hope it

is with common vision and common purpose for all 35 of us, that we can share, we can understand the differences, and we can get things done. I have great confidence that we, along with my Republican counterpart, the good Senator Thibodeau and his assistant, the good Senator Katz, along with Senator Jackson, and Senate President Alfond, can get many accomplishments done to help move the state forward in collaboration with the other Body and the Executive Branch. He is so in love with Maine that when he was faced with the choice of where to go when he had his degree that he decided to come right back to Augusta, stay in Maine, and do whatever he could to get on a career track here. With each job that he rose to people who he worked for saw that he was a rising star. I thought I would walk around and ask some of them, those who worked for as well as those who worked with him, if they would just say a word about what comes to mind when I say Darek Grant. Here's what I was told: very smart, with emphasis on very; fair; capable; hard working; he has vision; and he loves the legislative process. I echo the same to all of those attributes because I have to share with you that I, too, had the privilege, and I consider it a privilege, of having had Darek as my Legislative Aide. He made me look good most of the time, which is a lot of hard work on his part. He was an absolute pleasure to work with. What I have to add to the list of attributes, which was important to me, was that he has a great sense of humor. Through the worst of times he and I could laugh and live and survive another day.
