As you know, the Senate Secretary and the House Clerk have conducted polls to see if membership is in favor of returning for a Special Session. The results of the poll were as follows:

- Republican Party – 83 votes in favor (45 necessary)
- Democratic Party – 90 votes in favor (46 necessary)
- Green Independent Party – 2 votes in favor (2 necessary)

Pursuant to Article IV, Part Third, Section 1 of the Maine Constitution, a Special Session is in order. **Therefore, the House and Senate will convene at 10:00 a.m. on Tuesday, June 19<sup>th</sup>.** We expect this session could last multiple days, but we will work to complete our business as quickly as possible. Members should also be aware of the possibility that the Legislature may need to convene at a later date should it be determined that it is necessary to act on any bills vetoed by the Governor.

TO COMMEMORATE THE LIFE OF BARBARA BUSH,  
FORMER FIRST LADY OF THE UNITED STATES AND  
MOTHER OF THE 43RD PRESIDENT OF THE UNITED  
STATES**

**WHEREAS**, the Maine State Legislature has learned of the death of Barbara Bush, former First Lady of the United States and mother of the 43rd President of the United States, and a longtime summer resident of Kennebunkport; and **WHEREAS**, in 1945 the former Barbara Pierce, a native of New York State, married the Honorable George H. W. Bush, a young naval aviator who went on to a successful political career culminating in 1988 with his election as the 41st President of the United States, and they were married 73 years; and **WHEREAS**, she became a popular First Lady, appreciated for her unpretentiousness and self-deprecation, and was a tireless advocate of adult literacy programs; and **WHEREAS**, in Maine, she gave her time and resources to local causes and institutions, including the Maine Literacy Volunteers, The Barbara Bush Children's Hospital at Maine Medical Center and the University of New England, home to the George and Barbara Bush Center; and **WHEREAS**, she and her husband had six children, two of whom also became successful politicians: the Honorable John Ellis "Jeb" Bush, Sr., who became Governor of Florida, and the Honorable George W. Bush, who became Governor of Texas and later the 43rd President of the United States; and **WHEREAS**, the Members of the Senate and the Members of the House of Representatives wish to express the high esteem in which they hold the late Barbara Bush and the sadness with which they received the news of her passing; now, therefore, be it **RESOLVED**: That We, the Members of the One Hundred and Twenty-eighth Legislature now assembled in the Second Regular Session, pause in our deliberations to commemorate the life of Barbara Bush and to recognize her contributions to the Nation and the State of Maine; and be it further **RESOLVED**: That suitable copies of this resolution, duly authenticated by the Secretary of State, be presented to the family of Barbara Bush as a token of our sympathy.

We truly do mourn the loss of a wonderful lady, somebody that served as First Lady, somebody that I looked up to as a young person, my children looked up to as young people, and I think everybody in this room came to respect and to recognize the tremendous dignity, the honor, the just absolute kindness that poured out of Barbara Bush and her husband, George, as well. So we just take a few moments to kind of reflect on what she meant to this nation, what the passing of this lady means, and we all feel a loss. Whether you are Republican or a Democrat, when we lose one of our First Lady's it is a sad moment. So today the State of Maine and the State Senate takes just a few seconds to remember the life of a very special lady, Barbara Bush. Thank you.

Some of the other pieces that I think are really important: a new State family medical leave credit that's equal to the federal credit, that is extremely important in expanding relief to those young families, in particular, that we're trying to attract here in Maine to live, work, and play; and also the establishment of the child dependent credit. Aside from that, we also wanted to make sure that small businesses have the opportunities and tools to thrive in our state and we think this overall package helps to get us there.
