Senator BREEN: Thank you, Mr. President. Mr. President, men and women of the Senate, it's really my pleasure and honor to present this Joint Resolution recognizing February 6<sup>th</sup> as National Girls and Women in Sports Day, and you'll see in a few minutes we have some very distinguished guests here to help us celebrate that today. I was so pleased to put in this Joint Resolution, to be asked, because, as a high school and college athlete myself, I have benefited enormously from sports programs throughout my whole life. Some of the things that playing sports, for me, prepared me and helped me do - helped me learn was preparation, self-discipline, sacrifice - certainly in college where I had to balance my sports obligations with my employment obligations and my academic obligations - teamwork, starting at the bottom of the heap and earning a place on the starting lineup, how to win and how to lose with grace and dignity, and, just as importantly, how to show up. I know that there are a lot of athletes today who have very, very involved parents who make sure that they get to every game and every practice. I have great admiration for those parents. Those were not my parents. I have terrific parents, but I was one of six kids and if you wanted to do something you got yourself there and that's the way I grew up. It's not because my mother played any sports. My mother does not have an athletic bone in her body. It's because I learned all of this for one very, very simple reason; Title 9. Title 9 was landmark federal legislation that passed in 1972 when I was 7 years old. That law turned the tide, making sure that any educational institution that offered federal funding for boys to participate in sports also made that sure that girls had the very same opportunity. So when that law was passed when I was 7 vears old I had the enormous benefit of having teachers. community members, all sorts of folks step forward and start coaching girls in ways they hadn't ever been coached before. Along with the law came funding and that's what we continue to have today. It was the community, it was government, it was legislation that made this opportunity available to me and so many of my peers and the folks that are here today. I love terrific parents but it's what government does that makes things available to everyone in the community, not just parents. So with that, I thank you, Mr. President, and I believe you're going to read the names of our guests today. Thank you.
