Senator CRAVEN: Thank you Mr. President. Men and women of the Senate, the state of Maine is divided into three sections serving youth who are homeless. One is situated in Bangor, one in Portland, and there were two shelters in the second district which one is still located in Lewiston and one located in Skowhegan. The Skowhegan shelter closed last year and now the only 24 hour shelter that exists in the state of Maine for homeless youth is in Lewiston. Portland and Bangor sent people to testify in favor of this bill because their shelters are not 24 hour shelters. Corrections, as well as the Department of Health and Human Services, use this shelter because it is the safest place for homeless youth to stay. They can stay up to 30 days, go to school, engage in therapy to see if they can be reconciled with their families, and, if they cannot, some of them are set up in group homes so that they can be safe and go to school. This bill would have required the department to continue funding the second district as usual, even though the house had closed. We are still serving all of the homeless youth in the second district, and some from beyond, at New Beginnings in Lewiston. I didn't want, and we had asked, the Majority had asked, for this money not to be repurposed but to be continued to be shared equally with the other two districts. That is what this bill would do. I was, I guess, surprised that it came out as being controversial, but I would ask for your vote and your support in keeping the dollars being delivered equally to all three districts. Thank you very much, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Oxford, Senator Hamper.

Senator **HAMPER**: Thank you Mr. President. Ladies and gentlemen of the Senate, I don't rise in opposition to homelessness or to homeless shelters and that sort. What I rise and I speak against is the statutory restriction on the Department of Health and Human Services as to how they allocate their

funds. It is as simple as that. We will be putting a restriction on the department with this bill. If there is a need in one area, and there are extra funds in another area, the department wants the ability to be able shift funds where the needs are. This will lock the funding into previous levels. It's a statutory provision that could also put a region at risk and not having adequate funding if the need arises. Please allow the department flexibility and vote no on this. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Hancock, Senator Langley.

Senator **LANGLEY**: Thank you Mr. President. Women and men of the Senate, I rise in support of L.D. 1736, which is a Resolve to Provide Maine Students with Access to Online and Digital Learning Opportunities Through Their Existing School Districts. Men and women of the Senate, we are woefully behind in our efforts to increase digital learning opportunities in our great state. In an Executive Order dated February 1, 2012, the Chief Executive penned an order to expand opportunities for digital learning in Maine. The Executive Order directed the Maine Department of Education to develop a strategic plan to expand digital learning opportunities for Maine students. It went on to say that the department should meet with students, parents, teachers,

school administrators, experts in educational information technology, and other persons interested in digital learning and review those existing policies in other states and develop a plan for Maine, including the statutory changes needed to make it happen. The order went on to say that no later than January 4, 2013 the department shall present the digital learning strategic plan to the Governor and Joint Standing Committee having jurisdiction over education and cultural affairs. It's now March 2014 and a digital learning strategic plan has not been submitted to the Education Committee. The DOE website indicates that the DOE staff is still in the drafting phase and have just filled the vacant positions in the technology department.

Late in the fall I was approached by Maine School Management Association to see if I would support a moratorium on virtual charter schools. I declined at that time because I saw a straight moratorium as a way to stop virtual charter schools and future legislation. However, I told Maine School Management that I would support a moratorium if Maine School Management and Maine Education Association were to work together to bring digital learning to all of our schools in Maine, sooner rather than later. They took me up on my office and have been working together since. I realize the incentive to come together in this fashion was initially driven by fear of virtual charters, nonetheless, there is now much more motivation to expand digital learning in Maine than ever before. There is enthusiasm amongst school districts to find a better way to deliver on-line education to all school districts at a competitive price. Declining enrollments, reductions of programing, tight budgets, lack of advance course work, and scheduling conflicts are motivating factors for digital learning. I am a supporter of charter schools, innovative school districts, early college, and reforms that will enable our students to achieve new heights in their pursuits of education. However, I feel an obligation to our tax payers to do so in the most cost effective way possible. Concerns that under Maine Charter School Law a virtual charter would receive the state average tuition per student, that starts at a base of around \$6,700 and goes up from there, has raised the question; is this the best deal for Maine tax pavers?

Further investigation lead me to learn that Maine would be considered the gold standard for full-time virtual education. I support charter schools but I also support good value for the dollar. My bill would suspend Monday's decision of the Charter Commission regarding current virtual applications until July 31, 2014 if there is not an effort made to create a memorandum of understanding with New Hampshire's Virtual Learning Academy to bring more digital learning opportunities to Maine. If this benchmark is met the moratorium is then extended to January 2015 to give time for a stakeholder group to develop on-line and digital learning opportunities in Maine. I envision more digital learning opportunities for traditional public schools, public charter schools, private schools, town academies, and homeschool children would be available using a statewide digital platform. I've spoken with the Director of New Hampshire's VLA last week and they are ready to work with Maine, as they are already an approved provider in Maine. A memorandum of understanding could be executed in short order. It makes tremendous fiscal sense to partner initially with our neighbor to the west and take full advantage of their experience, knowledge, and capital investment. That's why there is no fiscal note on this legislation. Our partnership would exist in the short run until we can go out on our own. It's time to fulfill the intent of the Executive Order of 2012.

In conclusion, I believe in virtual education. My masters degree work is in on-line education and I believe we can provide virtual education to all of our students in Maine at a very competitive cost. Thank you for listening.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator MILLETT: Thank you Mr. President. Men and women of the Senate, I rise today in support of L.D. 1736 as amended. There is a growing understanding and appreciation for the potential role virtual learning can play in education, especially in a rural state like Maine where some schools may lack the requisite resources to provide the breadth and depth of course offerings of other schools. This is the foundation from which the Education Committee built bi-partisan support for this bill and upon which I hope you will join us. On the local, state, and national level businesses, law enforcement, political, and military leaders agree that it is critical to move aggressively to improve the educational attainment of our youth. As such, it is clear that we need to make every effort to insure Maine's children, no matter where they live and no matter their economic circumstances, have equal opportunity to grow, explore, and develop skills necessary for success as adults. This bill is designed to do just that. As mentioned earlier, it builds off a concept outlined in the Governor's 2012 Executive Order, An Order to Expand Opportunities for Digital Learning, and strengthens access to online classes, utilizing clear benchmarks and an abbreviated timeline in order to make sure our goals are achieved. It wisely leverages the New Hampshire Virtual Learning Academy strengths and learned lessons while building upon Maine's budding network. The goal is simple; give every Maine student an option to receive instructions in a course, or a series of courses, that they would not otherwise be able to access. Endorsing this bill means that we have the opportunity to help over 180,000 Maine students as compared to the 750 potential virtual charter school students. The contrast of the economics involved is stark. The good Senator from Hancock County, Senator Langley, has worked hard to craft legislation, including a moratorium on virtual charter schools, that will bring all parties together to move Maine forward. Maine superintendents, principals, and teachers enthusiastically support a Maine-run statewide virtual exchange, yet the Department of Education continues to throw out argument after argument as to why it is impossible for anyone to create a statewide virtual exchange despite evidence to the contrary in New Hampshire and Ohio. The short lived moratorium will get the department to finally move forward on making Maine's digital learning resources more robust, with the full cooperation of our educators. This bill offers important next steps for expanding and strengthening on-line learning opportunities in Maine in a way that is efficient and effective. Please join me in supporting L.D. 1736 so that our children have every opportunity to fulfill their potential. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Penobscot, Senator Cushing.

Senator **CUSHING**: Thank you Mr. President. Ladies and gentlemen of the Senate, I rise today in regards to the pending issue. If you would grant me a couple of moments to digress, I've stood with the good Senator from Hancock at several events

related to education, the skills championships and the Bridge Year Program, and watched the pride he has in the success of those students. I think many people involved in this discussion on L.D 1736 have the interest of the students at heart and I commend that. It makes it all the more difficult for me not to be able to support the good work that the Senator has done on this bill because I know the passion that he has and the determination he applies to these situations to try and bring compromise and what's best for the students out of it. However, L.D. 1736 is not the course that I believe will get us there. I feel that in this effort we have lost track of the fact that the opponents of charter schools have used a number of tools to delay and prevent the evolution that is necessary for students in Maine to adapt to a digital global economy. There are already successful models out there, but we cannot continue to delay the process for Maine students. L.D. 1736, as drafted, creates the state virtual charter school as a false promise because it puts a moratorium in place, awaiting for actions that really have no direct bearing on the quality of education that we wish to provide our students. The bill puts power in the hands of those who are working to ban efforts at virtual education from the private sector. Additionally, what to me is disappointing, this takes away the choice from parents and students and puts it in the hands of administrators, some of whom are passionate about digital education and some of whom see it as a threat to already tight funding considerations for their budgets. While I respect greatly the concerns that they have and I respect greatly the efforts of many in the education community to try and craft this. I think it's time to move forward and that's why I would ask all of you to follow my light in opposing L.D. 1736. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Androscoggin. Senator Mason.

Senator MASON: Thank you Mr. President. Men and women of the Senate, it is not secret around here that I am a passionate supporter of school choice for all Maine students, no matter what their zip code or their economic standing. I applaud the Chair and the Republican Lead of the Education Committee for crafting a bill that attempts to move virtual education forward. I've always been a strong and ardent supporter of virtual education and I appreciate their efforts on trying to make the department move along on an initiative that was outlined in the Chief Executive's Executive Order from two years ago. However, I don't believe that this is the right course of action for public education in Maine. Let's be very clear on what this bill does. It sets up a virtual cooperative that provides a hub of digital education for students across the state. This is in addition to a brick and mortar public school. Extended course offerings, advance course offerings. That is a wonderful thing. The bill would allow us to work with New Hampshire or Ohio to take what they have already nearly perfected and use that for our students here in Maine. What New Hampshire and Ohio do is use course offerings from K-12 Connections Academy to offer to their students. I think that's great. Superintendents would be able to offer unique classes to all of their kids through one of these digital exchanges. The other part of this bill is a moratorium on virtual charter schools. The same two schools that provide course offerings for the proposed cooperative would then be banned from opening their own charter school. I think that that's the wrong course of action. I believe that by passing this moratorium we are halting the forward progress of public education in our state.

There is another option. We can do both. We can have both the digital cooperative to enhance our course offerings to our tradition public schools and we can have a virtual charter school that provides more options for students and families. I think that by putting this moratorium in place, and passing this Resolve, we are not doing all we can do to support the entirety of public education, whether that be traditional or charter. I would urge you all to oppose the pending motion and follow my light on this issue. Thank you, Mr. President.

Senator BOYLE: Thank you Mr. President. Men and women of the Senate, I rise in support of L.D. 1736. For me, education is the great equalizer of opportunity in the state for our children. This measure will ensure more students have an opportunity to learn from a curriculum or a class not offered in their schools. When done right, virtual learning can be an important new tool for Maine. This is a rural state and it can be a challenge to connect students with the resources they need. On-line learning can help us overcome that challenge. I've made the point before, I think everybody knows, I'm a small business owner. I'm in support of businesses. I'm all for a private business making a profit. Schools are for learning. They are not profit centers. Education isn't about the bottom line. It's about preparing our children for the future. Again, I support on-line learning, but we need to make every effort to ensure Maine's children, no matter where they live and no matter their economic circumstances, have equal opportunity to grow, explore, and develop skills necessary for success as adults, which is what this bill would do. Supporting this effort will help more than 180,000 Maine students access courses they would not otherwise be able to take. I support online learning and I hope you will support this bill. Thank you.

Senator **CLEVELAND**: Thank you Mr. President. I wanted to keep the Chamber up to date on some important energy matters from time to time. I briefly just wanted to bring to your attention, it didn't get much publicity, a recent Judicial Supreme Court ruling, actually on March 4<sup>th</sup> of this week, in regards to a decision by the Public Utilities Commission that was contested by the Houlton Water Company, the Public Advocate, and the Industrial Energy Consumer Group. I bring it to your attention because it was a

critical piece of the restructuring of the electric utility industry, which was my bill when I was here at a previous time that restructured the industry and it also played a lead role in the bill. The central question was this; when we restructured the industry what we said was that there would be a T and D, transmission and distribution, portion of the electric utility industry and then everything else on the generation side would be separated from the transmission and distribution side, for the purposes of making sure that we had competition in the generation of energy and that there would be in no way any favoritism or any influence by the transmission and distribution companies in regards to who the generators were and who provided the energy. There was some question, apparently, about that in the PUC decision. Recently Emera, which is the merged company of Bangor Hydro and Maine Public Service, joined in a partnership with First Wind to proceed ahead as an affiliate. The court said, unequivocally, that that violated that law and that that was part of bringing back generation into the T and D and therefore violated the intent of the law. I couldn't concur more with the Chief Justice and the other Justices of the Supreme Court. That is exactly what we intended when we passed the bill. I think it served the state well and will continue to do so. I wanted to bring that your attention because it was a critical decision just this week.
