**JOINT RESOLUTION  
HONORING FRANCO-AMERICAN DAY**

WHEREAS, the State of Maine is named after the Province of Maine in France, and the towns of Paris and Calais owe their names to the capital city of France and the French port city of Calais, respectively; and

WHEREAS, more than 1/3 of the population of Maine is of French and Canadian descent and Franco-Americans in Maine have contributed much to the beauty and quality of this State; and

WHEREAS, French is the primary language of thousands of Maine citizens and there has been a resurgence in the use of the French language and a heightened appreciation of the Franco-American heritage throughout the State; and

WHEREAS, clubs and organizations to promote French culture and language have sprung up throughout the State, including the Francophone Caucus at the Capitol; and

WHEREAS, fluent French-English bilingual people are a cultural and economic resource to the State; and

WHEREAS, cultural tourism can be greatly enhanced by the genuine Franco-American centers throughout the State, and the large Franco-American presence in Maine can further strengthen our relationships with Canada, France and the rest of the francophone world; and

WHEREAS, the first Franco-American Day was celebrated on Wednesday, March 6, 2002 at the State Capitol; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-seventh Legislature now assembled in the First Regular Session, on behalf of the people we represent, proclaim that Wednesday, March 18, 2015 is Franco-American Day, to be celebrated at the State Capitol; and be it further

RESOLVED: That Franco-American Day be celebrated to commemorate the rich history of the French people in the State of Maine and the United States of America.

**THE PRESIDENT PRO TEMPORE:** The Chair recognizes the Senator from Waldo, Senator Thibodeau.

Senator **THIBODEAU:** Good morning, Mr. President. Ladies and gentlemen of the Senate, bonjour. You know it was just yesterday that everybody in the Chamber was Irish. Indeed, we all get the opportunity to enjoy our Irish heritage. Well in just a 24 hour period we've transformed from O'Thibodeau to simply just Thibodeau. You know, there is no culture that has affected the State of Maine more than the French culture. I think we're all, all of us that are French, particularly proud of our heritage. You

know, the State of Maine got its name, indeed, from a Provence in France. That's how our state was named. The roots of the Franco-American relationship runs deep in our state. I think that each and every one of us are proud of our root. We recognize the tremendous impact that it's had on us, not just socially but financially. When we look at some of our cities around our state and we think about Lewiston and Biddeford and Waterville and we recognize the tremendous contribution that the French folks made in our state. They've made our great State of Maine what it is today in so many ways. I'm particularly proud of my Franco heritage. Yesterday I was proud of my Irish heritage, but this morning I'm particularly proud of my Franco heritage. You know, you don't have to go very far up and down the halls before you recognize that there are tremendous amounts of folks that, indeed, have that French heritage. You don't have to go very far before you meet the Senator Dutremble or Senator Willette or even Governor LePage or Senator Thibodeau. The Franco people are well represented here in this building and, indeed, a tremendous asset to the State of Maine. With that, I want to say *bonne jour nee de la Franco phonie*. I think that means "Happy Franco Day."

Expressions of Legislative Sentiment recognizing:

Joe Cyr, of Brewer, on his induction into the Franco-American Hall of Fame. Mr. Cyr is President and Chief Executive Officer of John T. Cyr & Sons, a bus company based in Old Town. He took the business his grandfather started and expanded it, adding many school districts to the bus service and creating Cyr Northstar Tours, a charter bus service. Mr. Cyr is also committed to the community. He has served as a director of the Maine Community Foundation and has been a board member of the Old Town/Orono YMCA, serving for 5 years as president of the board. We acknowledge Mr. Cyr's service to his community and to the State, and we send him our congratulations on the occasion of his induction into the Franco-American Hall of Fame;

HLS 129

Roland Alfred Ouellette, of Chisholm, part of what is now the Town of Jay, on his posthumous induction into the Franco-American Hall of Fame. Mr. Ouellette grew up in Jay and graduated from Jay High School. He enlisted in the United States Army and served in the First Army in the European Theater during World War II. He was wounded in battle and lost the use of his legs. That loss did not stop him from participating in the sports he loved. He began coaching with American Legion baseball. He led programs in the Farmington and the Livermore Falls-Jay areas. Mr. Ouellette was inducted into the Maine Baseball Hall of Fame in 2002. In the 1970s, he began the Area Youth Sports program with a group of friends, which continues to offer many sports opportunities to the children of Jay, Livermore

Falls and Livermore, and participated in the Summer Recreation Program in Jay for many years. In addition to his sports activities, he was active in local veterans organizations and the Knights of Columbus. He and his wife Barbara received the Knights of Columbus State Family of the Year Award and the New England Family of the Year Award. They were married in 1951 and were the proud parents of 7 children. Mr. Ouellette was also a recipient of the prestigious Jefferson Award for public service. We acknowledge Mr. Ouellette's service to his community and to the State, and we send to his family our congratulations on the occasion of his induction into the Franco-American Hall of Fame;

HLS 130

Maurice Pelletier, of Augusta, on his induction into the Franco-American Hall of Fame. Mr. Pelletier is a veteran of the United States Air Force and worked for 28 years at the Veterans Administration Center at Togus, where he became a Lead Health Benefit Advisor and received numerous awards. After his retirement, he continued to serve veterans, working part-time as a volunteer Driver Coordinator for the Disabled American Veterans until December 2005. Currently, he volunteers at MaineGeneral Medical Center in Augusta. He is a 48-year member of Le Club Calumet and has served as the club's president. He is also a 3rd and 4th degree Mason. He is a member of St. Michael Catholic Parish and a founder of the Friends for a Heritage Center at Mill Park, a group that contributes to the preservation and advancement of the State's history and culture. We acknowledge Mr. Pelletier's service to his community and to the State, and we send him our congratulations on the occasion of his induction into the Franco-American Hall of Fame;

HLS 131

Joseph Donald Cyr, of Lille, on his induction into the Franco-American Hall of Fame. A historian by education and work experience, Mr. Cyr has been at the forefront of efforts to preserve and promote Acadian culture. He has taught many college-level courses on Acadian history and folklore and French Canadian folklore. He was cataloguer and restoration specialist at the Acadian Village in Van Buren and restoration specialist of the Albert House at the Tante Blanche Museum in Madawaska. He worked with the National Park Service in implementing the Maine Acadian Culture Preservation Act. Active in several major projects, he has raised more than \$3,100,000 in grants for the restoration of the former Notre-Dame-du-Mont-Carmel church and rectory in Lille. A collector of Acadian artifacts, he has amassed more than 300 pieces of handmade Acadian furniture and smaller artifacts, the largest such collection in the country. We acknowledge Mr. Cyr's service to his community and to the State, and we send him our congratulations on the occasion of his induction into the Franco-American Hall of Fame;

HLS 132

George A. "Pete" Lamontagne, Jr., of Biddeford, on his induction into the Franco-American Hall of Fame. Mr. Lamontagne served in the United States Army and was stationed with the Adjutant General's staff in France. He worked for over 3 decades at the Westpoint textile mill, until the mill's closure in 2009. He was a leader in the UNITE HERE Local 305T, at one time serving as union president. He helped found the Biddeford Mills Museum and personally restored a missing plaque commemorating 200 mill employees who fought in World War II. Mr. Lamontagne served 5 terms on the Biddeford City Council, including one term

as Council President. We acknowledge Mr. Lamontagne's service to his community and to the State, and we send him our congratulations on the occasion of his induction into the Franco-American Hall of Fame;

HLS 133

Doris Belisle-Bonneau, of Auburn, on her induction into the Franco-American Hall of Fame. Ms. Belisle-Bonneau serves on the Board of Directors for the Franco American Collection at the University of Southern Maine's Lewiston/Auburn College, represents Franco American interests on the L/A Advisory Committee and co-chairs the Academic Affairs Committee. Since 2003 she has volunteered at D'Youville Pavilion in Lewiston with a focus on serving the French-speaking residents. She co-created and developed the Maine French Heritage Language Program under the auspices of the Franco Center and the University of Maine at Augusta. The program provides an after-school culture and language program for students from kindergarten to grade 6 and is currently active in Augusta and Lewiston. We acknowledge Ms. Belisle-Bonneau's service to her community and to the State, and we send her our congratulations on the occasion of her induction into the Franco-American Hall of Fame;

Senator **EDGEComb:** Thank you, Mr. President. I would like to congratulate Don Cyr from Aroostook. He lives in Grand Isle and he's probably done more to promote the culture of the Acadians in the Saint John Valley and Northern Aroostook than most anyone that's here.

Saying a few words towards my heritage, which is also French, I'm honored to welcome each and every one of you to celebrate Franco-American Day at our beautiful State Capitol here in Augusta. You, of French heritage, have become such an important part of our history, our culture, and our way of life here in the State of Maine. Thank you for your hard work, dedication, and especially your perseverance in helping to make Maine what it is today. Your contributions to the great State of Maine have been both honorable and immense. Today I'm humbled by your determination not to give up your inner strength and good example. You tilled the fields of Aroostook County, produced your food, and never asked for a handout. You logged in the forests of the great North Woods of Allagash and Millinocket, built your churches, homes, and schools. You filled your churches with faith and hope for a better future. You built our towns and taught in our schools. You kept faith with God in your new country. You fought in our wars and shed blood for our freedom. You have earned your place with the patriots of America. You worked in the textile mills of Lewiston and Auburn and Sanford, toiled in the shops of Biddeford and Saco, and helped build ships in the shipyards of Portland. From Eastport to Kittery, you fished the bountiful Atlantic and made our fishing industry such an important part of Maine's history. In the fields, forests, factories, and fisheries of Maine the people of French heritage became the backbone of Maine's economy. Your contributions were

immense, but yet you asked for so little. All that was asked was that your language, culture, and traditions be respected and allowed to flourish. We cannot help but salute you today and thank you for remaining true to your culture, faith, and heritage. I ask you to maintain your faith, continue your determination so that your culture and traditions will continue through the ages. May your French names ring for generations to come and people will know you by your pride, heritage, and contributions to the fabric of Maine and America. God bless to all of you.

**THE PRESIDENT PRO TEMPORE:** The Chair recognizes the Senator from Penobscot, Senator Dill.

Senator **DILL:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I would like to take a brief moment to speak to you about one of our people that we're honoring today, that is Mr. Joe Cyr of Old Town. Cyr Bus has been over 100 years in Old Town. School buses and tour buses. Along with this he's had a very storied history. Cyr Bus has been, as I said, transportation for many things, but one of the most interesting things that I have seen when I've talked to Mr. Cyr is that it's during WWII when Cyr Bus transported prisoners of war to and from Aroostook County. We had a big prisoner of war area here in the state and Cyr Bus was the one that actually did all the transportation of that. He's had a very storied history. Even more so than Cyr Bus, Joe Cyr, himself, is a great local philanthropist. A couple of these things I'd want to mention. He's been a benefactor of the Old Town/Orono YMCA and also the Old Town High School pool. Most recently he's been a driving force in the development of Sarah's House, which is a place to stay for people who are undergoing cancer treatment in Bangor. I'd just like to finish with that I think this is a well-deserved honor for a very honorable man. Thank you.

**THE PRESIDENT PRO TEMPORE:** The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator **KATZ:** Thank you very much, Mr. President. The community of Augusta was in many ways built by Franco-Americans who came here seeking a better life for themselves and their families; worked in our textile mills, in our paper mills, and became business leaders and community leaders. You don't have to look very far out these windows to see the impact that they've had on our community. I'm particularly glad today that so many members of the Club Calumet are here because that club, among other things, is absolutely dedicated to preservation of the French language and the French culture in our community, just as other similar clubs do elsewhere in the state.

Also, Mr. President, I would like to speak to item 1-3 on the supplement because I'm so proud today to welcome Maurice Pelletier here as an inductee into the Franco-American Hall of Fame. When you talk about someone who has worked hard for the American Dream, Mr. Pelletier is a real example. He's a four year veteran of the United States Air Force. He served in Korea. On discharge he worked at a number of different jobs. In 1972, he began a career at the V.A. at Togus, starting really in lower

level jobs but working his way up the ladder, without much education at that point, and getting his high school diploma and becoming a lead health benefit advisor at the V.A., earning numerous awards from around the state for his service. He retired in October 1986 after 28 years of service to Maine veterans. Even then he continued that passion, working part-time as a volunteer for Disabled American Veterans and currently volunteers at the Maine General Medical Center. Mr. Pelletier is a 48 year member of Le Club Calumet and has served as the Club's President. Mr. Pelletier is over there, wearing a red jacket. There are other members upstairs who are also wearing that red jacket. It's kind of like the green jacket for the Masters. You only get it if you're a special person, if you've served as a President of Le Club Calumet. Mr. Pelletier's also a 3<sup>rd</sup> and 4<sup>th</sup> Degree Mason and a member of St. Michael's Parish here in Augusta. He's also founder of the Friends for a Heritage Center in Mill Park, which is going to honor the Franco-American heritage in Augusta in a permanent way. Mr. Pelletier has been married to the former Patricia Gagne of Augusta for 55 years. If any of you want to seek the secret of success you can see him over there afterwards. They have four children and seven grandchildren. Again, thank you, Mr. President, for this opportunity to help honor a truly outstanding Franco-American. Thank you, Mr. President.

Senator **DUTREMBLE:** Thank you, Mr. President. I rise today on item 1-5 on the supplement number 2 in recognition of George A. "Pete" Lamontagne, Jr., of Biddeford.
