**STATE OF MAINE**

**Whereas**, now is a time of potentially significant changes with  
respect to the delivery of health care; and

**Whereas**, there currently exists very little impartial data regarding  
the best method of delivering high-quality health care efficiently  
and economically in the State; and

**Whereas**, it is imperative to establish a method to gather this  
information in order for the Legislature to successfully analyze  
and guide Maine's health policy; now, therefore, be it

**ORDERED**, the House concurring, that, notwithstanding Joint  
Rule 353, the Maine Health Advisory Committee, referred to in  
this order as "the advisory committee," is established to advise  
the Legislature regarding the interests of Maine citizens and  
businesses with respect to the delivery of health care in Maine.

**1. Appointment; composition.** The advisory committee consists  
of members appointed as follows:

- A. The following 5 members of the Legislature, of whom one  
must serve on the Joint Standing Committee on Insurance and  
Financial Services and one must serve on either the Joint  
Standing Committee on Health and Human Services or the Joint  
Standing Committee on Appropriations and Financial Affairs:  
Two members of the Senate, appointed by the President of the  
Senate, including one member recommended by the Senate  
Minority Leader; and  
Three members of the House of Representatives, appointed by  
the Speaker of the House of Representatives, including one  
member recommended by the House Minority Leader;
- B. One person representing the insurance industry, appointed by  
the President of the Senate;
- C. One person representing Maine hospitals or other health care  
facilities, appointed by the President of the Senate;
- D. One person who is an advocate for enrolling in health  
insurance hard-to-reach populations, including individuals with  
mental health or substance use disorders, appointed by the  
President of the Senate;
- E. One person representing health care providers, appointed by  
the Speaker of the House of Representatives;
- F. One person representing a health care advocacy group,  
appointed by the Speaker of the House of Representatives;
- G. One person who has expertise in health economics, appointed  
by the President of the Senate; and
- I. One person who has expertise in statistics, polling and data  
analysis, appointed by the President of the Senate.

The President of the Senate and the Speaker of the House of  
Representatives shall invite the following to participate as ex  
officio nonvoting members: the Superintendent of Insurance, or  
the superintendent's designee; the Commissioner of Health and  
Human Services, or the commissioner's designee; and the  
Director of the Division of Employee Health and Benefits, Bureau  
of Human Resources, Department of Administrative and Financial  
Services.

**2. Chairs.** The first-named Senator is the Senate chair of the  
advisory committee and the first-named member of the House of  
Representatives is the House chair of the advisory committee.

**3. Appointments; convening.** All appointments must be made  
no later than 30 days following passage of this order. The  
appointing authorities shall notify the Executive Director of the  
Legislative Council once all appointments have been made.  
When the appointment of all members has been completed, the  
chairs of the advisory committee shall call and convene the first  
meeting of the advisory committee. If 30 days or more after the  
passage of this order a majority of but not all appointments have

been made, the chairs may request authority and the Legislative Council may grant authority for the advisory committee to meet and conduct its business.

**4. Duties.** The advisory committee shall explore health care issues, including but not limited to the issues of quality, affordability and accessibility of health care throughout the State; the prevention of illness; fairness and equity of health care delivery and accessibility in different geographic regions of the State; various funding options; and methods of cost containment. Through the use of public meetings, questionnaires, polling and other sampling techniques, the advisory committee shall solicit information and concerns from the public. The committee shall review strategies employed by other states and, based on the information it gathers, shall develop recommendations to present to the Legislature regarding the delivery and financing of health care in this State.

**5. Reports.** The advisory committee shall submit to the Joint Standing Committee on Health and Human Services a preliminary report on its activities no later than December 31, 2017. The report must include:

A. A review and an evaluation of the continuation of the advisory committee, including the staffing and funding needs of such an advisory committee, and recommendations regarding the advisability of establishing an ongoing advisory committee in the Maine Revised Statutes; and

B. Recommendations for any changes in policy or law that would improve the delivery of health care for citizens and businesses in the State.

**6. Compensation.** The legislative members of the advisory committee are entitled to receive the legislative per diem, as defined in the Maine Revised Statutes, Title 3, section 2, and reimbursement for travel and other necessary expenses related to their attendance at authorized meetings of the advisory committee. Public members not otherwise compensated by their employers or other entities that they represent are entitled to receive reimbursement of necessary expenses and, upon a demonstration of financial hardship, a per diem equal to the legislative per diem for their attendance at authorized meetings of the advisory committee.

**7. Quorum.** A quorum is a majority of the members of the advisory committee.

**8. Meetings.** The advisory committee shall hold 6 meetings, 4 of which must be held at geographically diverse locations throughout the State. Meetings of the advisory committee are public proceedings as provided by the Maine Revised Statutes, Title 1, chapter 13, subchapter 1.

**9. Staffing.** The Legislative Council shall provide staff support for the operation of the advisory committee, except that the Legislative Council staff support is not authorized when the Legislature is in regular or special session. In addition, the advisory committee may contract for administrative, professional and clerical services if funding permits.

**10. Funding for advisory committee activities.** The Legislative Council on behalf of the advisory committee may accept from a state department or agency funding that is received by that department or agency for functions or activities performed by the advisory committee. The Legislative Council on behalf of the advisory committee may apply for and receive funds, grants or contracts from public and private sources to support the advisory committee's activities. Contributions to support the work of the advisory committee may not be accepted from any party having a pecuniary or other vested interest in the outcome of the

matters being studied. Any person, other than a state agency, desiring to make a financial or in-kind contribution shall certify to the Legislative Council that it has no pecuniary or other vested interest in the outcome of the advisory committee's activities. Such a certification must be made in the manner prescribed by the Legislative Council. All contributions are subject to approval by the Legislative Council. All funds accepted must be forwarded to the Executive Director of the Legislative Council along with an accounting record that includes the amount of funds, the date the funds were received, from whom the funds were received and the purpose of and any limitation on the use of those funds. The Executive Director of the Legislative Council shall administer any funds received by the advisory committee.

#### READ.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Gratwick.

Senator **GRATWICK:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I present to you this Joint Order for a study commission looking at inefficiency and waste in our healthcare system. As background, I'd simply have you know three figures. One is our state gross product is \$58 billion. That's how much money we generate in the state. A lot of money, \$58 billion. Of that we spend \$11 billion, nearly 20%, on health. Eleven billion dollars, private, public, whatever it be. Eleven billion dollars on that, nearly 20% higher than virtually every other state in the United States. Of that money spent, 25% to 35% is considered waste. It's not affecting health at all. Therefore, roughly \$3 billion we're spending on health in Maine does not have much impact on how we live, breathe, how we live our lives. It's extraneous money. I can tell you I can spend a long time telling you about all the ways that we waste money in terms of administrative inefficiencies, insurance, the drug costs are outrageous, lack of preventative medicine, the lack of foresight when people are hospitalized. We are not efficient at all in the way we spend our healthcare dollars. We can do much better. This advisory committee, 13 members appointed by the President and then the Speaker of the House, 13 members will be legislators plus outside economist experts, hospital people. It must be a bi-partisan group. This is a bi-partisan problem for us all. It should not be political. There will be committee meetings outside the State House, gathering information from other communities around the state, starting probably late August, September, through December and bringing back some recommendations for what we can do. This is designed to be a very hard, heavy lift. In other words, we have to begin to tackle some of the problems right here at home. We cannot depend upon Washington looking over healthcare because Washington is now in chaos. We have to take care of our own home. We have to do a better job, save more money for Mainers. Eleven billion dollars is a lot of money. Will this be successful right off the bat? The answer is no, but I consider it very important that we begin to try and so this is something that will be giving us a return on our investment for health dollars, an improved return on investments, so I would very much appreciate your support as this goes forward. Thank you, Mr. President and ladies and gentlemen.

Senator **VOLK** of Cumberland requested and received leave of the Senate to withdraw her motion to **TABLE** until Later in Today's Session.

On motion by Senator **BELLOWS** of Kennebec, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Bellows.

Senator **BELLOWS:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise in opposition to the pending motion. From my perspective, L.D. 165 is a rural Maine jobs bill. This bill provides funds to match federal funds that are distributed as grants to local communities through the CDBG program in areas ranging from infrastructure, housing, and downtown revitalization. The impetus for this bill came from the Town of Rumford and Representative John Madigan of the House who had a \$4.3 million infrastructure project to replace water and sewer pipes, a problem that we know from experience across the country that is incredibly important. Representative Madigan approached the State a year ago and was notified that 13 towns had applied for funding for just over \$10 million. Unlike the large municipalities, like Augusta, Lewiston, or Portland, towns in rural areas, and in my district, cannot draw down directly from the federal government. They must go through the State. So over the last year Representative Madigan described that the Town of Rumford secured the remaining funds necessary for the project, prepared engineering bid packages, and spent \$100,000 of local taxpayer money to prepare a shovel-ready project. To his surprise, and surprise by the Town of Rumford, this year the State announced on its website, and I quote, "No letters of intent or

applications will be accepted for the 2017 program year." The projects of Machias, Lincolnville, Ashland, and East Millinocket who submitted applications in 2016 are being funded in 2017. In other words, because of the lack of appropriations by this Legislature and by the State, no new CDBG programs or applications or letters of intent will be accepted. The LCRED Committee heard that CDBG funding in 1983 was just under \$12 million. It rose to a high of \$28 million in 2003, but has since plummeted to a mere \$9 million in 2016. In other words, we are spending dramatically less money, roughly one-third when adjusted for inflation, for CDBG block grant funds for our rural towns than we were 30 years ago. The longer we delay these infrastructure projects, like the Town of Rumford project, the most costly not only the projects themselves will be but the consequences of inaction in respect to our infrastructure. Well the Maine Municipal Association testified neither for nor against, their testimony expressed concerns about underfunding of CDBG by our State and I quote, "The reason the LPC chose to testify neither for nor against rather than in support of L.D. 165 is that our top priority is restoring revenue sharing." Two of the projects the MMA highlighted in their testimony as they advocated for the CDBG program were the Town of Eastport and the Town of Machias, where CDBG funding has had a tremendous economic development impact. I know from my experience, the City of Gardiner has used the CDBG block grant program to revitalize its downtown and support local companies like Central Maine Meats, The Common Wealth Poultry, Sebago Lake Distillery, and Lost Orchard Brewing that are creating jobs right now in my district and have a huge economic impact. I believe CDBG block grants are a vital tool to create jobs and promote economic development and I hope you will join me in voting no to the pending motion and supporting the Majority Report and the House in its efforts to create jobs in our rural communities. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Sagadahoc, Senator Vitelli.

Senator **VITELLI:** Thank you, Mr. President. Thank you, members of the Senate, I also would like to rise in opposition to this motion and urge that we pass L.D. 165. This is not just a jobs bill, but it's a small business bill. I've spent the last 30 years, let's say, helping small businesses throughout the state get started and I would say that these funds are especially helpful in our rural small communities as they set up revolving loan funds on the ground for their local businesses. Just as one example, the City of Presque Isle has partnered with local business assistance organizations, I happen to know one of them, to provide training and technical assistance to the small businesses who then apply for their CDBG loans in order to grow and sustain their businesses. CDBG funds, as you've heard, can also be used for infrastructure and they help improve our downtowns and contribute to more vibrant small communities. These are resources that are not otherwise available in these rural areas. This is an economic development bill that puts resources in the hands of our small rural communities. I urge your support. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Carson.

Senator **CARSON:** Thank you, Mr. President. I, too, rise to ask that we defeat the Ought Not to Pass motion and that we enact

this bill. I didn't know until this morning that it would be before the Senate. I can tell you that the population center of the largest town in my district, the Town of Brunswick, has benefited greatly from community development block grants in terms of revitalizing our downtown. It's not just federal money matching the state money, it's jobs, jobs, jobs. There are veterans coming back from Iraq and Afghanistan and the Middle Eastern theatre who want to go to work. There are people who are now on public assistance, or getting food stamps, who want to go to work. If we can match state dollars with federal dollars, as Senator Bellows mentioned, we can go from \$9 million, which is the current funding level, back to perhaps \$12 or \$15 or \$20. We can put Maine people to work. Please, ladies and gentlemen of the Senate, defeat the Ought Not to Pass Report and support jobs for Maine people. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Volk.

Senator **VOLK:** Thank you, Mr. President. Mr. President, ladies and gentlemen of the Senate, we don't have the money.

**THE PRESIDENT:** The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator **SAVIELLO:** Thank you, Mr. President. Mr. President, may I pose a question through the Chair?

**THE PRESIDENT:** The Senator may proceed.

Senator **SAVIELLO:** Can somebody please tell me what the fiscal note is on this particular bill?

**THE PRESIDENT:** The Senator from Franklin, Senator Saviello, poses a question through the Chair to anyone who may care to respond. The Chair recognizes the Senator from Androscoggin, Senator Mason.

Senator **MIRAMANT:** Thank you, Mr. President. Men and women of the Senate, this bill has roots in the theory that the voters aren't smart enough to know what they're voting for, something we've heard repeated here and that wasn't true then but communication and transmittal of information was more difficult then. Now it's not. The information gets out. The next step of the Electoral College for deciding elections was rooted in slavery. This was an appeasement to the slave states. They were allowed to count their slaves, although they couldn't vote, and use a two-fifths ratio. That increased the number of electoral votes that they had for their states. So after that not much has changed except that when I'm out talking to people, and I'm talking about how important their vote is, I say every single one matters. I hear every person in here say how important that is, but five times in our history the Electoral College has overruled the popular vote. That means that winner for two times in various parties, has been equal in the major parties and once for a different party, five times a smaller group of people have decided the election even after saying that every vote counts. I'm not doing this because it's partisan or benefits my party. It's worked against us twice. I'm doing it because I'm tired of telling people every vote counts. I'm going to go and tell the ones I don't like how I think they'll vote to stay home, stay out of the way. That's democracy now. Who cares what you think? Who cares if you vote? Your vote is worthless. It's crap. We need to support the roots of slavery and other garbage rather than come up with something that makes sense in this country. So let's start making some sense and aligning and getting this to where if you win by one vote you are the winner. You're not set out. When you lose by 3 million votes you are not the winner. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Chipman.

Senator **CHIPMAN:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise in opposition to the pending motion and in support of the bill. I've always felt that the person with the most votes should win. The problem with the system that we have right now with the Electoral College is the candidates raise their money, they do their polling, they see where the swing

states are, and they spend most of their time there. If you look at this last election and the few elections before that, you'll see that almost 95% of all the visits to states happen in about ten states. I think it's really frustrating. I mean, we're lucky that we split our votes and we get a few visits from candidates when things look close here, but there are many states in this country that don't see any of the candidates for President at all. They never go to their state even once. You can look up on-line to see where those states are. I think if we get rid of the Electoral College and go to a national popular vote it will force candidates to visit all 50 states, to visit with residents of all of those states, and make their case, and the one with the most votes will win, but it will require them to reach out to every state in the country because every state will matter equally and that every vote will matter equally in terms of getting to a victory. So that's really my reason for supporting this bill and I hope you will join me in voting against the pending motion. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Diamond.

Senator **DIAMOND:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I hope that you will support the motion. I think our Founding Fathers knew what they were doing. I think the Electoral College works. I think it brings into play small states. I think it also does, would not, focus all of the attention on the large populated states and I stand here saying I think, again, our system works and I would encourage you to support this motion and I see no reason why we should change a system that's been in place for over 200 years. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. I rise in support of the motion before us and in strong agreement with my colleague from Cumberland County. You know, as our Founders set up this nation, we were designed to be a collection of societies, not one giant municipality where we just elect our President like we elect a Major. We are a very, very diverse country and we saw in this election cycle Presidential candidates coming to visit our very small state. If we were to have a national popular vote you can bet that we will never see that again. Maine's vote will be discounted and every Presidential candidate will spend all their time in the population centers like New York and Texas and California and good luck hearing from any Presidential candidate in Maine ever again.

Senator **MIRAMANT:** Thank you, Mr. President. Men and women of the Senate, I just filed my income taxes and they didn't lower them because we rejected all kinds of federal money to improve our programs and create jobs. I was surprised because we hear it all the time. We can't afford this. We can't afford this even though this is trying to get money from the feds that's sitting there, that other states are getting, that we throw back and we give to other states. We're like we ought to have a group from every state in this country come here and say; "Keep rejecting funds. Boy, we're doing so much good with them. We're putting our people to work." Another one of them, last session, you voted for it. This passed, this bill passed. It had gone through process, as it did this time. It passed the House and the Senate and hit a stumbling block. I don't have to tell you what that was. So it came back and all the best pieces are in it. All the worst are removed. It passed the committee. Here it is and what it does is allows towns to get together and go after some of that money that's out there that otherwise is given to other states and other towns, well not in Maine. Here I am, rolling along, I'm thinking people keep saying, "Quit bringing these bills that cost the state so much money. You're spending our money. You don't think about it." I'm sorry. Let me bring one that brings money to

Maine. You reject that too. This reminds me of a committee I keep going to where they have this tag team thing going between two different groups to try to fight bills. They are very effective and this is like that. This is kind of schizophrenic to me, or something. Two personalities. As a Gemini I can appreciate that, two voices at the same time. How do I do good for this state? Quit spending money. Try to bring money. I'm doing both. I'll keep bringing bills and I'll keep pointing out when that is what one of these is. So reject the Ought Not to Pass, look at the Majority Ought to Pass. Let's do that one in a couple of minutes and thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. I just want to say, with due respect to my colleague from Knox County, Maine is already a net receiver of federal funds and this is not just money that is paid in from other states. The federal government is borrowing a million dollars a minute and we are approaching \$20 trillion in national debt. It's not just money being paid in right now by states across the country. These are dollars being paid in by our children and our grandchildren in the future.

**THE PRESIDENT:** The Chair recognizes the Senator from Knox, Senator Miramant.

Senator **MIRAMANT:** Thank you, Mr. President. Men and women of the Senate, thank you for pointing that out. I do appreciate that. I will take note, but as I started with nothing we do seems to reduce our federal income taxes and they don't seem to be changing that. While we're able to take the money, great. They should be finding ways to stop that and bring them down, that are fair to everybody who needs the help and the states that need the help, but for now they've got it and they're giving it to other people and we should get it.
