**TOWN OF CAMDEN**

April 26, 2013

**Resolution Expressing Opposition to the Governor's Proposed State Budget which Shifts Responsibility for Funding the State Budget Shortfall to the Property Tax and Property Taxpayers**

Whereas, the Governor has proposed a biennial budget that will shift the responsibility to fund State government by eliminating or significantly modifying Maine's primary programs that are intended to provide property tax relief;

Whereas, the property tax is the most regressive form of taxation and by eliminating Revenue Sharing and greatly changing the eligibility criteria of the Homestead Exemption and the Maine Residents Property Tax and Rent Refund Program (Circuit Breaker) would make the State's tax mix more regressive;

Whereas, by eliminating the State-Municipal Revenue Sharing program, the Town of Camden would lose approximately \$300,000 which would mean a property tax increase to both residential and business property owners, cuts to essential local services, or both;

Whereas, the proposed budget would eliminate the Homestead Exemption program for anyone under the age of 65, which would result in an automatic property tax increase of \$136.80 even if the local budget had no increase;

Whereas, the proposed budget would eliminate the Maine Residents property tax and rent relief program "Circuit Breaker" for anyone under the age of 65 and hurt the people most in need at a time they can least afford to pay higher property taxes; now

Therefore Be it Resolved, that the Camden Select Board calls upon the Maine Legislature to reject these proposals, restore Revenue Sharing, maintain the Homestead and Circuit Breaker programs, and fund State government through an equitable tax system that prevents this unfair shift to property taxpayers.

**JOINT RESOLUTION  
RECOGNIZING THE CITY OF SANFORD AS MAINE'S  
NEWEST CITY**

WHEREAS, Sanford, Maine's newest city, is located within beautiful York County, Maine's southernmost county and gateway; and

WHEREAS, the City of Sanford displays a visually breathtaking area of Maine, as it is bordered by ridges and is complemented by brooks and streams as they flow into the pristine Mousam River and then on to the Atlantic Ocean; and

WHEREAS, in 1661, Major William Phillips, an owner of mills in Saco, purchased from the Abenaki Chief Fluellin a tract of land, the western portion of which would become Sanford; and

WHEREAS, the first settlement in this area was established in 1739, and on February 27, 1768 it was incorporated as the Town of Sanford, named after Peleg Sanford, the son of Major Phillips; and

WHEREAS, Sanford held its first town meeting as ordered by the General Court of Massachusetts; and

WHEREAS, by a Special Act of the Maine Legislature in 1935, Sanford changed its form of governance to a representative town meeting; and

WHEREAS, in 2010 a charter commission developed a new charter, and, on November 6, 2012, the people of Sanford voted to establish Sanford as a city with a Council-Mayor-City Manager form of governance, effective January 1, 2013; and

WHEREAS, Sanford is a vibrant service center and economic hub with investments in exceptional infrastructure, economic development partnerships and quality of life and has now implemented a progressive and responsive form of governance reflective of its business-friendly accreditation, and the City of Sanford has been proclaimed "Open for Business"; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-sixth Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize the transition of the Town of Sanford to the City of Sanford on January 1, 2013, the first city created under Maine's home rule provisions enacted in 1970; and be it further

RESOLVED: That We acknowledge the commitment of all Sanford residents, past and present, to improve their legislative and administrative system in response to the needs and will of the people and businesses of Sanford, an economically vibrant and inviting community; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the 2010 Sanford Charter Commission and the Sanford City Councilors for display and preservation for the residents of Sanford, the newest city in Maine.

**THE PRESIDENT:** The Chair recognizes the Senator from Somerset, Senator Thomas.

Senator **THOMAS:** Thank you Mr. President. Ladies and gentlemen of the Senate, I didn't intend to speak on this again, but Senator Jackson said something yesterday when we talked about this bill. It started me thinking. When I first started buying off-road fuel we didn't pay \$1 a gallon for it. We paid 19¢. Once a week we'd go fill up the fuel barrel and we'd pay our 40¢ or 50¢ tax and that would go us all week. No one worried about 40¢ or 50¢. Today, if you are going to the woods and you are going to do anything, 100 gallon fuel tank is not big enough. You need 200 or 250. It's not 19¢ anymore. It's \$4. You are paying \$50 or more every day for taxes so you can work. Some people will say, "Well, you're getting more for the wood that you sell. What are you complaining about?" Yes, you can. The last time I sold logs, the last time we had a saw mill in Greenville, I got half as much as I get today. Fuel is 20 times as much and we get twice as much for the logs. Sounds like a good deal to me. Doesn't it you? We're working for a lot less and we're paying a lot more in taxes. It's a struggle. We've had votes here where it seems like we can't wait when some multi-national corporation comes here with their hand out and they want millions of dollars in one tax break or another, one special treatment or another. These people that we are talking about, they are not multi-national corporations. They are local people. They've been doing this for 4 or 5 generations. We're quibbling about a few pennies a gallon. Last year the fishermen needed a break. We didn't just reduce the tax, we eliminated it. These loggers, who are struggling, are paying way outrageous prices for their equipment, and are working more hours than most people that I know put in, need a break. They need some help, just like the fishermen did. How about if we are a little less anxious to give these multi-national people a break and we're a little more anxious to help our home-grown people? Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Washington, Senator Burns.

Senator **BURNS:** Thank you Mr. President. Ladies and gentlemen of the Senate, I, too, had decided not to speak on this, but given another opportunity I thought I would weigh in on a very important issue to my area. Much of what I believe has already been said here, especially by the good Senator from Aroostook, Senator Jackson, and Senator Thomas. I think it's very important for us to remember that what may create a fiscal note to us is very important here, but it's not as important to those people that

are trying to make a living day in and day out, out on the highway, driving these trucks and trailers, especially in the northern part of my district. We just passed a bill a couple of days ago here that may or may not have an adverse impact on that part of my district that is up above Princeton, where there are very few opportunities for people to make a living, whether you are a sportsman guide or whether you are driving a log truck or working in the woods. If we can do anything here such as reducing some of the costs of doing business which they are engaged in, trying to make a living for their families, I think it's an opportunity missed if we don't do that. As the good Senator Thomas just mentioned, we saw fit to do this for the lobstermen and the fishermen last year. Rightfully so, it made their bottom line a little bit better so that they could make a living. I think it's very reasonable for us to consider doing this for these people that are working in the woods industry especially. I'm going to vote to support that type of measure and against the pending motion. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Haskell.

Senator **HASKELL:** Thank you very much Mr. President. Colleagues of the Senate, I don't disagree with the importance of helping businesses here in the state of Maine. I believe that this dyed fuel that is purchased is already exempt from one tax, so there is some advantage that's been provided to this group. I would also remind people that when the cost of this is borne by the Appropriations Committee and it moves onto the people of the state of Maine, it is working men and women who are going to pay this as well. They are going to have to pay the bill for this. It's going to come out of them in some way. Once again, I would encourage your support for the Ought Not to Pass Report. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Jackson.

Senator **JACKSON:** Thank you Mr. President. Ladies and gentlemen of the Senate, I just wanted to rise and say how much I respect the Senator from Cumberland, Senator Haskell, and the tough job that she has in the Taxation Committee. There are a lot of competing interests on our limited revenues coming into the state. I understand truly how hard it is to balance all those interests. I also wanted to take the moment to say that the Professional Logging Contractors of Maine asked me to put this bill in on their behalf. I have a lot of people in my district that this will affect. I also wanted to say, for all the comments that were very good about helping Maine businesses here, that Professional Logging Contractors of Maine has got another couple of bills coming that are totally designed towards Maine businesses, not those foreign, multi-national corporations that we've heard about. I certainly hope that we have the same zest and support for those bills coming down the pike that we do today.

**THE PRESIDENT:** The pending question before the Senate is the motion by the Senator from Cumberland, Senator Haskell to Accept the Majority Ought Not to Pass Report. A Roll Call has been ordered. Is the Senate ready for the question?

Senator **THOMAS:** Thank you Mr. President. Ladies and gentlemen of the Senate, this bill, if we defeat the pending motion, would allow one sign on the northbound side of Interstate 95 in Lincoln, 100 or so miles north of here. This sign would help people from 17 countries and 15 states find the school their children attend. It will help parents from all over the world find Lee Academy before they spend more than \$30,000 a year to send their children to this great school. By the way, those parents will add hundreds of thousands of dollars to an economy that has one of the highest unemployment rates in the state of Maine. When I served on the Transportation Committee, we allowed both Hebron Academy and Maine Central Institute to have two signs on I-95. Lee Academy only wants one sign and they are willing to pay for it themselves. If you miss the exit in Lincoln, you've got to drive all the way to Medway and then drive all the way back. If you've ever been up there, that's a long ride even at 75 miles an hour. This school needs a sign to direct visitors to the school and they deserve it, just like MCI did and just like Hebron Academy did. Please help people find this great school and vote against the pending motion. Thank you.

I also want to make sure that we understand, I want to make sure that it is clear that I understand, the Transportation Committee has had serious and ongoing

conversations about the challenges of these signs and making sure that we don't cross a line or get into a slippery slope related to billboards. I want to thank them publicly and I appreciate that work. In this case, it is about consistency. It is about the signs that have already been in place and put in place in other places. In case it was not stated, I wanted to reinforce the fact that Lee Academy is only asking for one sign, only on the northbound side of the highway, and that they will assume all costs related to the creation of the sign and the placement of the sign. I appreciate the opportunity to share this information with you. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Valentino.

Senator **VALENTINO:** Thank you very much Mr. President. Members of the Senate, I rise to speak in support of the Majority Ought Not to Pass Report, a report that 11-2. One of those was the good sponsor of this bill. I would champion for my academy the same way. Lee Academy is a wonderful academy. We heard wonderful things about Lee Academy, but we also had another bill in for Berwick Academy. That sponsor had wonderful things to say about Berwick Academy and had a room full of people, students and educators and parents of foreign students, who came in to speak for that sign. We did not vote to approve that sign. We also had a sign for Gould Academy come in. That, again, we had people come in to speak about the wonderful attributes for Gould Academy. We did not allow that sign. I will also say that I represent Thornton Academy and Thornton Academy is a wonderful school which has foreign students from all over the world that come to Thornton Academy. If you miss the exit for Saco, you do have to go all the way down into Scarborough for the next exit. You have to go through a lot of traffic. We can't go 75 miles an hour on my stretch of the road yet. There are a lot of great schools out there and my first reaction is that if this goes through I'm going to run down and put an after deadline bill in and I'm going to get one for Thornton Academy because it's a great idea. The problem has been that it is an extremely slippery slope. All of the signs that are up there are all in violation, really, of the Department of Transportation rules. They have all been done by the Legislature. That's why we have a sign when you get off the turnpike that says Fort Kent, 10,000 miles from now. It was legislatively done. That sign is a nonconforming sign. You go down 295, you go down the turnpike, they are all nonconforming signs. It has to be a point where you say stop. We need to treat everybody fairly. Treating Lee Academy by denying their sign is actually treating them fairly. It is treating them the same way that we have treated everybody else in the Transportation Committee. A sub-committee was actually formed to look at all of the sign requests and the sub-committee came back and said, "Enough, no more signs." Every single person offered to pay for their sign, to put their sign up. This is not anything new. Everybody offered to pay for their sign. I think everybody would have gone and physically hammered it onto the post themselves. All I'm saying is that if we allow one, without allowing the others, is that fair? Is that what we want to do? I would say that the 11 people on the Transportation Committee said no, that is not fair. Thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Gerzofsky.

Senator **GERZOFSKY:** Thank you Mr. President. Ladies and gentlemen of the Senate, you might have thought I'd gotten up to debate on helmets today or other issues. This one I didn't expect that we were going to debate. Seeing how we're going to debate it, I want to get my two cents in because I put in a sign bill this year for a town in my district that has no sign for a whole town. Actually the liaison from the Department of Transportation got lost twice trying to find this town. The town of Harpswell. I know where it is. I can't hardly get any place without bumping into it. They don't have a sign on the Interstate. They've wanted a sign on the Interstate since the Interstate was built, since 295 got up there. They asked me to put in a bill this year and I did. I talked to the chairs of the committee and I found out just what they were going to do with sign bills. Well, I took my lumps like everybody else. They were very nice. They allowed me to table it so I could go to my community. I could also take the Commissioner of Transportation with me. We brought in a thick book and explained to them the rules and how much we'd been breaking those rules in the Legislature. If we're going to pass signs, we might as well get rid of the billboard sign law because we've taken the State and put it in the position of creating the billboard signs. If you drive down the highway, down south or up north, you will find a proliferation of signs telling us how to get to everyplace except Harpswell. I couldn't get my Harpswell bill in this year, so if this bill were to pass I want you to know where I'm going to be tomorrow. I'll be down in Transportation trying to resurrect my bill, just like everybody else will. We have a proliferation of State signs. Either we are going to reenact the sign bill law and start having signs all over the place like we're doing, except they won't be State sponsored signs, they will be commercial signs. Just what an academy would have, a big billboard, back in the old days, saying where the academy was. We got rid of that. We replaced them with State signs. I would say follow the chairs on this one. Follow the committee, 11-2 vote. Treat everybody the same. I just want fair treatment, my friends. If you get a sign, I want a sign. That's the way it's going to go through this whole Legislature. Thank you very much, Mr. President, for your time.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Collins.

Senator **COLLINS:** Thank you Mr. President. Ladies and gentlemen of the Senate, today's modern vehicles, they have GPS in them. You could find just about any place in the United States by relying on one of these systems. I'm sure that includes Lee Academy. As far as the necessity for a sign, I question whether or not it's even needed. We have, on the Transportation Committee, in the past have tried to be cooperative, but it was a mistake, in allowing signage for other private academies. That was a mistake. We've now adopted the federal regulations, which prohibit those types of signs on the interstate highway system here in Maine. I think that's the correct course of action. We've treated all the sign bills the same way this particular year in session. They are all being voted almost unanimously Ought Not to Pass. I am also on that side of the ledger of Ought Not to Pass. As mentioned in previous testimony, it was an 11-2 vote in the committee of jurisdiction, that being the Transportation Committee. I would urge you to follow my light. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Washington, Senator Burns.

Senator **BURNS**: Thank you Mr. President. Ladies and gentlemen of the Senate, I can't believe I'm rising twice in the same day. I learned several years ago that that's not a good idea, but I can't sit in my seat on this one. Just for a moment please indulge me. The good Senator, Senator Valentino, mentioned that this is an issue of fairness and I agree wholeheartedly. We already have two signs. Somebody asked the size of that sign. I believe it was Senator Craven. As you know, I come back and forth every Sunday. On my way down Sunday night I looked for the sign for MCI so I would have some idea what I was talking about. It's pretty innocuous. I think it's only about 10" high and the width of the large billboard above it. It is something that you drive by day in and day out and never notice. It's not like it's an eyesore. It's very appropriate, I think. Again, the issue is of fairness. It's already there for MCI. It's already there for Hebron. I certainly would never suggest that those two wonderful schools would lose their sign, but I am suggesting that it's a matter of fairness that we do this for this school. I understand the argument about the billboards. We're not talking about billboards here. We're talking about giving some direction to a very important institution. I don't think that's going to open the floodgates to all the billboard signs coming back. My little academy down in Washington County. We're off Route 1. We're not off the Interstate. We have a small sign on both sides of the road that leads off Route 1 to go to the academy so people can find it. I'm sure their GPS's would take them there, but you know it's kind of nice to have a little bit of direction. It's certainly kind of nice to have something to look at that will give you some direction when you go north of Old Town. If you haven't been there, take the ride and see for yourself. I think what's being requested here is very reasonable. I don't think it's going to open up the floodgates and I would ask you to not support the motion. Thank you very much.

**THE PRESIDENT**: The Chair recognizes the Senator from Aroostook, Senator Jackson.

Senator **JACKSON**: Thank you Mr. President. Ladies and gentlemen of the Senate, just to rise and answer the question that was put. It's not 10,000 miles; it's 290 to Fort Kent.

**THE PRESIDENT**: The Chair recognizes the Senator from Oxford, Senator Patrick.

Senator **PATRICK**: Thank you Mr. President. Ladies and gentlemen of the Senate, colleagues and friends, I did co-sponsor the bill to put a sign for Gould Academy and am pretty sad that it didn't get there. I've heard of Lee Academy. The one thing I do know is Lee Academy is located on Route 6, 12 miles east of the town of Lincoln, Maine. It is accessible from both the north and south by traveling on Interstate 95 to Lincoln. We're in the center of the Village of Lee, the crossroads of Route 6 and Route 168. If I didn't know where Lee Academy was, one thing I would do is look it up. The directions are pretty clear on their own website on how to get there. As much as I'd like to support this, I'd like to support one for Gould and the other institutions as well. There will always be an issue of fairness on there unless we open it up to everyone who wants a sign on there. If we open it up to just the institutions I'm sure there are many small businesses that want to have one. Signs do work in some respects and signs don't work in other respects. We've got a sign down at the beginning of the state of Maine that says, "Open for Business"

and that doesn't seem to have worked all that well. I'm going to be voting in support of the Adhere.

**THE PRESIDENT**: The pending question before the Senate is the motion by the Senator from Aroostook, Senator Jackson to Adhere. A Roll Call has been ordered. Is the Senate ready for the question?

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator **KATZ:** Thank you Mr. President. Men and women of the Senate, I rise in support of this motion. I think we all want to have great schools. I think we can also agree that a part of having great schools is having great leaders. That begins with the Superintendent of Schools. To me, that's the goal of this legislation. It's to help communities be in the best possible position to have the best leaders. Right now certain charters, including the charter of the City of Augusta, indicate that school superintendents must live within the four corners of the municipality. Let me tell you a little bit about the Augusta City Charter. It was passed decades ago. It was reviewed by a commission back in 1997. I know because I was chair of that commission at that time. We talked about how many city councilors we ought we have and we talked about what the districts ought to be. We talked about all sorts of things in this 40 page charter. I can assure you that one thing we didn't think about back then, that was sort of passed over, was this antiquated charter provision rule that was in there that looked back to an earlier day when school superintendents tended to be in their jobs for 20, 30, or 40 years, as was the case in Augusta literally, and it was just passed through. Times have changed. School superintendents are like baseball managers now. They have a shelf life of about three to five years for a variety of reasons. A requirement that school superintendents live within their communities really does tie a community's hands. You could say, "Fine, why don't you just go and change the charter?" We can certainly try to do that, but changing the charter is a rather cumbersome and complicated procedure. The alternative is to say, "Why don't we leave these decisions in the hands of those who really think most about educational issues? They are not appointed people. They are not self-anointed. They are elected by the community." That is our school boards; school boards who understand the challenges of trying to recruit superintendents. I'm sure you've all faced that in your own districts as well. Right now, let's say we identified in Augusta a great potential school superintendent who lived in Hallowell, less than a mile from where we are right now. That person was towards the end of their career, they don't want to have to sell their home, or even someone younger who's not sure they are going to be a good fit for the community and want to sell their home. Right now we literally can't hire them. I understand the opposition to this. It's a matter of local control. If it's in the charter; go change the charter. It is a matter of local control. It seems to me that the committee, by, I think it was, a 12-2 vote or a very lopsided vote, said, "Let's leave that local decision in the hands of the local elected officials, the school board." It seems to me that's a good outcome and I urge support of the motion. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Waldo, Senator Thibodeau.

Senator **THIBODEAU:** Thank you Mr. President. Ladies and gentlemen of the Senate, you certainly can't make this stuff up. I

think it's important that we not lose sight of how this bill got here. This bill was sponsored by an individual that represents a district where this is a very important issue. It was taken to the voters of that district. There was an attempt to change the charter so that the superintendent in that district did not have to live within the confines of that school district. It was rejected by the voters. Now we have a bill sitting before us today from one of our representatives. They brought it in good faith, but the fact of the matter is this is an attempt to override the will of the voters in that community. I think that's unfortunate. We're going to, as a Body, say that the school boards should have jurisdiction over a town charter. I really hesitate to give them that sort of authority. I appreciate the fact that they are the ones that have interaction with any superintendent within the state. The fact of the matter is that voters in that district said, "We want our superintendent to live in our community." We certainly shouldn't be stripping that authority away from any of our communities. If that is what the community decides that they want in their charter, that's where it should be. I might add that it's not the school board that has typically had jurisdiction over town charters. It's the municipal officials. Now we're allowing the school board to make that decision. I think that's unfortunate. I think it's an overreach on our part as well as an overreach on any school board's part to simply override the will of the people that they are representing. That's not good government. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Lincoln, Senator Johnson.

Senator **JOHNSON:** Thank you Mr. President. Ladies and gentlemen of the Senate, I just wanted to point out that this is exactly the debate we had in the committee. It started with a great deal of concern over local control. It's also very clear in Maine law that what the school board does have responsibility for is hiring a superintendent. This is a case where it's the town charter interfering with their ability to fulfill that expectation. We felt strongly that the school board is responsive to the district which elects them. We also felt that, although in the particular case you are referring to where it's a municipal school district, there is an inherent problem in having municipal charters determine where a superintendent lives as we now have many more districts that are consolidated school districts. Which town's charter in a consolidated school district should determine where the superintendent must reside if you have several? I think that leaving the question to the charters of the municipalities creates an inherent problem and the responsibility is clear in law that it's the school board that makes those decisions. They are still elected. We need to give them the power to make those decisions for the best interest of the school system. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Valentino.

Senator **VALENTINO:** Thank you very much Mr. President. Members of the Senate, I rise today to support the Majority Report out of the Education Committee. The report was a 12-1 report. I did not support the original bill. If the original bill was before this Body I would not be voting for the original bill. This is not the original bill. Even the title has been changed. The title is now, "An Act Regarding the Authority of a School Board to Elect a School Superintendent." It's a new title and a new bill and a new amendment that I can support. It was a difficult decision for me



because I do represent part of Biddeford and the superintendent actually lives in Saco. I think that work that the Education Committee has done on this fulfills the needs of both the citizens and the school board and is a practical solution. This is not about one community. This is about the entire state of Maine. The amended version simply allows a school board to choose whether or not the residency should be part of the superintendent's contract. There is no order. There is no mandate. Only an option. The bill is really about home rule; letting the school board decide. All existing state law indicates that school boards and school units have sole control over a superintendent. Let the schools work that. State law already has declared that municipalities cannot restrict fire chiefs or police chiefs or other city employees from having to reside in the town or city in which they work. I would question why we're forcing a superintendent when we could have a fire chief or a police chief in Saco that might live in Cape Elizabeth. If there is an emergency, he has to come down from Cape Elizabeth. A superintendent has to be in the same town. I would think those emergency personnel, if anything, they would be required to live in the town. That is not the case because state law has said that they do not have to live in that town. As I said, I did not support the original bill, but I do support the amendment. One of those reasons is that I do have a letter here from the Biddeford school committee which, "We the members of the Biddeford school committee, by unanimous vote, express our support of L.D. 6 as currently amended by the Education and Cultural Affairs Committee of the Maine Legislature." It is signed by every member of the school board. With that, I would say we do not force fire chiefs or police chiefs to reside in the town. Let the school boards make the decision. This is not about one city. This is about superintendents throughout the entire state of Maine. Therefore, I will be supporting the Majority Report. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Dutremble.

Senator **DUTREMBLE:** Thank you Mr. President. I wasn't going to rise today to speak on this bill, but I think it's very important that I do stand up. We all know how this bill became this bill and how it was introduced. My constituents just voted on this in November, the same time they elected me. It was overwhelmingly that they defeated this residency change in the charter. Senator Katz stated that the charter may be antiquated and outdated. Our voters came out and they voted for the charter. They voted to deny this. As their representative in the Majority, I would have to support them and I will be voting against this bill. Thank you.

WHEREAS, the Boy Scouts of America teaches the core values of duty to God and country, personal honor, respect for the beliefs of others, volunteerism and interdependence with the environment, values that are conducive to good character, citizenship and health; and

WHEREAS, since 1910, more than 111,000,000 people have been members of the Boy Scouts of America; and

WHEREAS, the Boy Scouts of America has enhanced the lives of millions of boys and young men from every ethnic, religious and economic background, including those with disabilities and

special needs, participating in scouting programs across the United States; and

WHEREAS, each local Boy Scout Council charges each Boy Scout with performing 12 hours of community service yearly, for a total of 30,000,000 community service hours each year; and

WHEREAS, more than 1,000,000 adult volunteer leaders selflessly serve young people in their communities through organizations chartered by the Boy Scouts of America; and

WHEREAS, the Boy Scouts of America has always affirmed faith in God as foundational and essential to its purpose and mission, animated by Lord Baden-Powell's insight that "God has given us...the great Book of Nature to read"; and

WHEREAS, the Boy Scouts of America enjoys a sustained record of proven success in producing leaders for our nation who are trustworthy, loyal, helpful, friendly, courteous, kind, obedient, cheerful, thrifty, brave, clean and reverent; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-sixth Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize the Boy Scouts of America and express our appreciation for the public service it performs through its contributions to the lives of the nation's boys and young men.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Cushing.

Senator **CUSHING:** Thank you Mr. President. Ladies and gentlemen of the Senate, Chicago publisher William D. Boyce lost his way in a dense fog in London. A boy came to his aide and, after guiding them in, refused the tip, explaining that as a Scout he would not take a tip for doing a good turn. This gesture by an unknown Scout inspired a meeting with Sir. Robert Baden-Powell, the British founder of the Boy Scouts. As a result, William Boyce incorporated the Boy Scouts of America on February 8, 1910. He also created the Lone Scouts, which was merged with the Boy Scouts in 1924. Today I rise to speak to the many positive attributes offered to America's youth for the last 102 years as a result of this chance meeting. Over 111 million young men have been Boy Scouts in America. Imagine the impact in the lives of those youths who have learned the basics to advanced skills that have allowed them, in some cases, to save a life. They have been mentored by family, neighbors, and community members. Today those include over one million adults in this country. The mission of the Boy Scouts of America is to prepare young people to make ethical and moral choices over their lifetime by instilling in them the values of the Scout Oath and Scout Law. Their motto, very handily and appropriately, is Be Prepared. Their slogan is Do a Good Turn Daily. For boys between 11 and 17 years of age, or those who have earned the Cub Scouting Arrow of Light Award and are at least 10 years of age, or have completed the 5<sup>th</sup> grade and are 10 years of age, they may participate in this program. Ninety-five percent of all Boy Scouts participated in Cub Scouting at some time. As of 2012 the combined total was over one million members of the Scouting organization. One of the most significant levels of achievement

as a Scout is the advancement to Eagle Scout. I have had the privilege, as many of you have, of attending the Code of Honor Ceremony for a number of young men who have achieved this impressive rank and it truly is a special occasion. From 1912 to 2011, more than two million Boy Scouts earned the Eagle Scout rank. Included among them, I just wanted to highlight a few names, are: Neal Armstrong, the first man to step on the moon; President Gerald R. Ford; Bill Gates, founder of Microsoft; Supreme Court Justice Stephen Breyer; former U.S. Secretary of Defense and CIA Director Robert Gates; William Sessions, the former Federal Judge and Director of the FBI; in our region, former Governor Michael Dukakis. I may hazard to say that within our Body there are a number of people who have also, Mr. President, been able to complete this level of participation in a very worthwhile journey in their life. In closing, Mr. President, I'd like to share a few words of the Scout Oath as I feel it's something we, in this Body, should reflect on as we the people's business. The Scout Law urges them to be trustworthy, loyal, helpful, friendly, courteous, kind, obedient, cheerful, thrifty, brave, clean, and reverent. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator **SAVIELLO:** Thank you Mr. President. Ladies and gentlemen of the Senate, for those that don't know it, I'm one of the few Eagle Scouts that sit in this Body and also in the other chamber. If it wasn't for Scouts I really wouldn't be where I am today. In the rush of growing up in New Jersey, there were a lot of temptations out there that could have easily, as many of you known, lead me astray into what I shouldn't have been involved in and would have been spending a lot of time with my friends in the other blue instead of the green. Today I still remember being at Boy Scout Camp when a cook came down the field. Here was this distraught 11 year old in the woods, trying to figure out the volume of a tree. I know Senator Boyle would serve a smile with that, as he is. Totally frustrated with how to do the math to make that happen, this cook came up to me and said, "Let me help you." I don't even know what his name was. Because of that gentleman that became my profession, because he took the time to help me understand what I needed to do. It taught me also to respect nature and how I, too, can help make that a better place as I worked towards that. It also taught me to be the person I am, where I really do want to do, and try to do, a good deed daily. Thank you very much, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Waldo, Senator Thibodeau.

Senator **THIBODEAU:** Thank you Mr. President. Ladies and gentlemen of the Senate, I just rise to add my voice in support of the Boy Scouts of America. This organization has been a tremendous asset to our state and our nation for many many years, where they teach young men life skills, leadership, and public service. I know that each and every one of us is very proud of the Scouts that live in the districts that we represent. Most of us have had an opportunity at one point or another to attend an Eagle Scout Ceremony. We recognize just how proud the parents are when their young person obtains that rank. Certainly we want to recognize them today.

I never was in the Boy Scouts, but we had two sons that both wanted to join, in particular my eldest. I had the great honor and privilege of serving a number of years as a Boy Scout Leader for Troop 189 in Fort Kent, which is only 290 miles away from here. It truly was a privilege for me and my son. My son, years later, decided to not continue on with it. Since then I've had the real honor of attending a number of Eagle Scout Awards for young men that came into the first class with him. It is something that I always had a background and the knowledge of and something to speak to, a connection with, those young men. All through that time, going on outings on the St. Francis River and down to Washburn for overnight camp outs, it really was something that made people come together and share a moment, the stories, and instances that I'll never forget and I'm sure some of those Boy Scouts won't either. Great times helping out. Teaching people how to swim. All different backgrounds. People that didn't have a lot of money, didn't really have a whole lot of other opportunities, had the Boy Scouts to look forward to. It was always something that I really enjoyed and I think that it's a great program for some people. That's why I'm supporting it today. I just wanted to rise and talk about what a good thing I think it is for people in the state of Maine.

WE, your Memorialists, the Members of the One Hundred and Twenty-sixth Legislature of the State of Maine now assembled in the First Regular Session, most respectfully present and petition the President of the United States and the United States Congress, as follows:

WHEREAS, Nagorno-Karabakh is a landlocked region in the South Caucasus and has historically been Armenian territory, populated by an overwhelming majority of Armenians, which was severed from Armenia by the Soviet dictator Joseph Stalin in 1921 and placed under newly created Soviet Azerbaijani administration; and

WHEREAS, February 20, 1988 marked the beginning of the national liberation movement in Nagorno-Karabakh; and

WHEREAS, the Nagorno-Karabakh democracy movement inspired peoples throughout the Soviet Union to stand up against tyranny and for their rights and freedoms, helping to bring democracy to millions and contributing to world peace; and

WHEREAS, in 1989, the United States Senate expressed support for the legitimate aspirations for freedom of the people of Nagorno-Karabakh; and

WHEREAS, on September 2, 1991, in a popular expression of democracy, the elected legislature of Nagorno-Karabakh declared the creation of the Nagorno-Karabakh Republic, in full compliance with then-existing legislation and international norms; and

WHEREAS, on December 10, 1991, the people of Nagorno-Karabakh voted overwhelmingly in a referendum in favor of the independence of the region and, on January 6, 1992, the democratically elected legislature of the Nagorno-Karabakh Republic formally declared independence; and

WHEREAS, Azerbaijan launched a full-scale military aggression to suppress the national liberation movement in the Nagorno-Karabakh Republic, which ended with the signing of a cease-fire in 1994; and

WHEREAS, as one of the mediators, along with Russia and France, the United States has expressed its vision for a stable and peaceful South Caucasus, and direct United States aid to Nagorno-Karabakh represents a vital source of humanitarian relief for post-war reconstruction in the republic; and

WHEREAS, the Nagorno-Karabakh Republic has built a democratic nation, with a free-market-oriented economy and a vibrant civil society, and has held several presidential and parliamentary elections, all praised by international monitors as free and fair; now, therefore, be it

RESOLVED: That We, your Memorialists, encourage and support the Nagorno-Karabakh Republic's continuing efforts to develop as a free and independent nation in order to guarantee its citizens those rights inherent in a free and independent society; and be it further

RESOLVED: That We urge and request that the President of the United States and the United States Congress support the self-determination and democratic independence of the Nagorno-Karabakh Republic and its constructive involvement with the international community's efforts to reach a just and lasting solution to security issues in that strategically important region; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Barack H. Obama, President of the United States, to the President of the United States Senate, to the Speaker of the United States House of Representatives, to the Honorable Robert Avetisyan, Permanent Representative to the United States of the Nagorno-Karabakh Republic and to each Member of the Maine Congressional Delegation.

In the words of George Smith, who was involved in originally putting in place the blockage of the alewife passage many years ago, who spoke before the committee and said, "We made a mistake years ago." The science, the historical record, all of the information that's come to light today, there is an overwhelming preponderance of evidence that opening up the St. Croix River to the passage of alewife is the right thing to do. I ask that you all take advantage of this opportunity and join me for the sake of the groundfisheries, bait for our lobster industry, and most of all for the health of the St. Croix. I ask that you join me in voting for enactment of L.D. 72. Thank you.

This being an Emergency Measure and having received the affirmative vote of 33 Members of the Senate, with no Senators having voted in the negative, and 33 being more than two-thirds of the entire elected Membership of the Senate, was **PASSED TO BE ENACTED** and having been signed by the President, was presented by the Secretary to the Governor for his approval.

**JOINT RESOLUTION MEMORIALIZING  
THE PRESIDENT OF THE UNITED STATES  
AND THE CONGRESS OF THE UNITED STATES  
TO PROVIDE TO THE HOULTON BAND OF MALISEET  
INDIANS JUST AND EQUITABLE COMPENSATION  
COMPARABLE TO THE SETTLEMENT PROVIDED TO THE  
PENOBSCOT NATION AND THE PASSAMAQUODDY TRIBE**

WE, your Memorialists, the Members of the One Hundred and Twenty-sixth Legislature of the State of Maine now assembled in the First Regular Session, most respectfully present and petition the President of the United States and the United States Congress as follows:

WHEREAS, in the 1970s, the Passamaquoddy Tribe, the Penobscot Nation and the Houlton Band of Maliseet Indians asserted claims for possession of large areas of land in the State and for damages, alleging that the lands in question originally were transferred in violation of the Indian Trade and Intercourse Act of 1790; and

WHEREAS, the Indian claimants and the State reached certain agreements that represented a good faith effort on the part of all parties to achieve a fair and just resolution of those claims, which, in the absence of agreement, would have been pursued through the courts for many years to the ultimate detriment of the State and all its citizens, including the Indians; and

WHEREAS, in 1980, a settlement was reached and was enacted by the Maine Legislature as the Maine Revised Statutes, Title 30, chapter 601, An Act to Implement the Maine Indian Claims Settlement, and, as part of the settlement, the tribes dropped their claims to 12.5 million acres of land; and

WHEREAS, the United States Congress indicated that it finds and declares that the settlement represented a good faith effort on the part of United States Congress to provide the 3 tribes with a fair and just settlement of their land claims; and



WHEREAS, of the \$81,500,000 settlement, paid for by the Federal Government and not the State of Maine, \$40,300,000 was awarded to the Passamaquoddy Tribe and \$40,300,000 was awarded to the Penobscot Nation, while \$900,000 was awarded to the Houlton Band of Maliseet Indians; and

WHEREAS, the Houlton Band of Maliseet Indians also claims aboriginal territory in Maine, although the basis of their claim is different from that of the Passamaquoddy Tribe and Penobscot Nation, because the Maliseet Indians had not signed treaties giving up their lands in Maine, yet their lands were taken from them; and

WHEREAS, the Houlton Band of Maliseet Indians believes that the settlement did not fairly compensate the band and seeks just and equitable compensation; now, therefore, be it

RESOLVED: That We, your Memorialists, respectfully urge and request that the President of the United States and the United States Congress consider the request by the Houlton Band of Maliseet Indians to receive a just and fair level of compensation that is comparable to the compensation that was previously provided to the Passamaquoddy Tribe and Penobscot Nation; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Barack H. Obama, President of the United States, the President of the United States Senate and the Speaker of the United States House of Representatives, to each Member of the Maine Congressional Delegation and to the appropriate representatives of the Houlton Band of Maliseet Indians.
