#### READ.

**THE PRESIDENT**: The Chair recognizes the Senator from Hancock, Senator Langley.

Senator LANGLEY: Thank you, Mr. President. Men and women of the Senate, I rise today to recognize Jim Rier on the occasion of his retirement from the Department of Education and truly it's been a great honor to work with Jim over the past five years. Jim, as many of you may know, is the resident and original guru of the Essential Programs and Services Funding formula for the State of Maine. The funding formula comes under fire each and every session. There doesn't seem to be any district that is truly happy with it, which is probably the sign of a good system. In fact, in the 125<sup>th</sup> Legislature we commissioned an outside review of the funding formula which determined that, in Maine, the funding formula is an equitable way to fund the learning results. For those of us that have been on the committee, Jim will forever be known for his salmon colored graph of education spending over time in Maine. You haven't lived until you've sat through a briefing on the funding formula that often times leaves you more confused about how it all works then when you started. Jim

understands every single component of that and knows how it all really works together in support of students.

It's one thing to be known for great technical abilities and it's another to be known as a true gentleman. I've never heard a single bad word used to describe Jim Rier. His soft spoken manner is greatly appreciated by all who know him and have worked with him and for him in the Department of Education. Jim's passion for education has strong Downeast roots. He was the President of Rier Motors Company in Machias for 25 years, which gave him a ringside view of the value of education in rural Maine and shaped his passion for kids. Again, as was just noted, he served on many boards and commission. On behalf of the Education Committee members who are in the other Body and who aren't here today, we want to wish him all the best in his retirement and it's our greatest wish that we still can draw upon his knowledge on a case-by-case basis, and I called him as little as a few days ago for some help, so he's willing to do so. Thank you, Mr. President and men and women of the Senate.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Haskell.

Senator HASKELL: Thank you very much, Mr. President. Men and women of the Senate, "It's all my fault." I had an opportunity, after I served in the first time around in the House, to work for Governor Angus King and the job that I had was to be the Director of Appointments to Board and Commissions for the Governor. Least you think that this is about me. Governor King came to me one day and said. "I heard about this guy up in Machias. Really cares a lot about education. He understands the rural parts of our state. He understands about education, but he owns this car dealership. Why don't you call him, Ann, and see if you can convince him to be on the Board of Education?" That was my job. Jim and I have often smiled about this because it took more than one call, but that was my job and he finally agreed to come down and stand for confirmation as a member of the Board of Education, which was the first time that he began his public service to the Department of Education here in the State of Maine. Often, as his career changed and he became the Commissioner, there would be a really bad day in Education and he would see me in the halls and he would look at me and say. "It's all your fault." I accepted that with great pleasure because it's been such a delight to work with Mr. Rier, to know him personally, to know what it meant for him to make the commitment that he did to move from that position and to move his career from Machias down here to Augusta to serve people all across the state of Maine. He's a true public servant, a true gentleman, and I wish him all the best in his retirement.

**THE PRESIDENT**: The Chair recognizes the Senator from Washington, Senator Burns.

Senator **BURNS**: Thank you, Mr. President. Ladies and gentlemen of the Senate, I'd be remiss if I didn't stand on my feet and say a few words about Mr. Rier, as I did when we confirmed him here. As you noticed, he's from Machias and the name Rier is a very prominent name in that area and that family has done great things for that community, as has Jim Rier himself. Since I've been in the legislature anytime I've had an issue or concern with a constituent regarding education I've been able to call Mr. Rier and he's always been very, very patient to explain the facts to me. Probably had to take a little more time with me than he

would a normal legislator. I'm a little thick sometimes, but he was always patient to explain things. Again, as I mentioned before, he's a man of many talents. Many times I've taken my carburetors to Jim Rier and he's fixed them for me and got my boat back in the water. I'm going to congratulate him on his retirement and wish him well. Thank you, Mr. Rier.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator MILLETT: Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise today to speak about Jim Rier. I first met Jim over ten vears ago as a school board member when we were struggling to understand the deep dark mysteries of the 279s. Those are, for those who don't know, the annual indication of how much school funding is going to be given, sent to your district. We all marched up here to Augusta for the meeting with the man behind the curtain and I think he gave us over two hours of his time. We were relentless. We were unwilling to accept that what was sent to us was accurate, but he sat there, he answered every question calmly, patiently. Since then my respect for Mr. Rier has grown even deeper. As was mentioned earlier, he is famous for his knowledge of the Essential Programs and Services Funding Formula. He is a master of the labyrinth of inputs, weights, adjustments, spreadsheets, and, as was mentioned earlier, the infamous salmon colored graph. He is more than that. His commitment and passion to the education of our children is unbounded. His professionalism is constant. His willingness to meet with anyone about any issue is renowned. The State of Maine has been so fortunate to benefit from his gifts and his dedication and I am sure we will continue to do so. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator SAVIELLO: Thank you, Mr. President. Ladies and gentlemen of the Senate, over ten years ago I also met Jim Rier. At the time we were in the battles of EPS and transportation. I can remember specifically meeting upstairs on the fourth floor and I, unbelievably, was guite animated and guite excited about what was happening to school district number nine. Jim remained very calm and collective. Later we went through the consolidation. Not to say that it would work or wouldn't work, the proof is in the pudding, but Jim was one who carried on with our rural caucuses. We worked through those issues, again, calm, cool, and collective, and giving us, providing us, valuable information to make a good decision. He was always a person I could call, whether he was the Commissioner or not the Commissioner, and get a straight answer. He was willing to help, as we've heard, willing to meet with one person, that's all it took, to answer the question. Jim, you're a fine gentleman, even though I found out when your confirmation took place you were a former car salesman but I don't hold that against you and never will. I've enjoyed working with you. Maybe we'll have the opportunity to do so again and I know you'll enjoy your retirement. You're a fine man.

**THE PRESIDENT**: The Chair recognizes the Senator from Androscoggin, Senator Mason.

Senator **MASON**: Thank you, Mr. President. Men and women of the Senate, I just wanted to rise just for a moment to say

congratulations to Commissioner Rier on his retirement. The last time the Senator from Cumberland, Senator Alfond, and I were seatmates we were on the Education Committee together in the 125<sup>th</sup> Legislature. As a freshman member, it was daunting, to say the least, to be a Chair and to be a member of another committee. Commissioner Rier was one of those people that made serving on that committee a little bit easier by explaining how important all the formulas that we have in education are and why they are the way that they are and how to navigate through that system. He was always very generous with his time for me and for the committee. His knowledge will be missed and I would say congratulations, Commissioner Rier, on your retirement. It's well deserved, well earned, and thank you for your commitment to not only the people of the state of Maine but to the kids of the state of Maine.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Diamond.

Senator **DIAMOND**: Thank you, Mr. President. Men and women of the Senate, I just am rising to say thank you to Jim Rier. Because of my association with Sue Gendron, the former Commissioner of Education, I had a chance to work with Jim on many, many issues that pertain to my Senate District at the time and it was very, very contentious. Having been 20 years as a teacher, principal, and superintendent, I thought I understood all of that, but I found out after talking to Jim I really didn't and he did. I really appreciate his ability to take us through some real rough times in SAD 61, where high property values and low income, very many frustrated people, and rightly so, and then the RSUs. I really appreciate all Jim has done and I wish him well and thank him for his help to my constituents and to the State of Maine. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Collins.

Senator COLLINS: Thank you, Mr. President. Jim Rier was, I think, the only person in the state of Maine that fully understood the school funding formula. I was privileged to represent, at one time, half of the Town of Ogunquit when I was in the House and all of the Town of Wells. The school funding formula between these two towns, as well as the State formula for providing funding, nobody completely understood it and they all looked to me and said, "Well, Ron, certainly you understand it." I go, "Well, not really, but I know somebody that does. I heard about this guy named Jim Rier." I invited Jim Rier down to speak to us in the auditorium and it was a very warm evening and it was doubly, triply, warm inside. Everybody was kind of going at each other and Jim walked in with his calm, cool demeanor and answered all the questions and the meeting went on for a couple of hours. By the time we all left everybody seemed to be satisfied. Jim, you're going to be missed by a lot of folks in the state of Maine and, yes, I would buy a used car from you. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland. Senator Alfond.

Senator **ALFOND**: Thank you, Mr. President. Ladies and gentlemen of the Senate, it is quite an honor to get up and speak about Mr. Rier and I think you've heard a lot of great, great characteristics of Mr. Rier. He's patient. He's intelligent. He's

dedicated. He's professional. He's kind. He's always putting our children first. You can really trust Mr. Rier and you also know. with that trust, that he's following the laws. I had to dig a little deeper and so I did some research and, as we all know, Mr. Rier, before being brought down to Augusta by the good Senator from Cumberland, worked and owned a General Motors dealership. Apparently, as the story goes, Mr. Rier one day was driving a new Corvette. For those of you up in Machias, you know Six Mile Lake and the Six Mile Lake Road. It's a very curvy road between Machias and Route 9. Amazingly, this person, that now we've talked about for ten plus minutes or more, was doing 94 miles an hour in a 55. Well, the Trooper who pulled over Mr. Rier clearly hadn't been around very long because he didn't recognize Mr. Rier and he was really angry. Finally I guess he said his name a couple more times, last name, and he finally recognized Jim and he said, "You know, Jim, what the hell are you doing?" If you know Mr. Rier, he's very deadpan and he goes, "You know I didn't feel like I could sell the car without actually testing the merits of the factory specifications." Amazingly, Mr. Rier was let off without a ticket and maybe he was even driving down to Augusta. I can't thank Mr. Rier enough for everything that he's done to help children, help students, and help the State of Maine be stronger. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Aroostook, Senator Edgecomb.

Senator EDGECOMB: Thank you, Mr. President. Ladies and gentlemen of the Senate, I first met Jim Rier when I was Superintendent at Jonesport-Beals and we needed a driver's ed car. I approached him at his dealership and he graciously allowed us, each year that I was there, to have a driver training car. That's an indication of the kindheartedness of this gentleman. Then he invited me attend a board meeting, where he was Chairman of the school board in Machias. He wanted to know how we put Beals Island and Jonesport Elementary Schools together for the high school and how the funding went on that. That's probably the last time that I knew only a little bit more than Jim about school funding because, as I worked in the legislature with him. I literally had hundreds of questions and he always was able to come up with answers. I just want to take this opportunity to wish him all the best and how much the State of Maine appreciates his knowledge of that school funding formula. Thank you.

WHEREAS, over 40 national and global construction firms constituting the Construction Industry Safety Initiative, or CISI, and the Incident and Injury-Free, or IIF, Forum, as well as the National Association of Minority Contractors and Women Construction Owners and Executives USA, have joined forces to inspire everyone in the construction industry to be leaders in safety; and

WHEREAS, companies across the country have banded together to create and celebrate the 2nd United States Industry Safety Week, running this year from Sunday, May 3rd, to Saturday, May 9th; and

WHEREAS, expanding the focus of Industry Safety Week to encompass not just safety issues pertaining to the construction industry but safety issues more generally would benefit citizens of the State as well as for-profit businesses and nonprofit organizations throughout the State; now, therefore, be it

**RESOLVED:** That We, the Members of the One Hundred and Twenty-seventh Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to proclaim May 3 to May 9, 2015 Maine Safety Week and urge citizens of the State to use safe practices at the workplace, in the home and on the road; and be it further

Senator **GERZOFSKY**: Thank you, Mr. President. Ladies and gentlemen of the Senate, today's going to be brief. Today is going to be low keyed because I left my voice yesterday. I want

to remind the Chamber, and I won't speak about what happened at the other Body and break our rules but I will speak about what's happened in this Chamber and in the committee. We had two work sessions that were a positive vote at the end. We had the Commissioner of Marine Resources come in and help us work this bill and tighten it up. We also brought it into this Chamber and we voted in a unanimous fashion both times. It went under the hammer the first time, had a roll call the second time. I'm sorry that the Chief Executive has decided to use his vote, which is much stronger than mine, in dealing with this matter, but I want to make sure that we all understood what this did. It gave protection to our municipalities while trying to combat that wily little critter, the Green Crab, who are running around and eating up all of our clams. If we'd like to have clams this summer and next summer we should be doing something about it now. Obviously we aren't going to. We'll still be able to make it through as a state. The sky is not going to fall. I wanted to get up today, Mr. President, and I thank you very much for giving me that opportunity. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Sagadahoc, Senator Baker.

Senator **BAKER**: Thank you, Mr. President. What Senator Gerzofsky says is absolutely true. It did go through committee. It was unanimous. It looks like a really good bill, and it was at the time. It was not Enacted as timely as we had hoped. Since that time the conditions of the bill have been violated. The bill directs reporting out on study areas regarding the clam flats and that has been violated. There is no means of getting valid, justifiable information out of the studies. Senator DAVIS: Thank you, Mr. President. Ladies and gentlemen of the Maine State Senate, this bill will give 33 moose permits to the Maliseet and Micmac tribes in Aroostook County. It will also give 33 bear permits and it would also give 33 moose permits and 33 bear permits to disabled veterans. The bottom line of this, Mr. President, is that we simply don't have it to do. We cannot afford this. Permits given for moose hunting have gone down. Three short years ago 4,000 permits were issued. This coming year 2,740 are going to be issued. That is a steep decline. There are a whole bunch of reasons for it. The moose herd is in bad shape. The disease. The ringworm. Ticks. On and on. The bottom line is that there are only 2,740 permits being given. As I just said, a steep decline. These folks can, as all Maine citizens can, apply for one of the 2,740 permits. They are free to do so. Last year there was one application from these folks, these tribes. Just one, so I'm told. If we support this bill, and if this goes forward, that means 66 moose permits come out of the lottery. That means our fellow citizens that want to apply for one have less of a chance of getting one. As I said, these folks can apply just like the rest of us can. Thank you, Mr. President, and I would urge my colleagues to support my motion.

**THE PRESIDENT**: The Chair recognizes the Senator from Knox, Senator Miramant.

Senator **MIRAMANT**: Thank you, Mr. President. Men and women of the Senate, I ask you to join me in defeating the pending motion. Not all tribes have the same area to hunt. The Houlton Band of Maliseets and the Aroostook Band of Micmacs have small reservation areas compared to their numbers. The tribes have recognized that adopting a processed food diet has led to obesity, heart disease, and diabetes, as we have pretty much noticed all around the state. They wish to expand the pursuit of the sustenance diet that served them well for thousands of years. They have special status in certain areas of law, and it

gets cloudy sometimes, but if you join me in defeating this motion I will share my ideas of how to accomplish this goal. Thank you for your consideration and I request a division. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Penobscot, Senator Gratwick.

Senator **GRATWICK**: Thank you very much, Mr. President. Ladies and gentlemen of the Senate, I rise today urging my colleagues to defeat the motion now before us on L.D. 243. As I'm sure you know, the IFS Committee spends a great deal of time on the issue of insurance and its regulatory insight. There's oversight. There's always a balance. We're trying to get it right. If you have too much regulation the whole system here of insurance would grind to a halt in Maine. We wouldn't have carriers. The red tape would overtake us. On the other hand, if you go the other way and there is too little oversight of insurance. the rates go up and who suffers? The patient. The patients pay more. People do not get healthcare. The Bureau of Insurance currently determines what is called "reasonable" in terms of rates. I ask you: what is a reasonable rate when it comes to insurance companies? The consumer, the patient's needs, and input. We've been dealing with this for a long time and I think this bill does a good job, the Majority Report out of the committee, at making a determination of what is reasonable. The amended bill

meets the standards of our committee, of our long discussion with the Insurance Commissioner, and what it will do is it'll list reasonable rate increases by insurance companies of 2% over the rate of medical inflation per year. Two percent over so there would be adequate profit, there would be an adequate way for carriers to be covered, and, an example of this, in 2011 Anthem asked for a rate increase of 9.7%, which was legit under the current rules. We can have a rate increase up to 10% currently without triggering a Bureau of Insurance investigation. The Bureau felt that that was too much at that time, as did consumers, and they finally figured on a rate increase of not 9.7% but rather 5.2%. Maine patients, Maine consumers, saved \$3 million at that time. The issue here is affordable healthcare. We all need healthcare. We don't want to be paying so much for it. Healthcare should not be a major profit industry. We need transparency. Therefore, I ask you to vote with me. Mr. President, I ask for a roll call. Thank you, sir.

On motion by Senator **GRATWICK** of Penobscot, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT**: The Chair recognizes the Senator from Somerset, Senator Whittemore.

Senator **WHITTEMORE**: Thank you, Mr. President. Ladies and gentlemen of the Senate, the rate review process was amended in the 125<sup>th</sup> Legislature to a more efficient and better review process. This bill attempts to repeal current law, which is working very well, back to the old. The current review process by the State Insurance Bureau makes sure that insurance companies don't over charge for their products and if they do there are heavy penalties and fines, along with the return of premium dollars to the policy holders. This bill is not necessary and attempts to compound the transparency process. I ask that you support the motion on the floor. Thank you.
