We also are trying to, I hear it from the Committee Chair that this is trying to address a problem about the quality of some of the charter schools but not why we need to limit the number of them. There are traditional districts that have seen ways to maybe use the charter schools as a way that the Maine School of Science and Technology, I'm not sure, MSST up North, has done it without having to go through that whole process. There's a bunch of reasons why it'd be better not to vote for the Amendment "A" and instead Amendment "B". So let's vote this motion down and get to the one that would help. Please.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator **MILLETT**: Thank you, Mr. President. Mr. President, ladies and gentlemen, there is currently a cap of 10 on our charter schools in the state of Maine. This report simply keeps that in place. Today we had 9 applicants approved for charter schools. There's still space for another one. The committee discussion around this bill was, unfortunately, related to the fact that oversight of charter schools in the state of Maine is not what it could be, not what it should be, and not what it must be when we're talking about nearly \$20 million a year in taxpayer funds. The majority of the committee felt that until there was a robust review and accountability system for our charter schools the cap of 10 seemed reasonable. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Cyrway.

Senator **CYRWAY**: Thank you, Mr. President. Just a question to the office. If there's \$20 million to the charter schools, how much is it to the public schools?

THE PRESIDENT: The Senator from Kennebec, Senator Cyrway, has posed a question through the Chair for anyone who can answer. The Chair recognizes the Senator from Cumberland, Senator Breen.

Senator **BREEN**: Mr. President, I don't have an answer to the question that was just posed but I just want to set the Senate record straight that the wonderful school in Limestone, that's the Math and Science Academy, is a magnet school, not a charter school. Just want to make sure the record reflects that accurately. Thank you.

Senator MIRAMANT: Thank you, Mr. President. Men and women of the Senate, one of the things that came up that brought this bill into life was going to doors and meeting some of our elderly residents who really had an issue about not being able to get just a few channels. They used to be able to get that basic 12 channels, or 20, for a very small amount, \$25 or \$35. I have to always say \$25 or \$35 because the cable companies put them up every day, so you can't start with the lower number and expect that to be the one that's still there. Every day the cost is going up so that you're near \$100 just to get cable to be able to watch the same three channels you always watched your whole life. So our elderly was saying 'Please get some al la carte. So we started talking about it in EUT. Oh no, federal preemption law. The public advocate said not a problem. We came back with information from the feds. Not a problem. We can do this. We should do this. Give those folks a chance to just channel surf from their cable stations for a small amount per year and we'll try to keep that amount small and not over the top because we know where they'd like to take it. So please do not support this motion and we'll get on to the other motion. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Lawrence.

Senator LAWRENCE: Thank you, Mr. President. I appreciate the remarks from my good friend from Knox but I have to disagree. This is a bill that's probably about 30 years too late. If you receive any kind of transmission now you know that we have Amazon Prime, we have NetFlex, we have all different kinds of options out there, including DISH TV. This bill doesn't eliminate basic. They're still going to be able to offer basic to senior citizens. What this bill does is says you can't single out one industry, the cable industry, and say you must offer this array of options to everybody because you're not doing the same thing with DISH, you're not doing the same thing to everybody else. My guess is in a couple of years you're going to see cable industry change dramatically because of the competition they're facing and even though I respect the public advocate, and I thank Senator King for getting us an opinion, but a lawyer's opinion is just an opinion. Believe me, we're going to face a lawsuit over this and I can't see buying a lawsuit for something that is really 30 years beyond its time. Thank you.

This bill started out six years ago, passed both Houses here and then was vetoed. Four years ago passed both Houses, vetoed. Back again. This will prohibit the use of tanning salons for kids, people, less than 18 years old. It has an educational component. There has to be announcements there. There has to be protections to those who do use tanning salons. The major risk, as I'm sure everybody is now aware, overly aware, is various kinds of skin cancer, melanoma being the worse but also basal cell, squamous cell carcinoma, etcetera. This has been endorsed by the World Health Organization, by the American Academy of Pediatrics, the Maine Academy of Pediatrics, dermatologists universally. Remember that exposure to UV radiation. UV ravs in this instance, is equivalent a cancer risk to smoking and to asbestos. Susceptibility to both is significantly prevented by not being exposed to either smoking, asbestos, or, in this instance, tanning salons. I urge you to follow my light. Thank you, Mr. President.

Senator VITELLI: Thank you, Mr. President. I rise to speak in favor of L.D. 1324. President Lyndon Johnson declared the beginning of the war on poverty in his State of the Union Address in 1964. Since then we've seen the implementation of many programs and policies to lift people out of poverty: Social Security, food stamps, community action programs, Job Corps, VISTA, Head Start, earned income tax credit, temporary assistance to needy families, General Assistance, the Low Income Home Energy Assistance Program, Medicaid, the Homestead Exemption, the Housing Choice voucher program known as Section 8. The list of what has become known as the social safety net is long. But have these programs accomplished their purpose? Poverty is still with us. In addition, to qualify and receive the benefits of these programs it's often a cumbersome, sometimes embarrassing, and bureaucratic process. Do the way these programs function discourage people from working? Do they foster self-sufficiency and individual initiative? Or do they trap people in poverty? Is there, in fact, a better way to meet the basic needs of individuals and families? These are the questions we should be asking ourselves now. These are the questions that this bill's Committee to Study the Feasibility of Creating Basic Income Security would address. The committee would be tasked with examining options to better provide basic income security to Maine people, including through the development of a Direct Cash Payment System. The members of the committee would come from various legislative committees, including Labor and Housing; Health and Human Services; Taxation; Innovation, Development, Economic Advancement and Business; along with people who have lived and experienced both earning low wages and receiving public benefits in our current system, employers, someone from higher education, trade unions, and from the Governor's Office of Innovation and the Future. It has often been said that the best anti-poverty program is a good job and, while in an ideal world, a static world, that might work, in reality there are times when individual and economic circumstances where that solution, of getting people jobs as a solution to poverty, is not appropriate or sufficient. A basic income, on the other hand, could provide the floor on which people could build economic security, adding employment or self-employment to meet their financial needs, rather than face the cliff that often awaits people when they try to get ahead by increasing their earnings but end up losing benefits from our so-called safety net. A basic income is an idea worth exploring as an alternative path out of poverty. It

is time now and I urge you to support this initiative. Thank you, Mr. President.

Senator BELLOWS: Thank you, Mr. President. I rise to answer my colleague from Kennebec County's question. I want to specify, this is a study. It's a Resolve to Establish the Committee to Study the Feasibility of Creating Basic Income Security. The reference to the cash payment is not intended to suggest currency but rather that this would be a universal basic income, very similar to what Alaska provides to its citizens, in lieu of food stamps or coupons or other benefits would be an income to all the citizens of Maine, should it go forward. But this is simply studving. The reason this studv is so important is since President Lyndon Johnson declared the war on poverty in 1964 we've seen the implementation of many diverse, and also sometimes fragmented, programs with some significant administrative costs. This study would take a look at replacing or enhancing government efficiency and limiting government bureaucracy by moving forward with this study.

The Chair noted the absence of the Senator from Washington, Senator **MOORE**, and further excused the same Senator from today's Roll Call votes.

Ladies and gentlemen of the Senate, I rise to ask you to support the pending motion and to clarify that this bill, as amended, does not mandate project labor agreements but is permissive, allowing state, municipal, and school entities to employ project labor agreements should it prove the best option in their evaluation of the specific project and to remind all of you project labor agreements are also called project stabilization agreements. They can greatly increase the stability and efficiency of long-term and complex construction projects, providing benefits in terms of wages, benefits, working conditions, safety, diversity and inclusion issues, and conflict resolution issues. It can have multiple and significant benefits to the public entity and, at the same time, this bill simply gives state, municipal, and school entities another tool in their construction projects to utilize should they see fit based upon the events on the ground. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Cyrway.

Senator **CYRWAY**: Thank you, Mr. President and ladies and gentlemen of the Senate. Just had a question: couldn't they do this already and also wouldn't this raise the cost tremendously on a highway funds and also not to mention school funds as well? That's the question I have to the Floor, to the President.

THE PRESIDENT: The Senator from Kennebec, Senator Cyrway, posed a series of questions through the Chair. The Chair recognizes the Senator from Kennebec, Senator Bellows.

Senator BELLOWS: Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise a second time only to answer the questions posed through the Chair. First and foremost, it's important to recognize that project labor agreements were banned for a brief time in the state between 2011 and 2015, leaving a lack of clarity about the permissiveness of PLAs under the law, particularly for municipal and school entities. There was at least one project where a municipality sought to engage a project labor agreement and was unclear about the direction from the State. So this is permissive. It's explicit in its permissiveness and it is necessary because of the lack of clarity in the law and the prior law. So this is, in part, cleaning up statute. Secondarily, I would say that it's important that this bill does not carry a fiscal note and the reason for that is in some cases a project labor agreement may save the project money, and this is best, the reason it is permissive is it's left to the discussion of the entity overseeing the project. I do trust that the Maine Department of Transportation and other entities will carefully safeguard our funds and use this when it will save the taxpayers money and benefit the project. That's, again, it's a permissive bill to allow it where it will benefit the taxpayers, our communities, workers, and businesses alike.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Guerin.

Senator **GUERIN**: Thank you, Mr. President. Mr. President, ladies and gentlemen of the Senate, I wanted to also address the questions raised by Senator Cyrway.
