**SENATOR BURNS:** Thank you, Mr. President. Good morning, ladies and gentlemen. We have a continuing theme that I hear here about asking for wisdom and I think it's a very good theme. I particularly recall a few days ago Dr. Gratiwick's brief history lesson that he gave us in the prayer and I want to follow up on that just a little bit. I really appreciated that, so please bear with me for a second. I want to read excerpts out of a speech that Benjamin Franklin gave to the First Constitutional Convention after a long stalemate. I'll be very brief here.

Mr. President, the small progress we have made after four or five weeks close attendance and continual reasoning with each other, our different sentiments on almost every question, several of the last producing as many no's as yeas, is, methinks in melancholy, proof of the imperfection of human understanding. We, indeed, seem to feel our own want of political wisdom since we have been running about in search of it. In this situation of this assembly, groping as we are in the dark to find political truth, scarce able to distinguish it when presented to us, how has it happened, sir, that we have not hitherto once thought of humbly applying to the Father of Lights to illuminate our understanding? In beginning of the contest with Great Britain, when we were sensible of danger, we had daily prayer in this room for divine protection. Our prayers, sir, were heard and they were graciously answered. All of us that were engaged in the struggle must have observed frequent instances of superintending providence in our favor. I have lived, sir, a long time and the longer I live the more convincing proof I see of this truth, that God governs in the affairs of men. If a sparrow cannot fall to the ground without His notice, it is probable that an empire cannot rise without His aid. We have been assured, sir, in the sacred writing that except that the Lord build a house they labor in vain that build it. I firmly believe this and I also believe without His concurring aid we shall succeed in this political building no better than the builders of Babel. We shall be divided by our little partial local interests, our projects will be confounded and we, ourselves, shall become a reproach and a bye word down to future ages. What is worse, mankind may hereafter, from this unfortunate incident, despair of establishing government by human wisdom and leave it to chance, war, and conquests. I therefore beg leave to move that henceforth prayers imploring the assistance of heaven and its blessings on our deliberations be held in this assembly every morning before we proceed in business, that one or more clergy of this city be requested to officiate in that service.

Thankfully we continue on in that vein. I just ask you to bow your hearts and your heads in prayer please. Father, in heaven, we just thank You for the opportunity to come here before You.

Thank You that You have sent us here. Father, we do ask this morning for the wisdom, patience, and guidance that only You can provide to us. We pray for our President. We pray for our Governor. We pray for the House of Representatives. We pray for the men and women that You have called to serve in this Body. Father, too, this morning, we pray for peace and comfort and guidance for all those in Charleston, South Carolina who have suffered such great loss. Father, give them the grace that they need to get through this tragedy and help their brethren come together with them. Father, I thank You for these things. In His name, Jesus Christ, I pray. Amen.

Dear Honorable Members of the 127th Legislature:

Under the authority vested in me by Article IV, Part Third, Section 2-A of the Constitution of the State of Maine, I am hereby executing line-item vetoes of a number of allocations contained within LD 1019, "An Act Making Unified Appropriations and Allocations for the Expenditures of State Government, General

Fund and Other Funds and Changing Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 2015, June 30, 2016 and June 30, 2017." These vetoes are included on the attached sheet.

Mainers want a budget that can be used as a blueprint for prosperity for our great state. Instead, legislators delayed the process for five months, then presented a business-as-usual budget patched together at the last minute. Secretive, late-night decisions made under the cover of darkness and behind locked doors have led to a budget based on the best interests of a handful of politicians, not what is best for all the people of Maine.

As the drug epidemic continues to ravage our state—with nearly 1,000 babies born each year addicted to drugs and 208 Mainers dead of drug overdoses in 2014—it is appalling that politicians would rather fund their own pet projects than prevent ruthless out-of-state drug traffickers from infiltrating our communities and killing our children.

Because politicians are so busy capitulating to special interests and kowtowing to social-justice activists prowling the halls of the State House, they ignore our elderly, disabled and mentally ill citizens. These Mainers are rightfully entitled to healthcare, but they are left sitting for years on waitlists without basic services. Politicians have submitted a budget that provides only \$6 million toward the waitlist, when the true need is another \$40 million—which I allocated in my original budget.

They also rejected my plan to overhaul the state's General Assistance program, which encouraged cities like Portland to spend more of local taxpayers' money so they could get more funding from the state. Politicians watered down General Assistance reform to reward cities that insist on giving local taxpayers' money to illegal aliens.

Clearly, the health and public safety of Mainers was not a priority of the 127<sup>th</sup> Legislature. Instead, Augusta politicians snuck in a \$4 million "Christmas tree" adorned with piggy projects for legislators, such as buying federal land in Kittery, building an unneeded "Francis Perkins Homestead," paying for a commission disguised as initiative to end hunger and creating entirely new projects.

Maine taxpayers deserve to know how every dollar of their money is being spent, but this "Christmas tree" with gifts for certain legislators was presented with no public notice or input. This is exactly the kind of back-room politics the people of Maine sent me here to prevent.

Too many Augusta politicians are willing to disenfranchise the Maine people in exchange for feeding off the public trough, even at the expense of our most vulnerable and needy citizens. The days of pork-barrel spending—and Christmas in June—must end. At the very least, I will bring these politicians' actions to light for Mainers to see.

My administration has been working for five years to create an efficient government, but that is an oxymoron to Augusta politicians. They must put aside their petty political agendas and put the hard-working people of Maine first. Mainers deserve to have a say in how their money is being used, and they should be included in the budgeting process. I took my budget directly to the people of Maine, holding public town hall meetings up and down the state.

Until Augusta politicians bring transparency to their budget process, I will continue to veto legislation that is not in the best interest of all Mainers. I ask each one of you to stand up for the Maine people and support these vetoes.

Dear Honorable Members of the 127th Legislature:

Under the authority vested in me by Article IV, Part Third, Section 2-A of the Constitution of the State of Maine, I am hereby executing line-item vetoes of a number of allocations contained within LD 1080, "An Act Making Unified Appropriations and Allocations for the Expenditures of State Government, Highway Fund and Other Funds and Changing Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 2016 and June 30, 2017."

A sound transportation infrastructure, especially roads and bridges, is critical to a good quality of life and economic prosperity. Many in the Legislature have asked me to raise the gas tax to fund these improvements – but there is another way.

My Administration has adopted a policy of stretching the transportation dollar to ensure funding for the basics – quality roads, safe bridges, and prosperous ports. No longer do we spend millions of dollars planning projects that we know we will never build. So too, we must scrutinize the Highway Fund Budget to ensure that we are directing as much funding as possible to core infrastructure. Paying per diems for legislators to meet in the summer, funding cold case squads or computer crimes do not result in better roads and bridges. Moreover, the Constitution of the State of Maine mandates that highway fund dollars be spent solely on highway fund activities. I took an oath to uphold the Constitution and I intend to honor that oath.

Until Augusta politicians allow us to focus limited resources on the most important transportation needs, I will continue to veto legislation that is not in the best interest of all Mainers. I ask each one of you to stand up for the Maine people and support these vetoes.

**THE PRESIDENT PRO TEMPORE:** The Chair recognizes the Senator from Androscoggin, Senator Libby.

Senator **LIBBY:** Thank you, Mr. President. Men and women of the Senate, I rise today to address this bill. This is a bill that I submitted in January to continue the Maine New Markets Capital Investment Program. I also intend to offer an amendment to this bill today, but first I'd like to address a few things. This legislation would have extended the New Markets Capital Investment Program, a relatively new tax credit program that during the three years of its life has been largely responsible for saving about 350 good union jobs at the Woodland Pulp Mill in Washington County and another 80 new jobs at the St. Croix Tissue Mill in Baileyville. It will keep the pulp mill operating for long into the future. It was also partially responsible for creating 60 new jobs at a wound dressing plant on the former Brunswick Naval Air Station, among many other significant projects that were more or less successes. I'd also include the Quoddy Shoe Company in Lewiston/Auburn that's once again employing shoemakers in that community. This program is also used as a last ditch effort to keep the former Great Northern Paper Mill from going under, an effort that public officials in both parties in this Legislature and in the Chief Executive's office have been working on that project for over 20 years. The financial transactions that were used in this deal with Great Northern were, to say the very least, complicated and, in light of a long investigation, appeared to many of us to be little more than financial tricks that were used to claim a tax credit that was not earned. Nevertheless, the New Markets Program did

help manage to keep the mill operating for several months, perhaps longer than anyone expected. Salaries were earned in the East Millinocket area for about 18 months. With all certainty, those jobs wouldn't have been there without the New Markets credit. I'm sure none of you have missed the publicity about the New Markets Program, especially about the Great Northern deal involving Cate Street Capital. I also know that no one likes to be called a naive legislator.

Many of us have learned a lot about this program in the last six months and many of us believe we have got a good idea on several significant reforms to the program to ensure that these tax credits go to parties that are committed to making new jobs in the state of Maine. We also feel that the package of reforms we've developed would absolutely prevent another Cate Street scandal from happening in the future. Of course the debate over this program, which is being conducted in the press and in internet blogs and in the halls of this legislature, really hasn't focused on fixing the program. Rather, various interests have taken this opportunity to rail against the alleged scam artists to vent their frustration about the top 1%, to vent their frustration about corporate welfare fraud, and also to use this as an opportunity to gain political advantage over members of the other political party. While this may all be expected and understandable, this kind of rhetoric does nothing to fix this program, which has had a significant impact on many parts of rural Maine.

As I said, I intended to offer an amendment that would, in the end, actually not extend the program into the future but would have included several significant reforms that would have prevented another Cate Street Capital from doing that same thing again. In the end, I'm not going to offer that amendment. After many discussions with members of both houses and both parties and other interests, I'm feeling like there's less interest in reaching a reasonable compromise or in passing good policy. I don't want this bill to be used for any further demagoguery or partisan advantage. I think the best course of action, Mr. President, then is to commit this bill and all its accompanying papers to the Committee on Taxation. That's my formal motion. Thank you very much.

Senator **LIBBY** of Androscoggin moved the Bill and accompanying papers be **COMMITTED** to the Committee on **TAXATION**.

**THE PRESIDENT PRO TEMPORE:** The Chair recognizes the Senator from Penobscot, Senator Cushing.

Senator **CUSHING:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise today to encourage your support of the pending motion. I thank my colleagues, both from Androscoggin County, who have worked on this and the Chair of the Labor, Commerce, Research and Economic Development Committee here in this Body, the Senator from Scarborough, who worked very diligently. I think this may be an example, ladies and gentlemen, of both the best and the worst aspects of what we face in policy making here, the best showing a thoughtful approach, of a bi-partisan nature, to addressing an issue that has become very public and very thorny, but also, Mr. President, an issue that has provided value to many companies in rural Maine; providing good paying jobs, providing opportunities for other small businesses to grow in support of that. I think, Mr. President, that the sad part of this, in my opinion, is that good people on both sides of the aisle, not for partisan political reasons but more for

larger reasons outside of this Body, have been vilified for taking what they thought were forthright votes to support a program that was benefiting the citizens of our state. I think, Mr. President, as we reflect on this and some of the other bumps of this session, we recognize that we truly do our best work when we work together. I want to offer my personal thanks to both Senator Libby and to Senator Volk for their tremendous efforts on behalf of this, in helping some of these organizations that are working for the benefit of rural Maine jobs and opportunities for our state. Thank you, Mr. President.
