The Town of Falmouth, which is celebrating its 300th Anniversary. In 1632, Arthur Mackworth was the first European settler in the area. Falmouth was founded in 1718 and included what is now Portland, Westbrook, South Portland and Cape Elizabeth. In 1775, the town was burned by the British in retaliation for its boycott of British goods and, in return, sent a group of soldiers south to fight in the War of Independence. In the 1700s, the town's economy had been based on fishing and lumber for shipbuilding but by the early 1800s had transitioned to fishing and farming. In the early 1900s, trolley service to and from Portland allowed Falmouth to flourish as a tourist destination, with travelers enjoying the town's beaches and shops. The town's economy boomed during the Second World War, when the United States Navy's destroyer fleet was stationed in Falmouth's large anchorage. Since the 1950s, Falmouth has grown due to the automobile and the town's proximity to Portland and has increased its commitment to high-quality public education, land conservation and excellence in town governance. Senator **DESCHAMBAULT:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I am very honored and pleased today to talk about someone in my department in Biddeford that has done exemplary work throughout his career. Captain Melancon started in 1975 under the government program CETA at the Biddeford Fire Department and this was a civil service job. He was hired as a medic and became an EMT within six months of being hired. He moved to the rank of Lieutenant eight years later, and was promoted to Captain in 1988. He has retired recently after 42 years of service. I would like to mention a few things. First of all, this came to my attention by the employees, the people that he worked with, that really wanted to show what kind of man he is. He earned the Silver Star for Bravery from the American Police Hall of Fame. Now I want to tell you, some of you might remember, I remember, I am old enough to remember, that you didn't call 9-1-1. You had a street box and you pulled the box and that's when the firefighters knew there was a fire somewhere. Well that happened, and he shows up and so does everybody else thinking there's going to be a fire. Instead they respond with all of their gear for firefighting but when they arrive they found that four children had fallen through the ice. The responders didn't have an ice rescue gear and so they used their ladders to crawl over the ice. Captain Melancon broke through the ice and he himself at that moment thought he will not make it either. But he managed to keep on going and Captain Melancon and his crew rescued two children. However, two others died. He had a commendation for saving a child from a fire. Captain Melancon and Lieutenant Thorpe entered a home in Saco and found that there was a child trapped on the second floor. They made their way to the second floor under extreme heat and smoke conditions and began a systematic search and located the lifeless body. They removed the victim to the waiting ambulance, worked on him and the child was resuscitated successfully and fully recovered. This one happened five years ago, I recall very visibly, an act of heroism. Captain Melancon and his crew responded to a report of multiple people being shot in their apartment building during blizzard conditions. It was quite of a hectic night. It was the landlord who had entered the home and had shot some victims. No one knew how serious that was and I well imagine fire trucks, police cars what have you. Captain Melancon put himself in the line of fire to help remove the female gunshot victim, the mother, into the waiting ambulance. She was transported to the trauma center in Portland. Unfortunately two

people in the home were killed. Over the years Captain Melancon has received numerous citations and successful rescues in complicated emergencies that were challenging the normal call of duty. You know you read about these things in the paper. Those are the headlines. You don't hear of what happens to the officers or the firefighters, our first responders. You just know what happened and you don't know about these acts of bravery. They go home and the spouses are heroes also. He has been married for forty years. His wife is an RN at Southern Maine Medical Center so she probably sees people that he has helped save himself. They have two children: a son who graduated from UNE and is going for a Master's in Business, and a daughter from USM who is a fourth grade teacher married to a firefighter. I would like all of you to join me in welcoming them and thanking them for their service. Both for Captain Melancon and his family. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Dill.

Senator **DILL:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I want to speak briefly on LD 1747 which enjoys a broad support and will provide necessary assistance and peace of mind for the residences in seven assisted living facilities across the State. These seven facilities provide support and services to seniors who are able to live independently but still require some assistance such as medication management. They provide less intensive support than private non-medical institutions, PNMI's, and much less the nursing homes. They are also significantly less expensive than these options. The state funds these services located in Augusta, Bangor, Camden, Millinocket, Portland, Saco and Sanford through individual contracts with the provider agencies. Because the State separately negotiates each of the contracts, some facilities are able to make ends meet while others are steadily losing money. At least four facilities are operating at a significant loss: Bangor, Millinocket, Camden and Sanford. For Penquis, which oversees the first three of these

facilities, these losses are unsustainable. In the event that Penquis discontinues assisted living services, housings for eighty-seven individuals will be in jeopardy. Penquis has operated a loss since 2009, requiring Penquis to subsidize the flat state funding with approximately \$600,000 over the last ten year period. Even after a one time emergency additional funding of \$200,000 during the current two year period which ends in June. Clearly this is an unsustainable investment for Penquis. Penquis has spent the last year working with staff members reviewing fiscal and operational practices to discover efficiencies that would allow delivery of services within a contracted, budgeted amount. The Department's review concluded that Penquis is as efficient as possible. A current review of the residents show that we have four private pay, or that there are four private pay residents, twenty-one who receive MaineCare, and fifty-six who are not eligible for MaineCare. Thank you, Mr. President. Please follow my light.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. I rise in opposition to my own motion since we are debating on having a roll call. You know this is every now and again you get a bill that comes before you that has a wonderful title, yet you hate to vote against the bill just on the bases of the title alone. But you delve into the bill and you recognize that there are some problems with it. Some of the problems with this bill that I just like to highlight is some unanswered questions, questions that I never felt and many of us in the Committee never felt that we got sufficient answers on. One of those questions is where does the number \$500,000 come from. There is a \$500,000 ask for these facilities. That didn't seem to be based on any objective measure of why half a million dollars, it just was the number of the ask. Other questions were, you know, these aren't the only facilities that qualify for this. Why these particular facilities? Why are they singled out for these funds when other facilities that fall under the same criteria wouldn't be receiving any of this? I think we all share the goal. I think everyone in this Chamber shares the goal: wanting to protect our long term continuum of care for our seniors and we have many bills that come through this chamber readily seeking to do that. Many of those bills often see unanimous reports out of Committee. I don't think that this bill, I think there are a lot of arbitrary decisions that are made in this bill and I think that there will be other opportunities that we should be taking to makes sure we are protecting our long term continuum of care. Thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Gratwick.

Senator **GRATWICK:** Thank you very much, Mr. President. Ladies and gentlemen, I hadn't intended to speak on this but I have been through the facility in Bangor. It's very well run, but right now they are not making ends meet. They are running, they are working on spending down their endowment. This is a group that has been supporting this facility for a very long time. They'll have very little money left. I think that the questions raised by the good Senator are reasonable. Why \$500,000? Because we have to start someplace. We have to be able to have a better accounting for this. I think it will come forward next year, but I want to be sure that these people have some place to go. And

second, why these particular ones? I think that the group that has been working on this chose those as being the ones most in danger at this time. I feel that this is absolutely essential. This is a pennywise and pound foolish. We can most assuredly vote for this. On the other hand, we are going to be spending a lot more money in the future. It is our obligation to be caring for our seniors. Thank you, Mr. President. Ladies and gentlemen, I urge you to follow Senator Dill's and my light. Thank you.
