H.P. 1509

JOINT RESOLUTION SUPPORTING THE DESIGNATION OF THE YORK RIVER AND ITS MAJOR TRIBUTARIES AS A PARTNERSHIP WILD AND SCENIC RIVER IN THE NATIONAL WILD AND SCENIC RIVERS SYSTEM

WHEREAS, the York River, located in southern Maine, with watershed lands in the towns of Eliot, Kittery, South Berwick and York, was evaluated for inclusion in the National Wild and Scenic Rivers System; and

WHEREAS, the National Wild and Scenic Rivers System was established in 1968 to protect rivers with outstanding values for the benefit and enjoyment of present and future generations, and rivers that flow through private lands and are eligible for designation are included in the national system as "partnership" rivers, maintaining all local control of land and river use, subject to existing local and state laws; and

WHEREAS, the York River's water quality, ecological and cultural resources and many outstanding values with national and regional significance make it eligible for Partnership Wild and Scenic River designation; its healthy river habitats and salt marshes support important Gulf of Maine species and improve resilience to climate change impacts; and its vibrant working waterfront contributes to the economy and to community character; and

WHEREAS, the 4 watershed communities strongly support pursuing inclusion of the York River in the National Wild and Scenic Rivers System as a partnership river and accepting the York River Watershed Stewardship Plan, as evidenced by affirmative votes by the people of Eliot and York on November 6, 2018 and adoption of resolutions by town councils in Kittery and South Berwick on November 26, 2018 and December 11, 2018, respectively; and

WHEREAS, with the York River being designated as a partnership river, the 4 York River watershed communities will have access to financial and technical assistance from the National Park Service and will be able to proactively and collaboratively address issues and priorities for the benefit of the watershed region, the State of Maine and the Gulf of Maine environment; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-ninth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to recognize the eligibility and suitability of the York River and its tributaries for designation as a Partnership Wild and Scenic River in the National Wild and Scenic Rivers System and acknowledge the strong community support for designation; and be it further

RESOLVED: That We recognize the benefits and opportunities of Partnership Wild and Scenic River designation to better enable watershed communities to work collaboratively to address important river preservation issues for the long-term benefit of current and future generations of Maine citizens.

Joint Resolutions in Memoriam:

WHEREAS, the Legislature has learned with deep regret of the death of:

(1-6) Claude Dumond, of New Canada. Mr. Dumond, a veteran of World War II and a farmer, was hired in 1954 to serve as town manager of New Canada, a position he held for 32 years. In 1958, he became a full-time town manager for Eagle Lake and in 1968 started his 18-year career as town manager of Fort Kent, serving until his retirement in 1986. Of his many accomplishments in town government, his greatest was the flood prevention dikes in Fort Kent built by the United States Army Corps of Engineers. In 1986, he was named Manager of the Year by the Maine Town and City Manager's Association. He was a past president of the Aroostook County Town and City Managers Association and served on the Maine Municipal Association's legislative committee and various other boards. He was a 73-year devoted member, finance officer and Post Commander of the American Legion Post 133 in Fort Kent. He was a past president of the Fort Kent Rotary Club and a State Court Trustee and a past Chief Ranger of St. Anthony's Ct. of the Catholic Order of Foresters in Wallagrass and was named Forester of the Year in 1989. He was a past Faithful Pilot in the 4th Degree Knights of Columbus, of which he was a member for over 70 years. He was a communicant of St. Joseph Catholic Church in Soldier Pond, where he was a lifelong member of the choir group. He served as president of the parish council, lector and eucharistic minister. In 1996, the Greater Fort Kent Area Chamber of Commerce named him the Citizen of the Year, and he received a Maine Healthcare Association 2014 Remember ME Achievement Award. Mr. Dumond will be long remembered and sadly missed by his family and friends and all those whose lives he touched; HLS 856

JOINT RESOLUTION MEMORIALIZING THE NATIONAL OCEANIC AND ATMOSPHERIC ADMINISTRATION TO CONSIDER THE SAFETY OF THE MEN AND WOMEN WORKING IN MAINE'S LOBSTER INDUSTRY

WE, your Memorialists, the Members of the One Hundred and Twenty-ninth Legislature of the State of Maine now assembled in the Second Regular Session, most respectfully present and petition the National Oceanic and Atmospheric Administration as follows:

WHEREAS, the men and women who work in the Maine lobster industry are constantly at risk of injury and loss of life; and

WHEREAS, the safety of these workers must be the primary concern of all government agencies that regulate the ocean; and

WHEREAS, the Maine lobster industry has made many changes to help protect the right whale; and

WHEREAS, no right whales have been killed by Maine lobster gear and deaths in 2019 were predominantly by ship strikes in Canadian waters or in one instance due to Canadian fishing gear entanglements; and

WHEREAS, the National Oceanic and Atmospheric Administration has stated that right whales likely are not traveling in the waters in which Maine lobster fishing occurs; and

WHEREAS, the proposal to modify the existing Atlantic Large Whale Take Reduction Plan developed by the National Oceanic and Atmospheric Administration will not save any right whales in Maine waters but will put the lives of workers in the Maine lobster industry at great risk; and

WHEREAS, the lobster industry is one of Maine's core traditional natural resource industries and has employed generations of Maine's citizens; and

WHEREAS, the lobster industry contributes \$1.5 billion to Maine's economy and entire communities depend upon the work that the lobster industry provides; now, therefore, be it

RESOLVED: That We, your Memorialists, respectfully urge and request that the National Oceanic and Atmospheric Administration take the lives of the men and women of the Maine lobster industry into account in the agency's decision making and understand that the agency's proposed changes to the Atlantic Large Whale Take Reduction Plan will not save one right whale in Maine waters but will put many human lives in danger; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Donald J. Trump, President of the United States, to the President of the United States Senate, to the Speaker of the United States House of Representatives, to Dr. Neil Jacobs, acting Under Secretary of Commerce for Oceans and Atmosphere, and to each Member of the Maine Congressional Delegation.
