**An Act to Expand Access to Certified Residential Medication Aide Training**

1       **Be it enacted by the People of the State of Maine as follows:**

2           **Sec. 1. 22 MRSA §42, sub-§1-A,** as amended by PL 2025, c. 237, §1, is further  
3           amended to read:

4           **1-A. Administration of medication.** The administration of medication in assisted  
5           housing programs, residential care facilities, ~~drug treatment centers~~, day care facilities,  
6           children's homes and nursery schools and nonnursing level intermediate care facilities for  
7           persons with intellectual disabilities must be in accordance with rules established by the  
8           department. In other facilities licensed or approved by the department, excluding those  
9           facilities licensed under section 1811, other than nonnursing level intermediate care  
10          facilities for persons with intellectual disabilities, the department may establish rules for  
11          the administration of medication as it considers necessary. In establishing rules for each  
12          type of facility, the department shall consider, among other factors, the general health of  
13          the persons likely to receive medication, the number of persons served by the facility and  
14          the number of persons employed at the facility who might be involved in the administration  
15          of medication. Any rules for the administration of medication must be established in  
16          accordance with Title 5, chapter 375.

17           **Sec. 2. 22 MRSA §42, sub-§1-B** is enacted to read:

18           **1-B. Certified residential medication aide certificate.** The department shall issue a  
19           certificate to an individual who has successfully completed a department-approved  
20           certified residential medication aide course that meets the medication administration  
21           training requirements for unlicensed assistive personnel under Title 32, section 2102,  
22           subsection 11 in accordance with rules established by the department for facilities under  
23           subsection 1-A. The course must be designed to ensure competency in the safe  
24           administration of medications by individuals who are not licensed health care  
25           professionals. The department shall review the course curriculum at least once every 5  
26           years, or more frequently as determined necessary by the commissioner, to ensure  
27           alignment with current clinical standards, safety practices and the needs of residents and  
28           clients in facilities under subsection 1-A. The department shall develop rules for the  
29           certification of certified residential medication aides and certified residential medication  
30           aide instructors and may establish and collect reasonable certification fees and sanction  
31           fees from individuals as well as from instructors. Fees must be set by rule and may range  
32           from \$25 to \$100 per individual or instructor, per course, and be valid for a 2-year  
33           certification period, as specified by rule. Fees collected pursuant to this section must be  
34           deposited in a dedicated special revenue account to support certified residential medication  
35           aide certification activities and the ongoing oversight and maintenance of the curriculum.  
36           Rules adopted pursuant to this subsection are routine technical rules as defined in Title 5,  
37           chapter 375, subchapter 2-A.

38           **SUMMARY**

39           This bill directs the Department of Health and Human Services to issue a certificate to  
40           an individual who has successfully completed a department-approved certified residential  
41           medication aide course that meets the medication administration training requirements for  
42           unlicensed assistive personnel in accordance with rules established by the department for  
43           certain facilities. The bill also requires the department to review the course curriculum at

1       least every 5 years and allows the department to establish by rule certification fees and  
2       sanction fees for certified residential medication aides and instructors.
