1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 12 MRSA §541-A**, as amended by PL 2021, c. 398, Pt. YYY, §1, is further
3 amended to read:

4 **§541-A. Division of Geology, Natural Areas and Coastal Resources**

5 The Division of Geology, Natural Areas and Coastal Resources is established within
6 the Department of Agriculture, Conservation and Forestry and is administered by the
7 commissioner. The division consists of the Maine Geological Survey, referred to in this
8 chapter as "the "survey," and the Natural Areas Program."

9 **Sec. 2. 12 MRSA §544**, as amended by PL 2011, c. 655, Pt. II, §3 and affected by

9 The Bureau of Resource Management is established within the Department of Inland
10 Fisheries and Wildlife. The bureau is equal in organizational level and status with other
11 major organizational units within the department or its successors. The bureau is
12 administered by a director of wildlife and a director of fisheries and hatcheries who ~~is~~ are
13 immediately responsible to the deputy commissioner. The ~~director possesses~~ directors
14 possess full authority and responsibility for administering all the powers and duties of the
15 bureau within their respective divisions, subject to the direction of the commissioner and
16 except as otherwise provided by statute. The responsibilities of the bureau include, but are
17 not limited to:

18 **1. Wildlife conservation and management.** The conservation and management of
19 the wildlife resources in the State for their preservation, protection, enhancement and use;

20 **2. Fisheries conservation and management.** The conservation and management of
21 the inland fisheries resources in the public waters of the State for their preservation,
22 protection, enhancement and use;

23 **3. Propagation of fish.** The propagation of fish for the effective conservation and
24 management of inland fisheries resources in public waters of the State;

25 **4. Habitat conservation and management.** The conservation and management of
26 habitat for the protection, preservation, enhancement and use of inland fisheries and
27 wildlife resources, plants and natural areas;

28 **5. Wildlife sanctuaries; wildlife management areas.** The management of wildlife
29 sanctuaries and wildlife management areas for the State as designated in chapter 925;

30 **6. Data collection.** The collection of data for the effective conservation and
31 management of inland fisheries and wildlife resources, plants and natural areas;

32 **7. Research and monitoring.** Research and monitoring activities for the effective
33 conservation and management of inland fisheries and wildlife resources, plants and natural
34 areas;

35 **8. Animal damage control.** The coordination of animal damage control functions
36 throughout the State, including supplemental assistance for the control of coyotes and other
37 nuisance wildlife that exceeds normal funding and staffing levels within the department;

38 **9. Rules.** The development of rules governing the effective conservation and
39 management of the inland fisheries and wildlife resources of the State;

40 **10. Land acquisition.** The acquisition and development of land for the protection,
41 preservation and enhancement of inland fisheries and wildlife resources, plants and natural
42 areas; and

1 **11. Resource planning.** The coordination with other resource management staff to
2 develop both short-term and long-term plans for the preservation, protection, enhancement
3 and use of inland fisheries and wildlife resources, plants and natural areas. The bureau shall
4 undertake activities as directed by the commissioner; and

5 **12. Invasive species management.** The management of invasive species for the
6 protection of inland fisheries and wildlife resources, plants and natural areas.

41 organization, state agency or other entity to undertake inventory of and research about
42 native plants and natural areas.

1 Funds in the fund, including earnings, may not be deposited in the General Fund or any

19 **1. Standards.** The commissioner shall recommend a species of fish or wildlife to be
20 listed as endangered or threatened whenever the commissioner finds one of the following
21 to exist:

22 A. The present or threatened destruction, modification or curtailment of its habitat or
23 range;

24 B. Overutilization for commercial, sporting, scientific, educational or other purposes;

25 C. Disease or predation;

26 D. Inadequacy of existing regulatory mechanisms; or

27 E. Other natural or human-made factors affecting its continued existence within the
28 State.

29 **2. Commissioner's duties.** In recommending a species of fish or wildlife to be listed
30 as endangered or threatened, the commissioner shall:

31 A. Make use of the best scientific, commercial and other data available;

32 B. Consult, as appropriate, with federal agencies, other interested state agencies, other
33 states having a common interest in the species of fish or wildlife and interested persons
34 and organizations;

1 C. Maintain a list of all species of fish or wildlife that the Legislature has designated
2 to be endangered or threatened, naming each species by both its scientific and common
3 name, if any, and specifying over what portion of its range each species so designated
4 is endangered or threatened; and

5 D. Report to the joint standing committee of the Legislature having jurisdiction over
6 inland fisheries and wildlife matters no less frequently than every 4 years on any
7 recommendations, status updates or changes to the list of fish or wildlife species
8 designated as endangered or threatened.

9 **3. Legislative authority.** The Legislature, as sole authority, shall designate a species
10 of fish or wildlife as a state endangered or state threatened species. The list of state
11 endangered or state threatened species of fish or wildlife by common name, scientific name
12 and status is as follows:

- 13 A. Least tern, *Sterna antillarum*, endangered;
- 14 B. Golden eagle, *Aquila chrysaetos*, endangered;

33 **4. Process for recommendation; notice and hearings.** Prior to recommending an
34 addition, deletion or other change to the endangered and threatened species listed in
35 subsection 3, the commissioner shall provide for public notice and at least one public

1 hearing on that proposed recommendation in accordance with the provisions of Title 5,
2 chapter 375, subchapter 2.

3 **5. Designation by Legislature.** The Legislature may not amend the list of endangered
4 or threatened species in subsection 3 except upon the recommendation of the
5 commissioner.

14 A. Acquisition of land or aquatic habitat or interests in land or aquatic habitat;

15 B. Propagation;

16 C. Live trapping;

17 D. Transplantation. Prior to the transplantation, introduction or reintroduction of an
18 endangered fish or wildlife species or threatened fish or wildlife species in the State,
19 the commissioner shall, in conjunction with the Department of Marine Resources,
20 when appropriate, develop a recovery plan for that species, conduct a public hearing
21 on that recovery plan pursuant to Title 5, Part 18 and submit that plan to the joint
22 standing committee of the Legislature having jurisdiction over inland fisheries and
23 wildlife matters. The introduction or reintroduction of that species must be conducted
24 in accordance with the recovery plan developed under this paragraph and may not begin
25 sooner than 90 days after all conditions of this paragraph have been met; and

26 E. In the extraordinary case where population pressures for a given species cannot be
27 otherwise relieved, regulated taking.

28 **2. Habitat.** For species of fish or wildlife designated as endangered or threatened
29 under this subchapter the commissioner may by rule identify areas currently or historically
30 providing physical or biological features essential to the conservation of the species and
31 that may require special management considerations. Rules adopted pursuant to this
32 subsection are routine technical rules as defined in Title 5, chapter 375, subchapter 2-A.

33 **3. Protection guidelines.** The commissioner may by rule develop guidelines for the
34 protection of species of fish or wildlife designated as endangered or threatened under this
35 subchapter. Rules adopted pursuant to this subsection are routine technical rules as defined
36 in Title 5, chapter 375, subchapter 2-A.

37 **5. Confidential information.** Specific information concerning the location of a
38 threatened ~~or~~ fish or wildlife species, endangered fish or wildlife species or species of
39 special concern is confidential if, in the judgment of the commissioner, disclosure of that
40 information would threaten the continued existence of the threatened ~~or~~ fish or wildlife
41 species, endangered fish or wildlife species or species of special concern. If the
42 commissioner determines that information is confidential under this subsection, the
43 commissioner may not disclose the information except to the landowner whose property is

39 C. Possess, process, sell, offer for sale, deliver, carry, transport or ship, by any means
40 whatsoever, any endangered fish or wildlife species or threatened fish or wildlife
41 species or any part of an endangered fish or wildlife species or threatened fish or

1 wildlife species. A person who violates this paragraph commits a Class E crime, for
2 which a fine of \$1,000 must be adjudged, none of which may be suspended; or

40 SUMMARY

41 This bill repeals the laws governing the Natural Areas Program administered by the
42 Department of Agriculture, Conservation and Forestry and reassigns certain
43 responsibilities under the program to the Department of Inland Fisheries and Wildlife. The

1 bill updates relevant definitions in the Maine Revised Statutes, Title 12 and cross-
2 references in Titles 36 and 38 to reflect these changes. The bill also reestablishes the
3 Natural Areas Conservation Fund, which is administered by the Commissioner of Inland
4 Fisheries and Wildlife.
