SUMMARY

This amendment makes changes to the municipal property tax deferral program in the bill in order to make the deferral program more manageable. The amendment simplifies eligibility restrictions, removes a reference to a property tax stabilization program that applied only to the 2023 property tax year, clarifies language related to the liens and lists recorded pursuant to the deferral program and provides a definition of "individually identifiable information" for the purposes of the confidentiality provisions governing the deferral program.
