1. General Fund Revenue Update (see attached)

General Fund revenue was above budget by \$70.7 million (12.0%) for the month of June and above budget by \$20.9 million (0.4%) for the fiscal year. General Fund revenue for FY24 through June was 0.5% less than FY23 General Fund revenue through June of 2023. Without the FY24 automotive sales tax transfers totaling \$107.5 million from the General Fund to the Highway Fund, FY24 General Fund revenue would have been 1.5% greater than FY23 revenue.

Individual income tax revenue was above budget by \$16.8 million for June but remained below budget by \$53.1 million (2.2%) for the fiscal year. Individual income tax final and estimated payments were \$114.8 million below budget through June. This negative variance likely resulted from the delayed tax filing deadlines to accommodate the winter storms. The final impact of these delayed payments will not be determined until FY25. Individual income tax withholding payments for the year were \$26.5 million greater than budget and individual income tax refunds were \$37.9 million less than budget for the fiscal year (a positive impact on the General Fund). Corporate income tax revenue was \$25.9 million above budget for the month of June and \$23.8 million (5.4%) above budget for the fiscal year. Sales and use tax revenue for June (May sales) was \$18.9 million above budget for the month and \$10.1 million (0.4%) above budget for the fiscal year.

2. Highway Fund Revenue Update (see attached)

Highway Fund revenue was above budget by \$1.5 million (5.0%) for the month of June and above budget by \$11.8 million (2.4%) for the fiscal year. Highway Fund revenue for FY24 through June was 46.2% greater than FY23 revenue through June of 2023 largely because of the sales tax transfers from the General Fund to the Highway Fund totaling \$107.5 million and the liquor operations fund transfers totaling \$60.1 million. Without these transfers, revenue for FY24 would have been 1.8% less than FY23 revenue.

Fuel taxes revenue was \$0.6 million below budget for June but \$2.1 million (1.0%) above budget for the fiscal year. Motor vehicle registrations and fees were above budget by \$1.3 million for June and over budget by \$6.7 million (6.9%) for the fiscal year. Highway Fund revenue for FY24 also included a positive variance of \$1.1 million in liquor operations fund transfers.

3. Cash Balances Update

The average balance in the cash pool for June was \$3,932.5 million, a decrease of \$108.1 million from May's average balance. The decreases were mostly in Other Special Revenue Funds and the Highway Fund. The Highway Fund balance for June was \$76.3 million, a decrease of \$22.0 million from May, a result of the pick-up in seasonal construction spending in June.

4. Fiscal Year 2024 Preliminary Closing

The FY24 preliminary closing General Fund balance totaled \$415.2 million, \$321.7 million of which was budgeted and \$93.5 million was unbudgeted. The FY24 closing is still considered preliminary given PL

2023, c. 643, Part LLL language that effectively delays the final FY 2024 closing until August 9, 2024. The \$93.5 million not budgeted included \$20.9 million in General Fund revenue surplus, \$56.6 million in unbudgeted lapsed program balances and \$16.0 million in lapsed encumbrances and prior period adjustments. Transfers under what is known as the "cascade" are made from the unbudgeted surplus only. That surplus was sufficient to make all \$18.5 million required fixed dollar transfers provided for under current law. Under current law, 80% of the remainder of the unbudgeted surplus would be distributed to the Maine Budget Stabilization Fund (MBSF) and 20% to the Highway and Bridge Capital program until the MBSF gets to its statutory cap. Because the MBSF is estimated to be above its current statutory limit of \$963.5 million, all of the remaining FY24 unbudgeted surplus (\$75.0 million) was distributed to the Highway and Bridge Capital program. The table below summarizes the sources and uses of FY24 unbudgeted unappropriated surplus funds.

Preliminary FY 2024 General Fund Year-End Summary

The Highway Fund also has a statutory year-end transfer provision that transfers all but \$100,000 of the increase in the unallocated surplus above the budgeted amount to the Department of Transportation for highway and bridge improvement projects in the next fiscal year. The amount that transferred and is available in FY24 is \$13.1 million. In addition to an \$11.8 million revenue surplus, unexpended Highway Fund allocations that lapsed back to the unallocated surplus totaled \$1.4 million and lapsed encumbrances and prior period adjustments totaled \$0.1 million.

- Prohibit the commission from meeting unless adequate funding is obtained.
