• Commissioner Lambrew and Director Johnson invited to appear and answer questions

Commissioner Lambrew and Director Johnson both made opening comments to the Committee. Rep. Fay asked Director Johnson if she was hearing similar things to what the Committee has heard in recent months and how the Committee and the Legislature and OCFS can communicate going forward to make sure the work gets done together.

- Director Johnson stated that there are mechanisms in place to keep the Legislature informed and suggested working with the GOC in a similar manner as the office does with the HHS Committee. Director Johnson answered that the office has heard similar things and are aware and looking at new strategies to implement and create better working conditions for staff to feel more supported.
- Rep. Mastraccio stated that she was happy with the steps that have already been taken. She stated that she was proud of all the work the Committees and the Department have done together so far and that they are on the right track.
- Commissioner Johnson thanked the Committee for listening to all the workers that came and spoke to the Committee.
- Rep. Arata asked if the Department would work with the Legislature on the current bill to add more case aides to the Department.
- Commissioner Johnson stated that the bill would be heard the next Wednesday in the HHS Committee and they were working on figuring out how to meet the goal of the bill.

- Rep. Arata asked about the rules to the new addition in Law (*LD 560, 130th Legislature*) to create 'baby boxes' that are safe for babies to be dropped off if parents decide they are too overwhelmed.
- Commissioner Lambrew noted technological and funding issues that may be affecting it.
- Rep. Arata stated that the fiscal note was approved and asked if there was any idea of when the rules would be finished.
- Commissioner Lambrew stated that they would have to get back to the Committee.
- Rep. Millett asked Commissioner Lambrew about the outside rapid review that has been mentioned and who the entity would be completing the review and how that process is going.
- Commissioner Lambrew stated that the Department needed the review done immediately. She noted an organization called the Public Consulting Group that completes some reports for the Department annually, so the contract will be renegotiated to include this outside review. She noted some of the focuses included what workplace structures and training are needed to create a welcoming and supportive workplace culture, what is working well within the current structure and what can be improved, and how to create consistency within the district offices.
- Rep. Millett asked Director Johnson to comment on the value the external review will give her as the new Director and her thoughts on improvements that might be different from her predecessor.
- Director Johnson answered that building partnerships with others to build and create solutions is her main focus as she feels strongly that those connections will help lead the Department in a positive direction. She looked forward to seeing what the review will suggest for the new Associate Directors role.
- Rep. Millett asked what Director Johnson would like to hear about her plan six months in the future.
- Director Johnson hoped that the staff would say that she has listened to them and included their opinions in the process and that would be successful.
- Sen. Timberlake stated that he was concerned about adding a new study and new modifications to the Department. He brought up the most recent Casey Family Programs that had recommendations and asked about the implementation of those. He asked what he should tell concerned Department staff that call to complain to him as constituents.
- Director Johnson answered that she has directly been involved in the implementation of the recommendations from the Casey Family Programs and shared the Legislation that was put through to implement those. She stated that she has been a caseworker and has sat in their shoes and is looking forward to hearing how the positions have changed. She wanted to elevate the voices of those on the frontline perspectives. She emphasized tracking data and strategic planning were important components of the Department's success.
- Commissioner Lambrew emphasized that the Department felt confident in Director Johnson's experience and skillset. She stated that the Department is looking to continue to work with the Legislature to continue making changes that are positive.
- Sen. Timberlake asked about a timeline of things actually being improved.
- Director Johnson stated that the work has been started and hoped that within the next three to six months those improvements would be visible.
- Rep. Fay reiterated Sen. Timberlake's worry about communication going forward to stay updated. She wondered about what the best route for updates or report backs to the Committee could be.
- Commissioner Lambrew stated that there were already notes from the Committee's Draft Report that she felt that the Department could be working on putting together.
- Sen. Hickman asked about the Department's relocation of Children's Behavioral Health Services and whether that was done through a budget initiative or what the process for that discretionary decision was.
- Commissioner Lambrew stated that they had the same thought when originally talking about the switch. She noted that Maine was in the minority of States for having Children's Behavioral Health split out and that the change would be more aligned with the majority of other states. She clarified that they looked through the

statutes and there were no required steps for these changes and were working to make sure there were no fiscal issues.

Sen. Hickman stated that he wanted to make sure that the Legislature maintains its oversight on the makeup of any Department so that it is not normalized that they can just make any changes at any time. He noted that it may not need a statutory change but that it seemed that reorganizations were generally approved through the budgets in review.

Sen. Tipping asked for an update on the OFI call wait times.

Commissioner Lambrew stated that there were a number of actions taken to help the issue; hiring more staff, changing the directory lines, uptraining staff to do more things. She noted that the re is a new Director in that office and noted improvements towards those call times.

Next GOC meeting date and planning

The next GOC meeting will be February 9, 2024 at 9:30 AM.

- The Director, Chairs, and Leads will coordinate to produce a document that identifies priorities for the Committee to discuss and vote on. The document will be sent to members at least one week in advance of the next meeting.
- Sen. Timberlake asked for more information regarding the hospital stays and hoteling. How long is the average stay and what is the final cost of children staying in hotels and hospitals?

Sen. Tipping asked about the Tax Reports being taken up by the Taxation Committee and how that was going. Director Schleck stated that they have been working together to catch up on past Reports and thought the process was going well.
