NEW BUSINESS

Item #1: Maine Development Foundation Proposal for Policy Leaders Academy for 2024-2026

President Jackson invited Yellow Light Breen, the President and CEO of the Maine Development Foundation, and Julie Beane, the Program Director of the Maine Development Foundation, to present to the Council their proposal for the Policy Leaders Academy for 2024-2026. Mr. Breen described the Legislative Policy Forum that is traditionally scheduled for the final day of the Pre-legislative Conference, and the multi-day Legislator Bus Tour that is traditionally scheduled in January following convening of a new Legislature. Mr. Breen said that this year, the bus tour would be going to Bangor, Katahdin and points north, and will highlight things that are uniquely important to that region of the State including but not limited to agriculture, forestry, and the outdoor recreation industry. Rep. Terry recalled the "civility pins" she and her colleagues received when they went on their first bus tour as freshmen legislators, and expressed the hope that the focus on civility and relationship building remains a focus of future Legislator Bus Tours. Speaker Talbot Ross shared that she had been discussing with the Council of State Governments about available trainings on civil discourse, and Mr. Breen expressed willingness to participate in future conversations on the topic.
