Re: Opioid Litigation Settlements and the Maine Recovery Fund

Dear Committee Members,

This letter is to report to you about the status of the settlement funds in the Maine Recovery Fund to address statewide needs for abating the opioid crisis in Maine.

As you know, in 2022 I signed a Memorandum of Understanding (the "MOU") with certain counties, cities, and towns which had filed lawsuits against manufacturers and distributors of opioid pain medications. The MOU allocates within Maine settlement funds from various opioids-related investigations and litigation, with 50% of settlement funds going to the Maine Recovery Fund, 20% to the Attorney General, and 30% to 39 counties, cities, and towns, all for spending to abate the opioid crisis in Maine. The MOU, along with legislation passed by the 130<sup>th</sup> Legislature (L.D. 1722), created the Maine Recovery Fund and established the Maine Recovery Council "to direct the disbursement of recovery funds for recovery purposes on a statewide basis" for certain opioid abatement uses. The Senate President and the House Speaker each have the authority to appoint three members of the Council, resulting in six of the fifteen members having been appointed by the Legislature.

Section IV(E) of the MOU provides that that "[t]he Attorney General shall report at least annually on or before the 2nd Friday in December" to your committees and the report "must summarize the activity in any funds or accounts directly related to this section".<sup>1</sup>

Regarding the Recovery Fund, as of October 31, 2024, it has a balance of \$ 36,289,632.82. An overview of the settlement funds allocated in Maine, including to the Recovery Fund, may be found on my office's website, <u>https://www.maine.gov/ag/opioids/settlement-payments.html</u>.

The Council has made significant progress towards distributing funds. Shortly following my report of December 8, 2023, the Council allocated over \$9 million to organizations working in four areas of opioid abatement: harm reduction, treatment, prevention, and recovery support.<sup>2</sup> Those funds have begun to flow out to communities in Maine as my staff develop and improve the Council's processes for contracting with providers. In addition, a few weeks ago, the Council completed its grant application process which it began in June 2024. The Council decided to award grants for 43 projects totaling nearly \$14 million.<sup>3</sup> The Council reviewed 220 letters of interest requesting a total of \$87.5 million and 127 applications.

The next report to the Legislature on the Recovery Council is due on February 1<sup>st</sup>, as required by 5 M.R.S. § 203-C (5). The statute requires me to report to the Committee on Health and Human Services "describing the activities of the Council and the status of the Maine Recovery Fund and listing information on disbursements from the fund and information related to the outcomes of funded activities." Between now and then, I will be coordinating with the Council as it works to take over its grants contracting work with the shared goal of speeding up its contracting process while ensuring these limited, critical funds are protected from misappropriation and waste.
