**Statement of Fact**

Maine Revenue Services anticipates a shortfall in the projected business activities for the second half of the fiscal year. Additionally, Maine Revenue Services will make Direct File available to Maine taxpayers this next filing season to file their federal income taxes and will work with the IRS to fully integrate Direct File and the Maine Tax Portal for future filing seasons, with a goal of completion in 2026. The funds in the Reimbursement - Homestead Property Tax Exemption account are no longer needed since all required payments have been processed for this fiscal year.

**Statement of Fact**

This financial order establishes one limited-period Senior Staff Accountant position beginning March 2, 2026, and ending March 1, 2028. This position will be funded through the Maine's Rural Health Transformation Plan, a five-year grant awarded to the State of Maine's Department of Health and Human Services. This position will be responsible for providing financial and accounting support for the increased workload that the Department of Health and Human Services Financial Service Center will be responsible for and will oversee the implementation of the grant to ensure compliance with standard financial operating practices. Funding is provided through the United States Department of Health and Human Services, Centers for Medicare & Medicaid Services, ALN 93.798. Failure to allot will result in the Department of Health and Human Services Financial Service Center's inability to provide the additional resources needed to manage this grant.






