## Law Library Adds Digital Collection

The Law Library has just added *LLMC-Digital* to its growing collection of digital resources. LLMC, a consortium of law libraries throughout the country, is building a comprehensive library of legal materials from jurisdictions around the world. Its state collections, when completed, will include entire runs of reported cases, statutes and other legislative materials, and executive documents. The volumes in its online collection can be browsed by title, searched full-text, or retrieved by citation. Page images can be printed or downloaded as PDF files.

Because it is a non-profit consortium, LLMC relies heavily on its member libraries to make materials available for digitizing. The first 122 volumes of *Maine Reports* are already included in the collection. The Law Library will be helping LLMC locate and obtain other Maine state materials to be added. These donated materials will not be discarded, even after imaging; LLMC preserves the originals in a "dark archive" deep in a salt mine, in case changes in technology ever make it desirable to scan them again.

LLMC-Digital is available at the public access computers in the Law Library. Please explore it for yourself, or ask a reference librarian to give you a quick tutorial.

#### Virginia Court Rules Against Maine

Wiscasset's Declaration of Independence

March 22, 2008 - A Virginia circuit court judge ruled against the State of Maine in its action to regain ownership of an early broadside copy of the Declaration of Independence which was sent to Wiscasset, formerly known as Pownalborough, in 1776. Maine argued that the document, discovered in a Wiscasset attic and sold several times since, was a public document not subject to private sale. The judge ruled in favor of Richard L. Adams, Jr., a Virginia collector who paid \$450,000 for the document in 2001. The Attorney General's office, representing the State, has appealed the circuit court decision to the Supreme Court of Virginia.
