**Statement of Fact**

This financial order funds two project Government Intern positions previously established by financial order. The interns will be assigned to support the Master Cooperative Agreement between the Maine Army National Guard and the National Guard Bureau. One intern will be assigned to assist the Energy Manager. Duties will include energy audits at Maine Army National Guard (MEARNG) facilities throughout the state; data collection, data entry and processing into the GIS database. Pieces of information to be gathered will include the 35+ real properties of the MEARNG across the state. Another intern will be assigned to assist the Warehouse Superintendent. Activities include conducting inventories at MEARNG facilities; pricing inventory, determine condition codes and replacement schedules for furniture at MEARNG; work with the Purchasing and Contracting section to create specifications for future furniture replacement contracts. The positions are funded 100% from Federal Expenditures Fund under the Master Cooperative Agreement.


