#### SUMMARY

This amendment, which is the minority report of the committee, reduces the reimbursement rate per discharge to cover the cost of providing care to MaineCare members in a psychiatric inpatient unit and limits the new reimbursement rate to the period beginning on the effective date of this legislation and ending January 15, 2022. The amendment directs the Department of Health and Human Services to seek and apply for federal funds and funds from any other sources to pay the costs of providing psychiatric services to uninsured patients. The amendment also directs the Department of Health and Human Services to submit a report to the joint standing committee of the Legislature having jurisdiction over health and human services matters regarding the progress the department has made in developing a reimbursement rate to provide inpatient psychiatric care under its rule Chapter 101: MaineCare Benefits Manual, Chapter III, Section 45.03. The committee is authorized to report out legislation related to the report to the Second Regular Session of the 130th Legislature. This amendment includes a provision to repeal the resolve January 15, 2022.

This amendment also adds an appropriations and allocations section.
