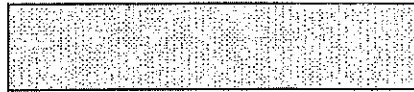

ORDERED,

That the State Controller increase allotment in account 014-01A-Z224-81, Snowmobile Trail Fund by \$495,891 in the Capital Expenditures line category and in account 014-01A-Z224-83, ATV Recreation Management Fund by \$495,891 in the Capital Expenditures line category for the purpose of purchasing land and funding development costs for a multi-use rail trail in Kennebec and Somerset counties; and,

Be it further ordered,
that the State Controller authorize the expenditure in accordance with the attached "Revision of the Work Program for Fiscal Year ending June 30, 2021", for which this shall be our sufficient warrant.

Statement of Fact

This financial order allots a portion of unencumbered balance forward to purchase an approximately 32.32 mile long railroad corridor from Pan Am Systems, Inc., to be developed as a public multi-use rail trail. This trail will connect six towns, eliminate unsafe water crossings, and create significant economic development opportunities. This trail will also connect to the Maine Interconnected Trail System and the Maine ATV Trail System. Funding sources include: \$436,000 in new revenue received as reimbursement from Northern Border Regional Commission (\$218,000 to 01401AZ22481, \$218,000 to 01401AZ22483), \$33,775 in new revenue as reimbursement from Recreational Trails Program (\$19,447 to 01401AZ22481, \$14,328 to 01401AZ22483) and \$22,007 from the Off-Road Recreational Vehicles Program using unencumbered balance forward funds (\$8,444 from 01401AZ22481, \$13,563 from 01401AZ22483). Failure to allot these funds will prohibit the department from purchasing this property.

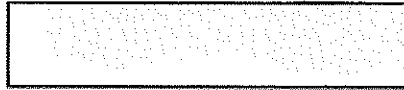

Statement of Fact

In addition, funds are needed to replace fencing that has become a public hazard. Failure to approve this financial order will have a detrimental impact on the department's ability to efficiently access animals for feedings over the winter as well as maintain a safe environment for visitors entering the Park next season.

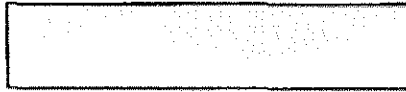

Statement of Fact

That the State Controller increase allotment in account 014-13A-0027-16, Halibut Fund, by \$1,891 in the Personal Services line category and by \$89 in the All Other line category for the purpose of allotting a portion of the unencumbered balance forward for the halibut longline survey; and,

Be it further ordered,
that the State Controller authorize the expenditure in accordance with the attached "Revision of the Work Program for Fiscal Year ending June 30, 2021", for which this shall be our sufficient warrant.

Statement of Fact

This financial order allots a portion of the unencumbered balance forward for Personal Services working on the implantable electronic data storage tags and the halibut longline survey. The purpose of this survey is to provide an index of adult halibut biomass as a basis for future assessments. The DST centi-ex archival tags will be surgically implanted into live Atlantic halibut. These tags collect data on temperature and depth at pre-programmed time intervals and can take measurements at depths up to 5,000 feet. The data from these tags can be used to determine where halibut migrate and if, when and where they spawn. Failure to allot these funds will cause a detrimental impact on the ability to continue to set precautionarily low catch limits. This could result in lost revenue in our state waters halibut fishery and the broader federally-managed multispecies fishery.
