Statement of Fact

This financial order provides allotment for temporary unemployment assistance benefits provided by federal laws passed as a result of the COVID-19 pandemic. This funding is provided by the Federal Pandemic Unemployment Compensation (FPUC) program included in the Continued Assistance for Unemployed Workers Act of 2020. This program provides eligible individuals who are collecting unemployment compensation benefits with an additional \$300 weekly benefit payment. Failure to provide this allotment will prevent accurate financial accounting for these payments in the State's accounting system.
