Statement of Fact

This financial order provides allotment for Maine Center for Disease Control and Prevention COVID-19 response efforts to provision for contracted staffing, testing supplies and expanded testing capacities, and allocated payroll for personnel and re-deployed staff. The additional funding is being used for preventing, preparing for, and responding to coronavirus by continuing expansive COVID-19 testing, case investigation and contact tracing, surveillance, containment, and mitigation. Activities include enhancing laboratory services by strengthening laboratory testing, provisioning for expanded testing (including point-of-care and other rapid testing), advancing electronic data exchange at public health labs, improving surveillance and reporting of electronic health data, using laboratory data to enhance investigations, response, and prevention, and containment and mitigation through social supports with community-based organizations. Funding is provided through the Maine 2019 Epidemiology and Laboratory Capacity for Prevention and Control of Emerging Diseases Application grant and includes supplemental funding from the Coronavirus Aid, Relief, and Economic Security (CARES) Act.
