- Added Department-approved programs for Educational Technicians as an alternative to credit requirements
- Other Teaching Assignments added: Added Language Immersion Teacher as an example of an International Teacher and added Alternative Education Teacher
- Added emergency teacher certificate and reciprocal professional certificates

### Part II Proposed Changes

Section 1: General Certificates and Endorsements

- Grade span recommendations, added Pre-K to any span starting with K: Pre-K-3, Pre-K-8, 6-12, and Pre-K-12
- Any "Social Studies" requirement expanded to include "or Social Sciences" and expanded the disciplines to include Psychology and Sociology
- Addition of 6 credit hours of required coursework
  - o 3 hours of coursework in the area of diversity
  - 3 hours of coursework in one of the following areas: Human Development, Educational Psychology, Developmental Psychology, Adolescent Psychology or Child Development

- World Language group: Extended down to Pre-K and added: American Sign Language, Hebrew, and Arabic

  - Specified some coursework requirements
- Removal of qualifying examination requirements. For teachers, this requirement was replaced with the option to take a basic skills test, provide evidence of a 3.0 cumulative GPA in the courses required for the certificate/endorsement, or the review of a portfolio which includes evidence of the Initial Teaching Standards
- Added a School Health and Physical Education combined teacher endorsement

## Section 2: Special Education Certificates and Endorsements Teachers and Educational Specialists

- Grade levels changed to Pre-K to grade 12 in alignment with Part B IDEA
- More specific course requirements in accordance with skills of special education identified in IDEA, High Leverage Practices from the Council for Exceptional Children and the CEEDAR Center, and trends in education
- For conditional certificates, added language for a "mentor teaching program endorsed by the Maine Department of Education"
- Added an additional pathway to certification for current Ed Techs who have (a) a BA/BS, (b) experience as an Ed Tech III for three years, and (c) positive evaluations
- Parents → parents/guardians
- Person first language: From "Teacher of blind or visually impaired students" to "Teacher of students with visual impairments"
- Removal of:
  - o 515 Adapted PE Teacher
  - o 079 Special Ed Consultant
  - o 293 Speech and Language Consultant

# Section 3: Career and Technical Education (CTE) Certificates and Endorsements Teachers and Educational Specialists

- Aligned endorsement areas with annually-approved CTE programs
- Removal of assessment requirements
- Created flexibility for certified teachers to become CTE instructors through the application of equivalent courses for the pedagogical course requirements

## Section 4: Administrator Certificates

- The Interstate School Leaders Licensure Consortium (ISLCC) standards no longer exist and were replaced with the Professional Standards for Educational Leaders (PSEL), which were developed with guidance from the Council of Chief State School Officers (CCSSO) and the National Policy Board for Educational Administration (NPBEA)
- Requirements for advancing a certificate by the second renewal were eliminated
- Submission of a portfolio was added as an option for demonstrating that PSEL standards have been met
- Removal of assessment requirements
