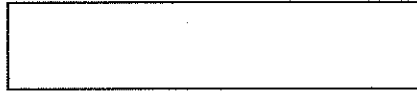

Statement of Fact

That the State Controller transfer \$109,542 from the All Other line category to the Personal Services line category within account 013-05A-Z080-14, IDEA/Personnel Preparation, for the purpose of covering the personnel costs associated with the 2021 Maine State Personnel Development Grant; and,

Be it further ordered, that the State Controller increase the allotment in account 013-05A-Z080-14, IDEA/Personnel Preparation, by \$109,542 in the Personal Services line category, and decrease the allotment in account 013-05A-Z080-14, IDEA/Personnel Preparation, by \$109,542 in the All Other line category; and,

Be it further ordered, that the State Controller authorize the expenditure in accordance with the attached "Revision of the Work Program for Fiscal Year ending June 30, 2022", for which this shall be our sufficient warrant.

Statement of Fact

This financial order transfers allotment from the All Other line category to the Personal Services line category to cover personnel costs to administer the 2021 Maine State Personnel Development Grant (CFDA #84.323A). This five-year grant will support Positive Behavior and Interventions and Supports (PBIS), a multi-tiered approach to supporting the social, emotional and behavioral development of students in K-12 settings, and Math4ME, designed to implement evidence-based professional development to improve math proficiency of students with disabilities in development grades 3-5 and to improve the instructional practices of these students. An existing Public Service Executive II and an existing Education Specialist III will coordinate and manage the work related to these two projects and a portion of their costs will be charged to this grant. Funds are no longer required in the All Other line category for the purpose for which they were originally intended due to over allocation for contracted services based on the authorized grant budget.

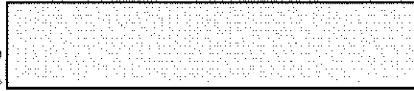

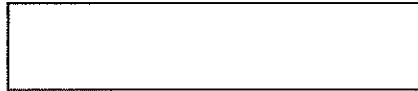

that the State Controller increase allotment in the Capital Expenditures line category and decrease allotment in the All Other line category by \$111,000 in account 010-16A-0291-01, State Police; and increase allotment in the Capital Expenditures line category and decrease allotment in the All Other line category by \$61,000 in account 012-16A-0291-01, State Police, for the purpose of purchasing equipment; and,

Be it further ordered,  
that the State Controller authorize the expenditure in accordance with the attached "Revision of the Work Program for Fiscal Year ending June 30, 2022", for which this shall be our sufficient warrant.

Statement of Fact

This financial order transfers allotment from All Other to Capital Expenditures for the purchase of night vision binoculars and one remotely-operated vehicle (ROV). The State Police will use the binoculars for low light and no-light situations where lighting conditions are not ideal, but law enforcement response is required. The ROV will allow the State Police to respond to situations at any body of water in the State to assist in explosive device detection/remediation, hazardous materials operations, tactical law enforcement operations, search and rescue, and surveillance/detection, as well as other potential underwater terrorist activities. Funds are no longer required in the All Other line category for the purpose for which they were originally intended, and remaining resources will meet existing operational needs.
