MaineCare Expenditure Detail through 1st Quarter of SFY 2022

MaineCare Expenditure Table 1 uses expenditure data from the State's financial warehouse (MFASIS) through 3 months of FY 2022 to compare MaineCare expenditures by expenditure category for the last three fiscal years. MaineCare "All Funds" spending through 3 months of FY 2022 increased by \$27.3 million from FY 2021 to FY 2022. As detailed in MaineCare Table 1, FY 2022 spending through 3 months increased in the residential care, dentistry, Medicare A, B, D premiums, laboratory, behavioral health and clinic services expenditure categories; and decreased in the pharmacy and related, other professionals and rehabilitation services expenditure categories. These increases were expected due to two items: 1) Medicaid expansion expenses increased by just over \$5 million, 2) Rate increases and program changes to multiple services during the 130th legislature effective July 1, 2021. See Exhibit A and B for a detailed breakdown of the Medicaid Expansion expenditures.

FY 2022 MaineCare "All Funds" spending through 3 months increased by 2.5% over last year's spending. MaineCare Expenditure Table 1 also shows that aggregate General Fund expenditures through 3 months of FY 2022 increased by 10.3% compared to FY 2021. At first glance this increase seems odd as the General Fund increase is higher than the all funds increase. However, manual journal entries, accounting adjustments and bad debt expense in the first quarter of SFY 2022 decreased the all funds total by \$6.5 million, but the General Fund impact of these same entries was an increase of \$14.8 million. Thus, the increase in expenditures between SFY 2021 and SFY 2022 was \$27 million all funds and \$29 million General Fund. If the spending is reviewed excluding these journal entries, the differences for SFY 2022 compared to SFY 2021 would be \$33.8 million increase in all funds and a \$14.9 million increase to the General Fund. See Exhibit D for more detail. Including this explanation, the current General Fund spending is in-line with the legislatively approved amount for FY 2022.
