Thank you for the opportunity to report to the Appropriations and Financial Affairs Committee the votes of the Criminal Justice and Public Safety Committee on LD 1995, An Act to Make Supplemental Appropriations and Allocations for the Expenditures of State Government, General Fund and Other Funds and to Change Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years ending June 30, 2022 and June 30, 2023.

We are pleased to attach copies of the voting sheets. In addition, we call you attention to the following:

- During the budget discussion there was support expressed for encouraging the Commissioner of Public Safety and Chief of the Maine State Police to renew their efforts to fill State Trooper vacancies in the Maine State Police in order to secure the safety of the public and to adequately patrol Maine's highways and roads.
- A minority of the committee supported including in the Department of Corrections budget funding for children's behavioral health services in the amount of \$12,000,000 for fiscal year 2022-2023. A majority of the committee did not support this proposal. Details of the minority funding proposal follow.

Justification:

The Maine DOC is an industry leader in the use of body cameras (aka lapel cameras) in corrections work in support of transparency, reviewing uses of force to ensure standards of conduct, and in support of the Prison Rape Elimination Act. The current lapel camera system is configured such that camera footage uploads to an on premises server rather than using cloud based storage technologies. Virtually all other vendors have also converted to similar web-based data storage platforms and away from on prem platforms. Our present configuration has prevented cameras from receiving software update downloads though web-based portals. Our vendor is ending their support of on-prem data storage which would render existing cameras to be inoperable in the near future. Without prompt action, namely an update to cloud based storage and conversion to the new platform, the continued existence of the lapel camera program is in jeopardy. This upgrade would also resolve many other functionality issues related to lapel cameras, purchase of service warranty, 30-month free upgrade to newer cameras, purchase of smaller magnetic camera uniform mounts, upgrading of charging capabilities, newer cameras with Image Stabilization, and significant increase in upload, download and recharging speeds.

Deaths due to overdoses continue to rise. Digital evidence in murder investigations continues to grow dramatically in complexity with large and time-consuming amounts of digital data.
