### **PURPOSE**

The Maine Justice for Children Task Force ("the Task Force") is hereby continued as a collaborative, multidisciplinary Task Force to improve safety, permanency, and well-being for children in the State of Maine child welfare system. It is anticipated that the work of the Task Force will regularly occur in conjunction and collaboration with the work of the Executive and Legislative Branches, along with appropriate child welfare entities. This collaboration may include joint meetings designed to maximize the experience of the membership of each committee, prevent redundancy, and be respectful of members' work schedules.

- Implementation of a virtual child welfare parent curriculum.
- Race and Equity Data Assessment Project.
- Continuing education for all system stakeholders.
- Interagency data sharing.



### PARENT CURRICULUM

- In August 2020, the Task Force added the development of information sessions for parents involved in the child welfare system to the strategic plan.
- Goal: Offer voluntary classes to parents, focused on understanding child welfare agency processes, court procedures, and suggested best practices for parents to implement in order to be successful throughout the life of a child welfare case. The sessions are led by parents with lived experience in the child welfare system or parents who have navigated multiple systems.

# PARENT CURRICULUM: DATA COLLECTION

### Data Collection:

- Pre- and post-parent surveys;
- Time to permanency;
- Participation in family visitation;
- Participation and engagement in reunification services; and
- Attendance at court proceedings.

### PARENT CURRICULUM: SEPTEMBER UPDATE


- 23 participants
- Pre/Post Survey Results from January 27, 2022 to July 13, 2022 (scale 1-5; score are for 19 participants)
  - · I have an understanding of how the child protective system works.
    - Pre-curriculum score: 2.4
    - Post-curriculum score: 4
  - I understand who is on my child protective services team and what the each do.
    - Pre-curriculum score: 2.7
    - Post-curriculum score: 4.3
  - I have an understanding of what I need to do to reunify my family.

# PARENT CURRICULUM: SEPTEMBER UPDATE

- I have an understanding of what I need to do to reunify my family.
  - Pre-curriculum score: 3.4
  - Post-curriculum score: 4.3
- I feel hopeful about my child protective services involvement.
  - Pre-curriculum score: 3.5
  - Post-curriculum score: 4.0

# PARENT CURRICULUM: SEPTEMBER UPDATE

  - "The whole class was very helpful there was a lot of information that I had not known or had been given the wrong information before this class."

- Assess systemic data collection with regard to race and other important markers of equity;
- Better understand what systems are in place for the collection and sharing of aggregated data on various data points in order to inform policy decisions, measure fairness and equity, and provide the courts and agencies with data about the people and populations they serve.


### **Data Point Set**

- Race;
- Ethnicity;
- Connection with tribe/band/nation;
- Enrollment or eligibility for enrollment with a federally recognized tribe(s);
- Sexual orientation;
- Income;
- Location;
- Gender;
- Gender identity; and
- Disability.



### **Action Steps**

- May 2021: Self- Assessment- an effort to inventory which data are collected, how they are collected, and how those data are coded in the various systems.
- October 2021: Public Consulting Group (PCG) was hired through the RFP process to create a data mapping inventory and produce a final report with findings and recommendations.



# **Data Mapping Inventory**

Generally, the Data Mapping Inventory is designed to provide an overview of the current systems and processes for the collection of the data point set by Project Partners.

#### **September Update:**

Draft report was provided to the Task Force in July 2022.



#### **Final Report**

- Identify barriers, if any, for collection of data from the data point set;
- Best practices for the collection of data;
- Opportunities, advantages, and disadvantages for interagency aggregated data sharing; and
- A proposed evaluation plan for the collection and possible sharing of aggregated data pertaining to the data point set by the Project Partners.
- To be completed by September 30, 2022.

#### **September Update:**

Draft final report was provided to the Task Force in August 2022.

Updated draft provided on September 15, 2022. Race and Equity Subcommittee meeting on Tuesday, September 20<sup>th</sup> to review.
