that the State Controller transfer \$60,057 from the All Other line category to the Personal Services line category within account 023-13A-0258-01 for the purpose of funding one limited-period Marine Resource Scientist II position; and,

Be it further ordered,  
that the State Controller increase the allotment by \$60,057 in the Personal Services line category and decrease the allotment by \$60,057 in the All Other line category in account 023-13A-0258-01; and,

Be it further ordered,  
that the State Controller authorize the expenditure in accordance with the attached "Revision of the Work Program for Fiscal Year ending June 30, 2023". for which this shall be our sufficient warrant.

**Statement of Fact**

This financial order transfers All Other to Personal Services to establish one limited-period position to provide administrative support and oversee \$7.6M in high priority fisheries connectivity and habitat restoration projects. Funds were authorized in Public Law 2021, chapter 483, An Act To Provide Allocations for the Distribution of State Fiscal Recovery Funds. The position will start on November 7, 2022 and end on November 6, 2024. All Other funds are no longer needed for the purpose for which they were originally intended due to a change in the business plan. Failure to approve this order will result in the department's inability to supply needed management of the awarded American Rescue Plan Act funds.
