On January 31, 2023, the Joint Standing Committee on State and Local Government reviewed the budget items in the Governor's proposed supplemental budget for FY23, LD 206, pertaining to those state agencies under the committee's jurisdiction. In summary, the committee voted as follows:

INITIATIVES

The committee voted unanimously of members present to move \underline{IN} all budget initiatives under the committee's jurisdiction with the **following exception**:

 Capital Construction/Repairs/Improvements, Department of Administrative and Financial Services, 059 (Ref #4)

The committee voted 7-4 to move IN Ref #4 as proposed

Four members voted **IN** Ref #4 with the additional recommendation that the Joint Standing Committee on Appropriations and Financial Affairs determine whether the Greater Augusta Utility District should reimburse the Department of Administrative and Financial Services for some or all of the construction costs.

LANGUAGE PARTS

The committee voted unanimously of those present to move \underline{IN} all language parts under the committee's jurisdiction with the **following exception**:

■ The committee voted 7-4 to move IN Part D as proposed.

Sec. D-1. PL 2021, c. 398, Part M is amended to read:

Sec. M-1. Department of Administrative and Financial Services; lease-purchase authorization. Pursuant to the Maine Revised Statutes, Title 5, section 1587, the Department of Administrative and Financial Services, in cooperation with the Treasurer of State, may enter into financing agreements in fiscal years 2021-22 and 2022-23 for the acquisition of motor vehicles for the Central Fleet Management Division. The financing agreements entered into in each fiscal year may not exceed \$7,500,000 in fiscal year 2021-22 and \$15,000,000 in fiscal year 2022-23 in principal costs, and a financing agreement may not exceed 6 years in duration. The interest rate may not exceed 7%. The annual principal and interest costs must be paid from the appropriate line category allocations in the Central Fleet Management Division account.

PART D SUMMARY

This Part increases the borrowing authority of the Department of Administrative and Financial Services to enter into financing arrangements in fiscal year 2022-23 for the acquisition of motor vehicles for the Central Fleet Management Division and adjusts the interest rate. The Division was unable to fully utilize the borrowing authority in fiscal year 2021-22 due to automobile supply issues.

Sec. G-1. Payments to State from Maine Governmental Facilities Authority operating account. Notwithstanding any provision of law to the contrary, the Maine Governmental Facilities Authority shall transfer \$149,955 from the balance in the authority's operating account to the State as undedicated revenue no later than June 30, 2023.

Notwithstanding any provision of law to the contrary, for fiscal year 2022-23 only, the Department of Administrative and Financial Services is authorized to transfer available balances of Personal Services allocations in the Information Services program, General Fund account after all salary, benefit and other obligations are met to the All Other line category of the Information Services program, General Fund account for the purposes of funding statewide cybersecurity costs. These amounts may be transferred by financial order upon the recommendation of the State Budget Officer and approval of the Governor. These transfers are not considered adjustments to appropriations.

PART I SUMMARY

This Part authorizes the Department of Administrative and Financial Services to transfer by financial order available Personal Services balances in the Information Services program, General Fund account for fiscal year 2022-23 only, in order to fund statewide cybersecurity costs.
