Re: LD 258, An Act Making Unified Appropriations and Allocations from the General Fund

and Other Funds for the Expenditures of State Government and Changing Certain Provisions of the Law Necessary to the Proper Operations of State Government for the

Fiscal Years Ending June 30, 2023, June 30, 2024 and June 30, 2025

Pursuant to Joint Rule 304, the Joint Standing Committee on Education and Cultural Affairs met to review the biennial budget initiatives pertaining to the agencies under our jurisdiction in the Governor's proposed biennial budget, LD 258.

As requested during the public hearing on the biennial budget, the Education and Cultural Affairs committee sought to organize the initiatives under our jurisdiction in a way that would be conducive to your review of our recommendations. Accordingly, we respectfully submit our report-back in two parts: 1) the attached spreadsheets and language parts, which includes the committee votes on each of the initiatives under our jurisdiction; and 2) the following narrative regarding additional information, recommendations on new or amended initiatives, and further explanation on certain proposals that the committee believes will inform your understanding of our positions on the Governor's proposed biennial budget.

All members of the Education and Cultural Affairs Committee were present for the votes on the initiatives, except that Senator Libby, while able to watch and listen to most of the discussion,

was not able to register his votes until after the work session had concluded. Had Senator Libby been able to vote, he would have voted with the majority of his caucus.<sup>1</sup>

The committee voted unanimously to amend Language Part QQ, to provide clarity that bonding for infrastructure upgrades must be only those infrastructure upgrades that support the new or updated equipment.

Following the votes on the initiatives contained in the Governor's proposed biennial budget, the Democratic and Republican members of the Education and Cultural Affairs Committee each provided additional information, recommendations, including new or amended initiatives and further explanation of positions. These additional recommendations are listed below.<sup>2</sup>

### **Democratic Committee Member Recommendations (Majority Report)**

The Democratic members of the committee express support for the Governor's proposed biennial budget and efforts to address the pressing needs related to cultural affairs and education in this State. At the same time, the Democratic members of the committee have identified the following areas in which they recommend that there be greater support, either through additional funding initiatives in the biennial budget or through support of proposed or pending legislation that will come before the Education and Cultural Affairs Committee, Appropriations and Financial Affairs Committee, or both. These additional recommendations are outlined below.

### Maine Public

The Democratic members of the committee recommend appropriating an additional \$850,000 in each year of the biennium for Maine Public to bring funding in line with recommended funding levels.

The Democratic members of the committee make the following recommendations in regards to the public higher education institutions:

### University of Maine System:

- A new initiative to provide \$7 million in each year of the biennium for tuition assistance for the creation of a University of Maine System free-tuition program, similar to the Maine Community College System – Free College program;
- In addition to the \$3 million in each year of the biennium proposed in the Governor's biennial budget under reference # 3264, provide an additional \$3 million in each year of the biennium (for a total of \$6 million in each year of the biennium) to the University of

- Maine System's Maine Economic Improvement Fund to support the University of Maine System's new R1 Carnegie Classification and expand the University of Maine System's research and development activities; and
- Support for LD 460, An Act to Authorize a General Fund Bond Issue to Improve Student Success and Workforce Readiness Within the University of Maine, sponsored by Senator Pierce, which is pending legislation that has been referred to the Appropriations and Financial Affairs Committee and would provide bonding to be used to strategically improve infrastructure at all campuses of the University of Maine System.

# Maine Community College System

- An additional \$5 million in each year of biennium to support student learning and completion, especially for those students whose education was disrupted by the COVID-19 pandemic, which led to gaps in learning and learning loss. This funding would provide:
  - o 20 additional navigator positions across the system focused on student success, career services, and retention (\$2.1 million);
  - o Expansion of tutor positions and peer mentor support at all colleges, specifically in the areas of math and English (\$1 million);
  - o 4 positions in the learning commons to assist students with research and library needs (\$280,000)
  - 6.5 disability coordinator positions to assist students with learning disabilities and social skills and community resource centers on multiple campuses to help students identify needs to be successful and connect them with both internal and external resources (\$520,000); and
  - O The remaining funding would be used to enhance student technology and course material availability, renovate study and collaboration space, expand on-campus housing support through housing scholarships, and for professional development for staff focused on how to identify students who are struggling, and determining barriers to success (\$600,000).

Additional information regarding this recommended new initiative may be found in the Maine Community College's response to questions on MCCS portions of the biennial budget, dated February 25, 2023.

# Maine Maritime Academy

• In addition to the \$2 million in each year of the biennium proposed in the Governor's biennial budget under reference #2762, an additional \$3 million in each year of the biennium towards operations.

In addition to the new initiatives and recommendations above, the Democratic members of the committee want to emphasize the pressing issues in preK-12 education in the State. The following new initiatives or recommendations of support for pending legislation are reflective of the need to support the Department of Education, the State Board of Education, and preK-12 students and educators in the State.

## General Purpose Aid for Local Schools (GPA) and Language Part C

- An additional \$250,000 in each year of the biennium (for a total of \$500,000) in each year for community schools pursuant to Title 20-A, section 15689-A, subsection 25;
- Additional funding for the English Learner budgetary hardship adjustment pursuant to Title 20-A, section 15689, subsection 16 for a total of \$1.5 million in the first year of the biennium a recommended \$1 million in the second year of the biennium.

## **Child Development Services**

• To provide parity in terms of reimbursement for services provided by Child Development Services, support for LR 1003, An Act to Clarify the Requirements for Payment of Tuition for Children with Disabilities by the Department of Education's Child Development Services System (sponsored by Representative Gattine), which will propose to direct Child Development Services to work with special purpose private schools and private general purpose agencies to establish appropriate daily rates for the educational component of services.

### State Board of Education

• An additional one-time funding of \$50,000 in the first year of the biennium to support contracted services to perform data gathering, research and facilitation of education stakeholder groups, including in the fields of career and technical education, certification, and school construction, to meet the goals of the Board's 5-year strategic plan. Democratic members of the committee recommend this one-time funding with the expectation that the committee, Department of Education, and State Board of Education will review staffing needs of the State Board of Education going forward.

## Workforce Development

Workforce development is one of the most important and pressing issues in K-12 education in this State and it is vital that the State support appropriate pay, salaries and other forms of financial support to recruit and retain the educator workforce. Accordingly, the Democratic members of the committee recommend support for the following legislation that would increase teacher and support staff pay:

- LR 204, An Act to Increase the Minimum Teacher Salary (sponsored by Senator Pierce);
- LD 955, An Act to Address Shortages of School Support Staff by Increasing the Minimum Hourly Wage for Those Staff (sponsored by Representative Millett); and
- LD 974, An Act to Establish Minimum Pay for Educational Technicians and Other School Support Staff (sponsored by Representative Crockett).

#### Student Supports

Sufficient funds and resources are necessary to assist schools in closing the achievement gap, especially in regards to reading. Additionally, it is clear that schools need more resources towards supporting K-12 student mental health. Accordingly, the Democratic members of the committee recommend support for:

- LR 57, An Act to Implement the Recommendations of the Maine Department of Education Study on Reading Proficiency (sponsored by Representative Brennan); and
- LD 829, An Act to Improve Behavioral Health Support for Students in Public Schools, (sponsored by Representative Crafts).

# Republican Committee Member Recommendations (Minority Report)

The Republican members of the committee recommend the following amended initiatives and offer the following additional information and explanation of the Republican committee members' votes on specific proposals raised in the Governor's proposed biennial budget.

# Maine Community College System Free College Initiative – Reference # 3214

The Republican members of the committee propose that the money being provided to the MCCS Free College program should instead be designated for vouchers for graduating high school students to attend any postsecondary institution in Maine at which the student is accepted. The voucher amount would be determined as a per-pupil rate.

# Maine Maritime Academy – Reference # 2762

Republican members of the committee propose an additional \$6 million in each year of the biennium (for a total of \$8 million in each year of the biennium) to Maine Maritime Academy operations. The members believe in meritocracy and feel that Maine Maritime Academy has consistently demonstrated a record of excellence, which should be recognized and support through this additional funding.

# University of Maine System - Reference #s 3255, 3256, 3257, 3264, and 3268

The Republican members of the committee voted in opposition to each of the initiatives for the University of Maine System under the committee's jurisdiction. The University of Maine System currently requires that students who plan to participate in any on-campus or university-sponsored experience must be fully vaccinated against COVID-19. House Republicans sent an open letter to Chancellor Malloy requesting that the COVID-19 vaccination mandate be lifted for all students, the Republican members of the committee further sent out a press release on February 28, 2023 similarly requesting the lifting of the mandate.

Requiring the COVID-19 vaccination negatively impacts students who may have wanted to attend a college of the University of Maine System but who opted against enrolling because of the COVID-19 vaccination mandate. Should the University of Maine System lift the COVID-19 mandate, the Republican members of the committee would be in support of each of these initiatives.

<u>Department of Education – General Recommendations on the Department of Education, including the Maine School Safety Center; and Learning System Team and federal ESSER Grant Funding</u>

As demonstrated in the attached spreadsheets, Republican members of the committee voted a number of initiatives "out" of the biennial budget. The reason for these votes primarily addressed concerns of unnecessary department growth during the last two years. The members note that while students in the State were forced into remote learning or to wear masks in schools, businesses were forced to close, people were unable to make a living, and unemployment options were limited to non-existent, the Department of Education expanded by approximately 10%.

The Republican members of the committee calculate that the sum of all of the initiatives voted "out" equals approximately \$70 million. As noted above, the Republican members recommend \$6 million of that go to Maine Maritime Academy. Republican members recommend that the remaining \$64 million instead be provided to the General Purpose Aid for Local Schools (GPA) to be distributed through the Essential Programs and Services funding formula to publicly-funded schools in this State. Local schools, and local control, are the backbone of education in this State, and these funds are best utilized directly in the classrooms supporting students, teachers, and education technicians.

One aspect of local schools that should and is being accomplished at the local level is regarding student safety. During the 129<sup>th</sup> Legislature, the Department of Education established the Maine School Safety Center to ensure the overall safety of schools with a primary role to provide training, guidance and technical support to schools regarding safety and security. A subsequent amendment to the establishing statute has expanded the Center's role beyond its original intent. Republican members of the committee note that the abundance of additional positions proposed to be established – or limited period positions proposed to be made permanent – for the Maine School Safety Center are unnecessary and accordingly voted each of the initiatives for the Department of Education's Maine School Safety Center "out" of the biennial budget. For these members, the Department of Education's expansion of the Maine School Safety Center, particularly during the COVID-19 pandemic, has been unacceptable. This work is best done at the local level, with local control, and without the additional layer of bureaucracy from the Maine School Safety Center. As noted in the paragraph above, additional funds are best utilized when they are sent directly to be used in the classroom.

Republican members of the committee voted in opposition to the initiative to provide additional funding to Child Development Services to develop additional preschool program (reference #1092). These members noted that with many existing resources at parents' disposal, additional funding for Child Development Services is not necessary. Such resources and organizations include:

- Families CAN!, which is designed to promote the 5 protective factors of parental resilience, social connection, knowledge of parenting and child development, concrete support in times of need, and healthy social and emotional competence of children;
- Maine Parent Federation, including KidsCount, which offers intervention services;

- Maine Children's Alliance;
- Elevate Maine, which partners with rural child care facilities and offers center-based programs; and
- Pediatricians offices, church services, and food banks, which all help link parents to needed services.

Republican members of the committee voted against each of the initiatives for the Learning Systems program within the Department of Education, with particular opposition to the initiatives related to the federal ESSER grants received by the Department of Education, which these members noted totaled approximately \$638 million. The third round of funding, ESSER III, included agreements with the Commissioner of Education and local superintendents to meet certain requirements in the grants. Receipt of the funds was also conditioned on accountability measures and required specific tasks and obligations to provide transparency for the public. Republican members of the committee indicate that this did not happen, in violation of the grant, and that evidence of the noncompliance was included on a spreadsheet that was ultimately submitted to the United States Department of Education. However, when submitted to the U.S. Department of Education, the information on the noncompliance was not included. Accordingly, the Republican members of the committee recommend requesting a forensic audit of all of the funding that was provided to the Department of Education through the federal ESSER funding.

## Conclusion

The Joint Standing Committee on Education and Cultural Affairs thanks you for your time and consideration of our recommendations – those in the attached spreadsheets and contained in this memorandum – on the Governor's proposed biennial budget. In addition to our recommendations, our OPLA and OFPR staff have compiled all of the additional information we received over the course of our deliberations so that you may access to those materials as well.

# PART QQQ SUMMARY

This Part authorizes the State Controller to transfer to \$7,500,000 in fiscal year 2023-24 and fiscal year 2024-25 from unappropriated surplus of the General Fund to the MCCS Free Community College - Two Enrollment Years, Other Special Revenue Funds account within the Maine Community College System to provide 2 years of free community college for high school graduates in the classes of 2024 and 2025 who enroll in a Maine community college full-time.

Sec. C-5. Authorization of payments. If the State's continued obligation for any individual component contained in those sections of this Act that set the total cost of funding public education from kindergarten to grade 12 and the local and state contributions for that purpose exceeds the level of funding provided for that component, any unexpended balances occurring in other programs may be applied to avoid proration of payments for any individual component. Any unexpended balances from this Act may not lapse but must be carried forward for the same purpose.

Sec. C-6. Limit of State's obligation. Those sections of this Act that set the total cost of funding public education from kindergarten to grade 12 and the local and state contributions for that purpose may not be construed to require the State to provide payments that exceed the appropriation of funds for general purpose aid for local schools for the fiscal year beginning July 1, 2023 and ending June 30, 2024.

This Part establishes the Total Cost of Education from Kindergarten to Grade 12, the state contribution, the annual target state share percentage, and the mill expectation for the local contribution for fiscal year 2023-2024. This section also makes permanent a career and technical education middle school grant program.

# Sec. QQ. 30-A MRSA §5953-G, is amended to read:

- 1. Additional securities. The bond bank may issue additional securities in an aggregate amount not to exceed \$20,000,000 for equipment purchases or building infrastructure necessary to support the new or updated equipment to career and technical education centers and career and technical education regions in accordance with this section, and the additional securities must be used for those purposes.
- **2. Issuance.** The bond bank may not issue any additional securities pursuant to this section after June 30, 2024 2025.
- 3. Report. The bond bank shall report to the joint standing committee of the Legislature having jurisdiction over education and cultural affairs upon the maturity of all bond proceeds pursuant to this section. The joint standing committee of the Legislature having jurisdiction over education and cultural affairs may report out a bill to repeal this section and any related provisions of law upon receipt of that report.
- 4. Department of Education application; criteria. A career and technical education center or career and technical education region may submit an application for a project, projects or part of any project, as defined in Title 4, section 1603, subsection 7, to the Department of Education. The Department of Education shall establish criteria for the approval of any project, projects or part of any project. The Department of Education shall notify the bond bank of any approved project, projects or part of any project under this subsection.
- 5. Debt service. Debt service costs for bonds issued by the bond bank to career and technical education centers and career and technical education regions for equipment purchases or building infrastructure necessary to support the new or updated equipment pursuant to this section must be paid by the State. Debt service costs must be paid by the Commissioner of Education to the bond bank according to each career and technical education center's or career and technical education region's debt retirement schedule developed by the bond bank. All debt service costs must be paid by the Commissioner of Education to the bond bank 15 days prior to the date of the career and technical education center's or career and technical education region's next debt service cost payment as outlined in the career and technical education center's or career and technical education region's debt retirement schedule.
