RE: Follow up to previous memo on Committee Recommendations to the
Governor's Proposed Budget (LD 258)

The Joint Standing Committee on Marine Resources had the opportunity to continue their discussion on the Governor's proposed biennial budget on March 16. At the committee's discussion on March 9, Representative Hepler requested information from the Department of Marine Resources regarding position reclassifications that had been approved but not included in the biennial budget. The Department of Marine Resources provided the pertinent information to the committee. The position reclassifications are as follows:

The committee held a vote on whether to recommend the inclusion of all three position reclassifications in the biennial budget. There were twelve members present for this vote; the committee voted unanimously in favor of recommending that all three positions are included in the Governor's proposed biennial budget.

In addition, Representative Lydia Crafts had been absent from the committee's March 9 meeting but later indicated that she would have joined the other committee members in voting all of the proposed initiatives in to the budget.
